



## 11 burnt to death as robbers torch house

Eleven members of a family, including a four-day-old baby, were burnt to death as robbers set fire to a two-storey earthen house in a remote village on Banskhali coast, 30 miles off Chittagong city, early yesterday.

The 11 charred bodies lay in rows on the floor of the burnt house as the only survivor of the arson, Bimalendra Shushil, narrated the horror.


The incident occurred when about 20 robbers raided the house of Tajendra Lal Shushil at Shilpara of Banskhali upazila at around 12:30am.

The robbers barged into the house, breaking the front door.

As the panicked family took shelter upstairs locking the wooden door, the robbers looted whatever they found on the ground floor.

"The robbers could not break the first floor door, which enraged them. They started shouting at the family members, threatening them with dire consequences unless they did not open door," Bimalendra, the only surviving son of Tajendra and a

4,000 Bangladeshis to return from Oman in December

Some 4,000 Bangladeshis are set to lose job in Oman after the oil-rich Gulf nation has asked expatriate foreign workers, mainly managers and businessmen, to leave the country by December.

Sources at the Expatriates Welfare and Overseas Employment told The Daily Star that the low-level workers would be affected by the Omani decision. Around 1.15 lakh Bangladeshis live in Oman of whom only a few holds managerial posts or own business establishments.

Oman is trying to ensure top jobs for its citizens, according to sources.

Bangladesh has asked Oman to ensure that those returning will be able to be repatriated with funds and movable property.

A high-powered committee led

by Secretary of the ministry Dalil Uddin Mondal is also working to arrange smooth repatriation of the returnees.

Oman has stopped recruiting Bangladeshi workers for several years following an altercation between Bangladesh ambassador and an Omani high police official during the mid-1990s.

However, it started recruiting again in agriculture, fisheries and textile sectors two years back.

Around 5,000 Bangladeshis have been employed in those sectors since then, claimed a high official of the ministry.

Meantime, around 20,000 Bangladeshis living in South Korea without valid documents are going to be deported as Seoul has gone strict on illegal foreign workers. There are more than 1.30 lakh Bangladeshis in Korea.

**Bhuiyan invites AL to talk, end JS stalemate**

Bangladesh Nationalist Party (BNP) Secretary General and LGRD and Cooperatives Minister Abdul Mannan Bhuiyan yesterday invited the main opposition Awami League (AL) to a dialogue to end a five-month-old stand-off in parliament.

He requested the speaker to invite the opposition to sit for the dialogue with the government party any day to sort out the dispute.

"We're ready to do whatever you will ask us to resolve the problem," Bhuiyan said in his speech in parliament.

The Awami League MPs walked out of parliament on June 25 to protest the switching off of the microphone of Leader of the Opposition and AL chief Sheikh Hasina and later began abstention protesting State Minister for Works Alamgir Kabir's 'derogatory

remarks about Sheikh Hasina.

Referring to the main opposition party's three-point demand, Bhuiyan said the government also wants to run the House as per rules of procedure. Regarding the second demand, he said unparliamentary words were already expunged. On the third demand as regards tendering apology by the state minister, he said there had not been any precedent of seeking apology after expunction of unparliamentary words.

"Still, if somebody used unparliamentary words, you can examine the records and expunge those," the BNP leader told the chair.

Bhuiyan recalled the past initiative by the deputy speaker to resolve the stalemate through discussion and said the opposition did not respond to that.

The speaker made it clear that if

They observed that these should debate in the House.

4 die in road accident at Banani

The bench also issued a rule on the government to explain why the petitioner should not be granted bail in the case.

The HC Division Bench of Justice Goura Gopal Shaha and Jubayer Rahman Chowdhury passed the order on medical grounds.

AC Akram was sentenced to life imprisonment by the Court of Third Additional Metropolitan Sessions Judge on June 17, 2002.



**2 to die, 1 gets life for killing Sgt Ahad**

Acquittal of 10 blamed on cop neglect

A court in Dhaka yesterday sentenced two muggers to death and another to life in prison for beating Sergeant Ahad Parvez on duty in 1999.

Judge Hussain Shaheed Ahmad of the Court of Second Additional Metropolitan Sessions Judge cleared 10 others of the charges and blamed the acquittals on the neglect of investigation officers.

Abdul Kader Akand, assistant

superintendent of police of CID (Criminal Investigation Department), and Sub-Inspector Jalal Uddin probed the case but did not carry out the test of identification parade (TIP), blocking the investigation.

**One-sixth of children work**

A sixth of the country's children at age 5-17 are engaged in economic activity, according to the National Child Labour Survey, released yesterday.

The survey is the second stand-alone national child labour study after the first in 1995-1996.

It has been undertaken to develop a comprehensive statistical database on working children and mitigate the deficiencies of data relating to child labour.

Of the total 42.4 million children, 2.4 million were reported engaged in

economic activity but also attending school, says the survey conducted by Bangladesh Bureau of Statistics and the International Labour Organisation (ILO).

As many as 4.1 million children were found neither at work nor in schools. They worked in households, were sick, disabled or beggars.

As Bangladesh ratified the ILO Convention No. 182 on the worst forms of child labour in the sectors like automobile workshop, welding establishment, battery recharging and recycling, road transport and

**Saifur slams survey**

The survey, the second stand-alone national child labour study after the first in 1995-1996, included the 5-17 age bracket as children. Bangladesh's number of children now stands at 42 percent of the total

not considering the country's socio-economic condition in preparing the survey, conducted by the BBS and the International Labour Organisation.

"In my view, people at age 17 are not children," he said, addressing the launch of a seminar on findings of the survey.

With the inclusion of people of the 5-17 age bracket as children, Bangladesh's number of children now stands at 42 percent of the total
