

## JS session prorogued

The 10th session of the Jatiya Sangsads was prorogued yesterday with the treasury bench requesting the speaker to initiate a fresh dialogue with the main opposition Awami League (AL) on its ending the parliament boycott.

The House on the last day of its four-day session yesterday passed the Code of Civil Procedure (Third Amendment) Bill, 2003, 'paving the way for quick disposal of civil suits and halting the trend of making false claims and lodging false cases on land disputes.'

"You (speaker) call the opposition (AL) members, hear from them what they want and tell us what we are to do. We want the return of the opposition to the House," Local Government and Rural Development (LGRD) and Cooperatives Minister Abdul Mannan Bhuiyan said in his winding up speech in the House.

Bhuiyan was however critical of the main opposition party's role and alleged it (AL) is planning to destabilise the country.

Prior to reading out the prorogation order by the president, Speaker Jamir Uddin Sircar urged lawmakers

## Bush for use of force for peace

Welcomed to Britain with royal pageantry and a smattering of anti-war protesters, US President Bush yesterday defended the war in Iraq, saying military might must at times be used to confront the continuing, global danger of terrorism.

"In some cases, the measured use of force is all that protects us from a chaotic world ruled by force," Bush told academics gathered at Whitehall Palace.

During a 3 1/2-day state visit here, Bush was seeking to puncture what he views as misconceptions on this side of the Atlantic about America's use of force in Iraq.

"There are principled objections to the use of force in every generation and I credit the motives behind these views," Bush said, mindful of the bitter opposition among many in Britain and across Europe to the US-and-British-led war in Iraq.

But, he added: "Those in authority, however, are not judged only by good motivations. The people have given us the duty to defend them and that duty

sometimes requires the violent restraint of violent men."

He invoked the Sept. 11, 2001, terrorist attacks in America to warn against inaction.

"The hope that danger has passed is comforting, is understanding, and it is false," he said. "These terrorists target the innocent and they kill by the thousands. And they would, if they gain the weapons they seek, kill by the millions and not be finished... The evil is in plain sight. The danger only increases with denial."

Earlier, Queen Elizabeth II and Prince Philip gave a royal salute to the American leader, greeting Bush at Buckingham Palace.

As ceremonial cannon blasts from a 41-gun salute shook the palace, Bush and his wife, Laura, moved down a receiving line with the queen and prince, greeting Prime Minister Tony Blair, Foreign Secretary Jack Straw and a phalanx of military officers in formal dress. Bush and the prince then inspected a column of Coldstream Guards, with their trademark gray coats and tall, fury black hats.

Japanese legislators approved a second term in office for Prime Minister Junichiro Koizumi yesterday, a formality after his ruling coalition won a narrow victory in a general election held November 9.

He must now push ahead with plans to reform the economy and to send troops to Iraq -- despite heavy opposition.

## Govt feels pressure to withdraw magistrate from Sadarghat

Launch owners are putting heavy pressure on the shipping ministry to withdraw the special magistrate from Sadarghat launch terminal ahead of the Eid-ul-Fitr.

The leaders of Bangladesh Launch Owners Association at a meeting at the Department of Shipping yesterday protested against the ongoing drive against faulty vessels and demanded Special Magistrate Munir Chowdhury's withdrawal.

They said they would not be held responsible if any untoward incident took place at the terminal.

The meeting, chaired by shipping department Director General Ahsanul Azim, also discussed the launch terminal situation and steps to be taken for

maintaining law and order there in the run-up to the Eid.

The lunch owners became incensed as the special magistrate was conducting regular raids on passenger and cargo vessels.

They are lobbying the government for the withdrawal of the magistrate, sources said.

As many as 450 vessels, including 200 passenger launches, were fined Tk 26 lakh for overloading, risky driving, lacking in safety equipment and up-to-date survey certificates during the drive that began in August.

Eleven passenger launches and 100 cargo vessels were impounded for irregularities.

Sources said some launches belonging to Arafat Ramzan, son of Prime Minister Khaleda Zia, were also fined

and impounded for failing to meet safety standards.

His Coco-1 was detained yesterday for about half an hour for carrying goods on the passenger deck.

Home Secretary Mohammad Omar Farooq visited the terminal Tuesday night and expressed satisfaction at the overall situation.

But Officer-in-Charge of Sadarghat Police Outpost Sergeant Altaf was removed from the terminal for failing to discharge his responsibility.

The drive largely restored discipline at the terminal also by removing illegal shops and stopping movement of suspicious people there, sources said.

5 AL leaders get bail in 'godfathers' list case

The High Court (HC) yesterday granted three months anticipatory bail to five frontline Awami League (AL) leaders in 11 defamation cases.

The HC Division Bench of Justice Md Joybul Abedin and Justice AKM Fazlur Rahman heard the bail petitions of the AL leaders and granted them bail. The AL leaders were present in court.

Earlier on November 15, the same bench granted anticipatory bail to 16 top AL leaders including its General Secretary Abdul Jalil in the same cases.

The leaders who obtained bail yesterday are Amir Hossain Amu, Tofail Ahmed, Abdur Razzak MP, Sheikh Fazlul Karim Selim MP and Sohel Taj MP.

## US to fund \$3.5m for CNG set-up

UNB, Dhaka

The United States Agency for International Development (USAID) will provide \$3.5 million for the development of CNG (compressed natural gas) infrastructure run by private operators.

The money will be channelled through banks as credit to Bangladeshi private entrepreneurs and businesses willing to install CNG infrastructure.

The USAID has signed two agreements with Prime Bank Limited and Hong Kong and Shanghai Banking Corporation (HSBC) Limited in this regard.

The agreement with the USAID is believed to be the first of its kind to support CNG infrastructure anywhere in the world, a press release said.

The agreements were signed against the backdrop of a mini-trade
