Ahmadiyya books banned

The government has banned all publications of the Ahmadiyya Muslim Jamaat Bangladesh a day before the end of an ultimatum by religious bigots to declare the sect non-Muslims.

"The ban was imposed in view of objectionable materials in such (Ahmadiyya) publications which hurt or might hurt the sentiments of the majority Muslim population of Bangladesh," said a press release of the home ministry yesterday.

The bigots represented mainly by Islami Oikya Jote (IOJ), a partner of the ruling coalition, have long been campaigning for the move. The Hifazate Khatme Nabuwat Andolon

(HKNA), represented by IOJ leaders, spearheads the anti-Ahmadiyya

The move is believed to be the first step towards declaring about one lakh Ahmadiyyas in the country non-Muslims, said a source present at a high-level meeting at the religious affairs ministry yesterday.

The government has not yet

taken any decision on the issue of declaring the Ahmadiyyas non-Muslims, he added.

"We discussed the demand but need to explore all aspects to reach a decision in this regard," a top government official who was present at the meeting said on condition of


Awal, Missionary of Ahmadiyya Muslim Jamaat Bangladesh, said We are shocked. The government has bowed down to religious terror-

"The people's right to the freedom of expression as enshrined in the constitution has been violated by taking such a decision," he said.

10 abducted in Rangamati

PCJSS blamed, kidnapped hills student found dead

At least 10 villagers were abducted in an incident blamed on a pro-CHT peace accord indigenous outfit and the body of a student killed in captivity was recovered in Rangamati yesterday in the latest in a string of kidnaps in the restive highlands.

Witnesses said up to 25 armed cadres of the Parbatya Chattagram Jana Sanghati Samity (PCJSS) launched attacks on their rival members of the United People's Democratic Front (UPDF) in Shapmara village in Naniarchar

upazila and abducted the villagers apparently for sheltering UPDF

Police also blamed the attack and abduction on the PCJSS that got bogged down in clashes with the UPDF after the 1997 peace deal that ended two decades of bush war in the CHT (Chittagong Hill Tracts).

The PCJSS men drove their rivals out of the village in the fierce firefight that came at about 9:00am before the abduction prompting the army to launch sweeps in the district in search of the abductors.


