RPC POWER PROJECT NEAR SAVAR

Corruption alleged in floating tender

When donors are pressing for freeing tender procedures from corruption, the Rural Power Company (RPC) is allegedly pursuing its donor-funded Savar 450-megawatt (MW) power project using "unfair" and severely limiting tender terms

to award the contract to a company. If awarded to the company, the overpriced contract will benefit a handful of lobbyists and businesspersons and put extra financial burden on rural consum-

The RPC is the brainchild of the Asian Development Bank (ADB) and enjoyed the Bank's support in past projects, but the ADB itself last month brought allegations of lack of transparency in the Savar project and withdrew its support from it.

Partly funded by German financier KfW, the RPC floated the tender a few months ago for Engineering, Procurement and Construction (EPC) Contract for the first phase of the 450-MW Dhaka North Power Project (DNPP) at Kadda, near Savar.

generate 280 MW and involve an estimated cost of 150 million Euros.

Although it is an EPC contract tender, its terms clearly bar participation of any EPC contractors. As a result, the RPC so far got

response from only two companies -- Siemens of Germany and Alstom of France -- as the tender's stringent terms and conditions disqualify most other power companies. The bid documents will be

opened on January 26. The RPC has already appointed German company Lahmeyer as project consultant without any tender. Lahmeyer was earlier given a 15-year operation and maintenance contract for RPC's Mymensingh power projects -- also without any tender -- at a cost at least five times higher than for similar operations

'Ban on Ahmadiyya books infringement of rights'

Govt defends decision amid flak

The government order banning all Ahmadiyya publications drew swift flak from people of all hues yesterday and prompted a demand for lifting the ban that the ruling coalition defended with a counterpoint

of ensuring peace in society. Supreme Court Bar Association President Barrister Rokanuddin Mahmud described the ban as violative of fundamental rights of the minority Ahmadiyyas.

"It clearly violates freedom of religion (Article 41), nondiscrimination on ground of religion (Sub-article 3 of Article 28) and freedom of speech, thought and conscience (Article 39) of the constitution," he pointed out.

"The order also reneges on the right to equal protection of law and the right to be treated in accordance with the law and equality before law," he added.

The ban was imposed on Thursday in view of what the government said was objectionable materials in Ahmadiyya publica-tions that "hurt or might hurt the sentiments of the majority Muslims

It came after religious bigots represented mainly by Islami Oikya Jote, a partner of the ruling coalition, launched a campaign with Hifazate Khatme Nabuwat Andolon at the forefront to force the government to declare the sect non-Muslim.

The move is viewed as the first step towards declaring about one lakhAhmadiyyas non-Muslim.

Dr M Zahir, a constitution expert, advocated even-handed treatment of all religious sects by the govern-ment, adding: "Nobody has the right to translate the Quran wrongly or misinterpret it. But when all publications are banned, other publications not concerned with the holy book may also come under the ban,

"If that is so, it is a bar to the right to propagate one's freedom of

Dr Zahir wondered why the Ahmadiyyas were not allowed to practise their religion the way SEE PAGE 11 COL 7



Debt management unit on cards

Bid to bring transparency in govt expenditure, lending

The government is going to form a debt management unit (DMU) in the Finance Division to ensure discipline and transparency in government expenditure and lend-

The government also decided under the Financial Management Reform Programme (FMRP) to collect monthly accounts on expenditures incurred by all ministries and district offices. These accounts are to be submitted to the FMRP

The government annually spends around Tk 40,000 crore.

The ministries of education, agriculture, women and children affairs and social welfare have already started sending their monthly accounts to the FMRD office. Each of these four ministries also has opened a financial management unit (FMU) to comply with a set of FMRP instructions on how to compile the accounts on a monthly basis. The FMUs will also be opened

in other ministries soon.
"Typically, when we start working on the budget, we don't instantly get accounts on government spending," said a FMRP source. "This new system will keep us ready all the time and facilitate us tremendously in

making the budget in June." In addition to expenditures under revenue and development

budget, the government spends and earns a significant amount through its district offices. But there are wide discrepancies in these accounts too. Therefore, the office of the Comptroller General of Accounts

(CGA) is now working on framing a set of accounting instructions for the district offices. The offices of deputy commis-

sioners (DCs) across the country will be linked through computer network and share accounting information online on a daily basis.

An acute power crisis may plague the coming summer.

Power sector officials said there is little possibility of enhanced power generation in the near future though the peak-hour demand in summer is likely to increase 10 percent, putting the requirement figure at around 4000 mw

The demand for power last summer was 3600 mw on average and the usual supply shortage was 250 mw. The Power Development Board (PDB) provided 3592 mw on August 17 last year, the highest in the sea-

The officials pointed out that demand for power registered an incremental rise by 10 percent a

Explaining the power generation situation, they said a 210-mw steam power plant at Siddhirganj on the outskirts of the capital may be commissioned by March 31. But people

involved in the construction of the plant for over seven years now think it is unlikely to generate power by the coming summer. It may take six more months to complete the pro-

The 80-mw turbine power plant in Tongi is set to go into operation in October, well after the summer.

The PDB and the Rural Electrification Board (REB) are working on adding around 1200 mw of power to the national grid through installation of six more power plants. But neither of them is likely to be commissioned before the next year.

As an immediate bailout measure, the PDB has taken up a 100-day crash programme aimed at completing routine maintenance and repair of the existing power plants before the onset of summer.

Power crisis likely to Outlaws woes of Rupsha bridge construction

The construction of the donorfunded vital bridge over the Rupsha river has been stalled several times because of harassment by an outlawed extremist group.

According to sources, the Purba Banglar Communist Party (PBCP) has been attacking the officials and workers at the site and demanding toll from the contractors in Khulna since the construction began two

They have demanded huge amount in toll and attacked the officials and workers at the construction site. One such victim of the PBCP attack was Rezaul Karim Raj, supervisor of the Rupsha Bridge Construction Project at Labonchora. On his way to work in the morning of November 22, the extremists chopped him with a Chinese axe and snatched his cellphone and purse. They left the spot raising slogans of the under-ground outfit, according to newspaper reports. Severely injured Raj was admitted to Khulna Medical College Hospital, and is now undergoing treatment in Dhaka.

The outlawed group earlier demanded Tk 50,000 in toll from him. They swooped on him as he had refused to oblige them, according to sources.

The Rupsha bridge project officials and workers witnessed two such major attacks between July and December this year, said an official "Such extortion demands and

threats are not uncommon, but this time the contractors have filed an allegation of threat from the extremists," said Momenul Huq, director of the Rupsha bridge project. Security has been beefed up at

the project site with another 30 policemen joining a contingent of 64 police personnel that has been guarding the project site since the beginning, the source said. The construction of the Japan-

funded bridge started in May 2001 and was supposed to be complete in November 2004. But the completion of the bridge is going to be delayed by at least seven more months.

Though more than 65 percent work has been complete, the contractors are now apprehending that the bridge would not be ready for traffic before June 2005.

Blast outside Iraq mosque kills 6

At least six people were killed and 39 injured yesterday in an explosion outside a Shiite mosque in the town of Baquba, northeast of Baghdad, after the end of main weekly prayers, medics said.

"Five people were killed and 39 people injured in an explosion near the Haj Sadek Banin mosque," said Ziad Tarek, a doctor at the general hospital in Baquba, 60km from Baghdad.

Baquba, in Diyala province, is populated by a mixture of Sunni and Shiite Muslims.

Unknown attackers strapped a gas cylinder packed with explosives to a bicycle and left it outside the mosque -- close to people praying on the pavement because of lack of

"At the end of prayers, it

exploded," Iraqi police Sergeant Haki Ismail Mustafa told Reuters. Officials at a nearby hospital said theyknew of 39 people injured. Another report says, Iraqi gueril-

las early yesterday fired two rocketpropelled grenades at a Baghdad hotel used by foreign companies, contracted by the US-led coalition, but there were no casualties, said security guards with the firms.

"The first and fourth floors were hit. No one was wounded," said one of the guards from the companies, hired by the coalition. The attack happened at around 6
