Installation of gas pipelines | Anti-Ahmadiyya

"There is no official monitoring of the job," a Petrobangla source said.

The contractors are also allegedly giving 12.5 percent of the 'undue 'profit' to young leaders of a certain Bhaban so that no official investigation can stop them, an insider said.

An investigation of The Daily Star reveals that corruption in the project cropped up at its inception.

When Titas Gas Transmission and Distribution Company Ltd took up the BBARGP in 1997 and got the project including the pipe-laying component approved at Tk 126 crore, corruption was there.

"When designing the project Titas high officials deliberately entered miscalculation in it that Ecnec (Executive Committee of National Economic Council) could not understand," said a Petrobangla high official who probed the corrup-

The BBARGP project has three components. The first component involves Tk 30 crore along with 10 percent contingency cost for construction of the two pipelines. It also spends Tk 70 crore on purchase of pipes, fittings and other construction tools and another Tk 26 crore on

It was supposed to be complete in

Soon after the BBARGP got clear-ance from Ecnec, the Titas board in 1999 revised the cost of all three project components keeping the total cost at the approved amount of

The Titas board said there was a mistake in estimating the purchase of pipes and awarding the contracts.

It said the project should be implemented 'mechanically' instead of doing it manually to ensure a high quality.

The logic gave the Titas board a chance to raise the pipeline installation cost to Tk 60 crore from Tk 30 crore and slash the material procure ment cost to Tk 40 crore from Tk 70

It said Titas made a mistake in estimating the procurement cost.

The Titas board informed the Petrobangla of the 'readjustment' and as one of the beneficiaries of the process was a high official of Petrobangla, it got the nod, sources

Petrobangla told Titas that the revised project' could be authorised later as it was a common practice with different government agencies.

The Titas board then imposed some conditions on the pipeline bid to ensure that only the companies of its choice get the job.

The three conditions that limited participation in the tender to only nine companies are: the contractors must ensure 'internal line-up of the pipeline through clamp-wielding' the pipelines will be laid using 'sideboom' and the contractors must have experience of laying pipelines on riverbeds using dredgers.

The nine companies then joined hands and submitted proposals in both the pipeline schemes. But only three of them in each bid quoted price while the six stated, "no price quote". This gave the project a cosmetic competitive look.

The contracts for laying the 101 km pipeline went to Business King and the 109 km to Don Construction.

Business King asked for a cost of Tk 34 crore while Don sought Tk 28 crore although Don's job was more complicated than the King's.

Shahidul Islam, who joined as the energy secretary at the stage, also became the ex officio chief of the Titas Board.

Sources allege that Titas officials tricked Shahidul into approving the tenders keeping him in the dark about the inconsistencies. But when someone alerted the secretary about the tender flaws, he recalled the files.

Upon a primary scrutiny, he asked King to explain why its pro-posed cost was higher than Don's. King instantly lowered its price by 7 crore, saying it could do the job at a

Shahidul formed a committee with a joint secretary as its chief to probe into the allegations of irregularities in the tender and pricing process and the committee pointed fingers at four Titas officials and recommended re-tendering after

dropping the over-priced project. The probe committee also recommended punitive measures against three of the Titas officials and their exclusion from future tender

But the state minister calmed the situation by issuing warning letters to the contractors, but gave them the green light to go ahead with the job. The Titas trio went scot-free.

The state minister denied any role in the corruption and claimed that the project was not overpriced.

"Tk 30 crore is an unrealistic estimate for this project," Mosharraf said, adding," There is no corruption "It's true I did not allow re-

tendering," Mosharraf added, "Because it would have increased the project cost further.' On his role after the ministry's

investigation found wrongdoing, he said: "The probe was initiated by the secretary because of inconsistency in the prices quoted by two bidders. After the investigation, the bidder in guestion lowered the quote by Tk 7

Titas Managing Director M Abdullah also denied the allegations of corruption.

"This project was processed through the ministry and Ecnec. There is no scope for corruption." He asked The Daily Star to talk to Mahbubur Rahman, general manager (planning) of Titas, but the newspaper could not reach him despite several efforts on two days.

"We are aware of the allegations of corruption in this project," said Petrobangla Chairman MR Osmani, adding: "The pipelines are being laid manually sidestepping the mechanical condition."

He said a three-member Petrobangla committee was probing the allegations. "No corruption will go unchallenged."

The pipelines are supposed to be laid by March-April.

"Since October, they are working on the project. But you will not see anyone to ensure that the pipelines are being laid mechanically. The rivers are dry and there is no dredger. The pipelines are being laid manually with utter neglect," said a source in the GTCL.

In the first attack on December 14 a bridge was blown up by remote control just seconds after Musharraf's car drove over it. Five bombs had been planted on the bridge. Security officials said a hitech jamming device on his car delayed the explosions and possibly saved his life.

The second attack came on Christmas Day when two suicide bombers rammed explosivesladen trucks into the presidential motorcade, killing 15 people.

The reported move to the official presidential house comes almost 12 months ahead of the deadline for Musharraf to quit his post as army chief.
