Muggers kill businessman in Tejgaon

A businessman was stabbed to death in an apparent mugging incident in Tejgaon on Tuesday night, police said.

Police recovered the body of Sharif Haque Siraji, one of the owners of Siraji Home and Overseas Machinery at Nawabpur, from the road in the commercial area at around 11:45pm and sent it to Dhaka Medical College Hospital (DMCH) for autopsy.

As the 39-year-old man did not return home, his family after an overnight search went to the DMCH and identified the dead yesterday.

Siraji and his brother Rafiqul closed their shop at 6:30pm and went to Madan Lal Lane in Sutrapur for business purpose. Rafiqul went back home, but Siraji went missing, the family said.

Police believe muggers killed him, as the victim's mobile phone, bracelet and about Tk 8,000 were missing.

A case was filed with Tejgaon Police Station.

Kids in fetters

108 children are held in jail in violation of law

At least 108 juvenile delinquents are being held in Dhaka Central Jail instead of correction centres, as the law dictates, according to a list prepared by the jail authorities in December 2003.

Section 2(F) of the Children Act, 1974 says any person aged below 16 is a juvenile and must be sent to a "certified home or approved home or to the custody of a relative or other fit person". A juvenile has to remain in such a place till the age of 16.

The children languish in the prison though at least 99 seats are lying vacant in the National Juvenile Correction Centre at Tongi. Of the 108 children, at least eight have been in the jail for more than one year. Al Amin, a boy of 14, has been there since October 7, 2000. Six have

murder cases against them while the majority were arrested for allegations of robbery or theft. A few are accused in arms cases too.

The Children Act says living in jail may pose moral dangers to juveniles. Social workers as well as guardians of the children are also worried from the thought that the children will be more exposed to crime inside the jail and from contact with adult criminals.

"I did not know there is an exclusive place for juveniles at Tongi and thought my son was bound to suffer in prison for his misdeeds," said Nasrin Begum, mother of 14-year-old Badal who came out of the prison on bail January 12 evening.

"Now, everyone says he will get entangled in bigger crimes," Nasrin weeps in apprehension.

Bail to accused of Lalbagh 7-murder cancelled

The High Court (HC) yesterday overruled its previous order that had granted ad interim bail to the prime accused in the sensational Lalbagh seven-murder case.

The carnage took place at Lalbagh in old Dhaka on December 31, 1994 in a violence following the Dhaka City Corporation election, in which the accused, Abdul Aziz, lost the race for a commissioner.

A division bench comprising Justice Mohammad Hassan Ameen and Justice ATM Fazle Kabir also asked the accused to surrender before the trial court in a week.

The court orders came upon petitions filed by the state and the informant of the case who sought cancellation of the bail granted by another HC bench on November 15 last year.



