

DG shipping accused of violating law

A shipping department magistrate has formally accused the department's head of misusing authority for illicit gains, violating judicial and civil service norms and obstructing the magistrate's judicial duties.

Munir Chowdhury, special magistrate of Department of

Shipping (DoS), made the accusation against DoS Director General (DG) Captain AKM Ahsanul Azim in a written complaint lodged with the chief metropolitan magistrate's court on January 21.

Munir alleged the DoS DG created various obstacles in conducting a special drive against rule-defying vessels, which began on August 7 last year after the disaster of MV Nasreen-1 in which more

than 600 passengers were drowned.

According to sources, Azim also did not provide logistical support for the magistrate in the drive. On the contrary, he allegedly even instigated launch owners against the magistrate, who during the drive fined and detained around 650 passenger launches and cargo vessels for violating maritime rules

Govt unleashing criminals: Hasina

Opposition Awami League (AL) President Sheikh Hasina yesterday accused the government of terrorising people by unleashing criminals on them.

"People are passing their days in panic spread by the BNP-Jamaat-led coalition loyalists and they are also in fear of government-backed criminals," Hasina told a discussion in the city's Paltan Maidan organised by Bangladesh Chhatra League (BCL), student wing of the AL, marking its 56th founding anniversary.

"The nature of a democratic government is that it will always be in fear of losing people's confidence if it does anything against public interest," Hasina observed. "The entire country is now a valley of killings where common people as well as political opponents, journalists, women, children and minorities are being tortured by ruling alliance loyalists."

1 killed in ansars fire during clash over land

One person was killed and 12 others were injured when ansars opened fire during clashes between two rival groups over a disputed land in the city yesterday.

Police and witnesses said clashes erupted when one of the feuding groups backed allegedly by ansars attempted to forcibly occupy land at Mohammad Nagar under Bayezid thana at around 8:00am.

As the group led by one Solainam started demolishing the boundary wall and thatched house on the land under the possession of Mohammad Nagar Housing Society, local people resisted them, giving way to clashes, said Sarwar Jahan Jamail, resident of the locality.

Around two hours after police brought the situation under control, the feuding groups clashed again at around 11:00am, he added.

At one stage, ansars hired by Solainam opened fire on the rival

Mystery disease claims 15

The mysterious disease that broke out mainly in Rajbari a few weeks ago has left 15 people, mostly children under 13, dead in its wake as health officials grappled with the problem of diagnosis of the fatal virus, medical sources said yesterday.

Three of the children, two from Goalondo in Rajbari, died Saturday while undergoing treatment at Dhaka Medical College Hospital (DMCH) in the city.

A team of experts visiting Goalondo has so far been unable to find any valuable clue to the mysterious disease except that it's most likely viral.

There have been reports of entire families fleeing the affected villages of Kumrakandi, Joran (Molla Para) and Poura Bazar in Rajbari, while many others who stayed back have sent their children away to relatives in other districts.

The health directorate has designated additional doctors and nurses

Outgoing CJ accents on Bar, bench trust

The judiciary cannot work effectively without mutual trust between the Bar and the bench, said KM Hasan, who retires from the Supreme Court as chief justice today.

"I grew to appreciate more the value and relevance of some lessons I had learnt previously. The first ... is the value of trust in the Bar," said Justice Hasan, accorded farewell by the Supreme Court Bar Association and the Attorney General's Office yesterday.

The law gives hope to those left out of the right to complain to court against their grievances, the outgoing chief justice said, terming the legal profession noble and advising lawyers to go ahead with their work to protect the interest of all.

"The law provides the basis for our freedom and rights," said

Hasan, appointed chief justice on June 22 last year, superseding two judges of the Appellate Division in a breach of seniority convention.

Before leaving office, Justice Hasan will submit to President Iajuddin Ahmed a report of the Supreme Judicial Council, tasked with dealing with an allegation of bail fix against a High Court additional judge.

Justice Syed JR Mudassir Husain is likely to be the next chief justice in another probable breach of seniority convention in the Appellate Division where Justice M Ruhul Amin is next in terms of seniority, followed by Justice Fazlul Karim.

At yesterday's event, Supreme Court Bar Association President Barrister Rokanuddin Mahmud accused the government of political

Crane lifter crashes, killing 2 workers

Two construction workers fell about 60 feet to death when the lifter of a crane they were on broke loose from the chain and crashed at the Bangladesh Bank's head office yesterday.

The dead are Lokman, 20, and Abdul Karim, 17. Their colleague Monu Mia, 18, who was also on the lifter sustained injury and is undergoing treatment at Dhaka Medical College Hospital (DMCH).

Monu told The Daily Star that they were climbing to the roof of the building on the lifter at 5:15pm.

"We were about to reach the roof when the chain snapped," Monu said.

The lifter fell on the roof of the building's extended two-storey part and Lokman died on the spot. Karim died later at 6:00pm.

KUSHTIA BY-POLLS EC finalises candidate list

The candidates for the February 29 election are Reza Ahmed Bachchu (BNP), M Korban Ali (JP-Najrul-Firoj), Abdul Halim (JP-Monju), Azibul Rahaman (JSD-Rob), Shahid Uddin (JSD-Ind), Abdur Khaleq (People's Party), Nazrul Islam (Muslim League), Nazrul Islam (NAP-Bhashani) and Shahidul Islam (independent).

1 killed as gang sprays bullets on Rangamati villagers

Armed miscreants yesterday sprayed bullets on a group of villagers killing an indigenous man and injuring two others at Pukurchhari village in Rangamati.

A 15-strong gang opened fire on the villagers who refused to pay toll on their way to Kutukchhari Bazar under Naniarchar upazila, local sources said.

Tarit Chakma, 25, died on the spot while Mohini Mohan Chakma, 22, and Shyamal Chakma, 28, were wounded in the attack, police said.

A team of army and police went to the spot and recovered Tarit's body and sent the injured to Chittagong for medical assistance, locals said.

Meanwhile, the United Peoples Democratic Front (UPDF), an anti-CHT peace accord group, held a rally at Kutukchhari Bazar and blamed Parbatya Chattagram Jana Sanghati Samity (PCJSS), the pro-peace accord organisation, for the 'barbarous shooting on innocent villagers'.

Protesting the armed assault, the UPDF also announced to block the Rangamati-Khagrachhari and Rangamati-Naniarchar highways today.

B Chy to float political body next month
