Security scurry for Eid

20 strike forces, 15 mobile courts to be deployed

UNB, Dhaka

The government has decided to immediately deploy 20 strike forces and 15 mobile courts in the capital in the run-up to Eid-ul-

A combined force of 4,258 Dhaka Metropolitan Police (DMP), 460 Bangladesh Rifles (BDR), 215 Armed Police Battalion (APBn)and 251 Ansar personnel have been deployed in this large-scale security operation, an official announcement said shortly after a decision to this effect was taken at a meeting at the Home Ministry.

Besides, plainclothes cops and Rapid Action Team will be in action in different areas of the capital.

Special arrangements have been made for ensuring security at Eid congregations and for clearing cattle skins and filth during the Eid holidays on an area to area basis.

The strike forces and mobile courts will remain in place till February 5 in areas under 22 police stations in Dhaka city, according to the decision of the meeting that also planned Eid security across the country.

Presiding over the high-level meeting on law and order situation, State Minister for Home Affairs Lutfozzaman Babar directed the law enforcers to take allout measures for checking criminal activities before and during the festival of Eid-ul-Azha.

Home Secretary Muhammad Omar Farooq, Inspector General of Police Shahudul Haque, Dhaka Metropolitan Police Commissioner Ashraful Huda and other high officials from ministries concerned, divisions and departments were present at the meeting.

Magistrates will lead the mobile courts in the operation. The strike forces comprise personnel from BDR, DMP and APBn. Besides, vigilance tams comprising police, Bangladesh Road Transport Authority (BRTA), Bangladesh Inland Water Transport Corporation (BIWTC) and Dhaka

City Corporation (DCC) personnel

will go into action at launch, bus

and railway terminals. Police, BDR and Ansar will be deployed at 400 key points of the capital to curb criminal activities. Block raids will be carried out in different areas, checkposts will be activated and preventive measures taken to curb extortion and robberies on the roads and highways throughout the country.

They said a youth named Himel along with some leaders and activ ists of the Hazi Mohammad Muhasin Hall unit of the Jatiyatabadi Chhatra Dal (JCD), the student wing of the ruling BNP, kidnapped Jannat Ara Rani from the business studies faculty at around 11:30am.

The abductors also confined to hall her two cousins Dulal and Ripon who escorted her to the campus, the family said. The JCD men then came to Rani and asked her to follow them if she wanted to see them alive. However, the cousins were released on Saturday.

"Rani talked to us over mobile phone and told us that she does not know where she has been con-fined," a family member said, adding that they did not file any t h e

More graft at DFP

More irregularities have surfaced in the purchase of equipment under a project of the Department of Films and Publications (DFP), as authorities are moving closer to press graft charges against the director general (DG) of the depart-

Officials at the Ministry of Information said documents show that DG Syed Mahbubur Rahman paid \$19,371 in foreign currency to the local agent as its commission, although the agreement signed with the suppliers stipulates the payment has to be in local cur-

By so doing, the DG caused huge loss to the national exchequer, they observed and added that the DG did not care to take permission from the higher authorities to pay commission to the local agent in foreign currency.

The ministry officials believe the DG may have siphoned off the foreign currency.

Rahman already faces charges of embezzling around Tk 36 lakh in purchases and in use and supply of films.

An inquiry has revealed that around Tk 36 lakh has been withdrawn against fake bills for four

films and through tender manipulation and irregularities in 2001-2002 and 2002-2003 financial

The DG undertook production of four documentaries and three video films without prior approval of the ministry and illegally obtained raw materials, causing loss to the national exchequer.

The ministry launched proceedings against the DG with the approval of the prime minister and president. He has been accused under articles 7 (1) (A), 3 (B) and (D) of the "Public Servant (Discipline and Appeal) Rules, 1985" following he report of a committee probing the charges.

The ministry this time found the DG and some other officials of the department misappropriated funds in purchasing ultrasonic film cleaning machine and spare equipment for sound and projection under the BMRE project.

According to official documents, the DFP signed agreement with RTI-UK Limited, UK represented by their Bangladeshi agent on June 9, 2002 to purchase 16/35 mm ultrasonic film cleaner at a cost of \$1,04,115.68 (around Tk 60 lakh), including a 4 percent commission for the local agent.

8,000 Nawabpur shops keep shutters down

Around 8,000 shops in Nawabpur area of the capital kept their shut-ters down for two hours from noon yesterday as part of a token strike demanding a proper probe into the murder of a local trader and immediate arrest of the killers.

More than a dozen trade bodies, which jointly called the strike, issued a 20-day ultimatum for arrest of the killers of SM Shariful Hoque Siraii. Their earlier ultimatum ended on Sunday with police

JS body against fresh tender

A parliamentary standing committee yesterday differed with the Cabinet Committee on Public Procurement and asked the telecoms ministry not to float fresh tender for the \$53 million project by the state telecoms monopoly to launch 250,000 cellphones.

The Cabinet Committee on Public Procurement on Saturday rejected state monopoly Bangladesh Telegraph and Telephone Board's (BTTB) proposal on the project, saying it was riddled with gross inconsistencies. It also asked the state telephone monopoly to float tender afresh.

The parliamentary standing committee on the Ministry of Post and Telecommunications at a meeting yesterday at the Jatiya Sangsad Bhaban also asked it to review the project and submit its plan again to the purchase com-

"Different committees like public scrutiny committee and technical evaluation committee and the judgement of the High Court observed no irregularities in the tender process. So there is no need to float fresh tender for introduction of BTTB's cellphone," G M Fazlul Hague, chairman of the committee,
