

Fire at temple  
Arrest of  
culprits  
demanded

Members of the Hindu community in the port city yesterday observed a hunger strike at the local press club demanding immediate arrest of the culprits responsible for the fire incident at the Gangabari Temple premises at Patharghat in Chittagong on the midnight of January 24.

They also demanded the arrest of the Deputy Commissioner (north) of Chittagong Metropolitan Police (CMP) Meah Lutfar Rahman Chowdhury and Awami League-backed local Ward Commissioner Jalaluddin Iqbal accusing them of masterminding the incident to meet the interest of a vested group.

Hindu leaders also urged the government to take immediate initiatives for the reconstruction of the damaged temple.

They also held a rally at the same venue.

Speakers at the rally alleged that the police created obstructions for the devotees who were coming from Patharghat and Kotwali to observe the hunger strike at the press club and snatched their banners.

They also demanded the withdrawal of "false" case against the Sebeyat (custodian) of Gangabari Temple Shyamal Sadhu along with other devotees.

The speakers also demanded immediate release of Nibaran Das who was arrested in connection with the incident.

Govinda Das, Kanchan Biswas, Nidhu Kumar Biswas, Jhantu Kumar Das, Swapan Das, Dibakar Das, Gopal Jaldas and Jagadish Das addressed the rally.

## 47 audit reports submitted to Khaleda

Comptroller and Auditor General (CAG) Asif Ali called on Prime Minister Khaleda Zia at her office yesterday and submitted 47 audit reports to her.

The audit reports include 30 annual reports of fiscal 2001-02, 16 special reports, and one appropriation report.

Receiving the audit reports, the prime minister appreciated the recent steps taken by the CAG to enhance the quality of audit through modernisation.

She stressed the need for continuation of the modernisation process by making the reports concise and easy to ensure accountability, transparency and discipline in financial sector.

Khaleda also underscored the

need for training of audit officials and immediate construction of Audit Bhawan and Financial Management Academy (Fima).

She suggested that the CAG office can accelerate its activities in international forums to enhance the country's image abroad.

The CAG said the Department of Commercial Audit settled 94,703 audit objections, out of 1,40,224 in banking and financial sector, under a crash programme from April 17 to November 11 in 2003.

He said the CAG office received letters of appreciation from the World Bank, UNDP and ADB for the standard of its audit.

Asif Ali also informed the prime minister that the 'value for money audit' or performance audit has been introduced in phases in place of traditional audit to determine

volume of failure or success of the expenditure of budget money in an audited organisation.

All BCS cadre officers up to director generals are going to the field level for auditing, he added. A total of Tk 10 crore has been saved following a real audit, at the request of finance ministry, in the allocation for advertisement in information ministry, he added.

He said internal training has been established as a regular system in all offices under the CAG.

The CGA office extended all-out cooperation to Public Accounts Committee which had seven meetings and recovered about Tk 100 crore so far, he said.

The CAG told the prime minister that the construction of Audit Bhawan will begin in March under a Tk nine crore project and it was expected to be completed by December 2005.

The process of establishing Fima complex on its own land in Mirpur is also underway, he added.

## Jubo League leader, college student gunned down

A city Jubo League leader and a Tongi College student were shot dead while the body of a police informer was recovered in last five days.

Jubo League leader Golam Mostofa alias Labu, 32, a resident of Madhya Monipur in Mirpur, was shot dead at West Shewrapara on Saturday night. Kamal Uddin, a first year HSC student, was shot dead at Tongi yesterday, and the body of Biplob was recovered at Karwan Bazar on Sunday morning.

Mirpur police said someone informed Labu's brother-in-law Rafiq over cellphone that his body was lying abandoned in the area.

Later, they recovered the body from there.

Rafiq filed a case in this regard.

On July 29 of last year, six gunmen opened fire at Labu's wedding reception at Kazi Community Centre at Kazipara killing a pregnant woman Najma Akhter, sister of his bride Afroza Akhter Doli, and injuring 12 others.

Locals caught two attackers-Amir Hossain Babu and Shahed Ali who told the police that they went there to kill Jubo League Tejgaon Thana unit General Secretary Shabbir Alam Litu.

However, Labu's relatives could not ascertain the reason for his killing and its link to July 29 incident.

Meanwhile, Kamal Uddin, a first year HSC student, was standing in front of their house at Madhya Arispur in Tongi when some unidentified youths opened fire on him, said his father Abbas Uddin.

Kamal was rushed to Tongi Hospital in a critical condition.

As his condition deteriorated further, Kamal was shifted to Dhaka Medical College Hospital where the

doctors declared him dead.

Tongi police said Kamal, a listed criminal, has been charged in two cases.

No case was filed or no one was arrested till filing of this report at 7.00pm yesterday.

The slaughtered body of police informer Biplob alias Japoni Biplob was recovered from Karwan Bazar fruit market in the morning of February 1.

Locals alleged that Biplob was killed as a sequel to feuds among the two groups of criminals controlling drug trade and extortion at Karwan Bazar.

Biplob, a resident of a slum at Tejkunipara, was slaughtered near Janata Tower on Saturday night, they added.

Tejgaon police said they arrested two youths in connection with the killing.

## 702 more held, 5 firearms recovered

Police arrested a total of 702 people, including three listed criminals, during their ongoing countrywide drive in last 24 hours till 6.00am yesterday.

They also recovered five firearms and 11 rounds of bullets and filed four cases against seven people under the Arms Act, said a press release issued by the police headquarters.

## Hasina condoles death of Hajis

Awami League President and Leader of the Opposition in Parliament Sheikh Hasina yesterday expressed her deep shock at the death of 244 Haj pilgrims, including 10 Bangladeshis, while performing the Haj rituals in the holy city of Mina.

In a message of condolence, she also expressed her profound grief at the death of 22 Bangladeshi Hajis, who died due to illness.

She said the incident took place at a time when the entire Muslim Ummah was celebrating the holy Eid-ul-Azha.

## Death anniversary



The seventh death anniversary of Dr AR Mallick, a noted educationist and former finance minister, was observed yesterday, says a press release.

The founding vice-chancellor of Chittagong University, Dr Mallick was the Professor of South Asian History at the University of Pennsylvania, USA.

During the liberation war, he represented Bangladesh at the UNO and also delivered lectures to universities across the USA to mobilise support for the independence.

He was also the first education secretary and the first high commissioner of Bangladesh to India. Dr Mallick was elected chairman of Asian Development Bank in 1975.

The 'British Policy and the Muslims in Bengal' and 'Amar Jibon Kotha O Bangladesher Mukti Sangram' are amongst his important publications.
