Beaten to death by husband

OUR CORRESPONDENT, Satkhira A housewife was beaten to death allegedly by her husband at Gangnia village in Sadar upazila on Thursday night.

The victim was identified as Taslima Khatun, 25, wife of Rustam Ali.

Quoting local people police said Rustam Ali married Taslima daughter of Sajjad Ali of Umrapara village in Sadar upazila four year back. After the marriage he took Tk 5,000 as dowry. He was demanding more dowry from his father-in-law who failed to meet the demand. He tortured his wife on the fateful day resulting her instant death.

Bogra BNP MP to face Death after arrest sparks forgery case

Tk 3.20 cr bank loans taken for "fake" project now stands at Tk 10.5 cr : Mortgaged lands "forcibly reoccupied"

The Janata Bank is preparing to file a criminal case against ruling BNP lawmaker Helal-uz-Zaman Thalukder Lalu and his business partner Mahabubur Rahman Talu for "violating" agreement with the bank.

The case will be filed with a magistrate court here under sections 402 and 406 of BPC (Bangladesh Penal Code) after delivery of the verdict by the Bogra Artho Rin Adalot (loan recovery court) regarding their defaulted loans, according to sources at the Shoptopody Branch of Janata Bank (JB), which disbursed the loans.

The Adalot will give its verdict on March 4, sources there said.

The two persons took loans of Tk three crore 20 lakh in the name of setting up a tannery named Bogra Tannery at Lichutola in Bogra sadar upazila. The loans disbursed between 1986 and 1992 stood at Tk ten crore 50 lakh with interest as on December last year, the sources

But no tannery was set up there. "So it is a forgery case because the loans were taken by showing a fake project", one source at the bank told this correspondent on Thursday, Of the amount. Tk one crore 20 lakh

was project loan and Tk two crore cash credit, he said.

The borrowers are defaulters on two counts-- for taking loans showing a "fake" project and for not repaying it, he said.

The sources also alleged that the loan defaulters have "forcibly reoccupied the mortgaged" lands at Lichutola and at other places against the loans. The case with the Artha Rin

Villagers lay siege to Taraganj thana, 2 cops suspended

Angry people from Katgari village in Kishoregang upazila in Nilphamari district laid a siege to neighbouring Taraganj thana in Rangpur following the death of a young man after arrest.

The people withdrew the siege following local lawmaker Amjad Hossen Sarkar's assurance of proper investigation. Amjad is a lawmaker from Kishoregang-Saidpur constituency. The victim, Enamul Hag, son of late Jan Mamud of Katgari village, is reportedly a BNP activist.

Rangpur Additional Police Superintendent Harun-ur-Rashid also rushed to Taragani thana and suspended Sub-inspector (SI) Bazlur Rahman and Constable Alimuddin. Additional police were also sent there.

According to Taraganj police, Enamul was arrested by SI Bazlur Rahman of Taraganj thana on the Eid night from Taraganj Chowpatti. He

was drunk, they claimed. He was released at about 9 am next day after he gave an "undertaking" and was escorted home at Katgari village by Constable Alimuddin

The victim's family alleged that reaching home. Enamul told his wife that he was feeling severe stomach nain. He was taken to nearby Taraganj Upazila Health Complex and then shifted to Rangour Medical College Hospital (RMCH) where he died at about 11:00 pm on Tuesday.

As the news spread, angry people from Katgari village laid a siege to Taraganj thana, alleging that Enamul died from police torture.

Enamul's mother Jokion Bewa said her son told her that a rubber pipe was inserted into his stomach through the mouth. But SI Bazlur Rahman denied this and said he died from excessive drinking

Rangpur Police Superintendent Manjur Kader told newsmen yesterday that the reason for the death would be ascertained after the post-

mortem report is available. The body of Enamul was handed over to his relatives on Wednesday after postmortem at RMCH but police said yesterday that they were yet to get the postmortem report.

Meanwhile some sources claimed that Emanul used to collect toll for police. He was tortured as he misappropriated the whole money he collected on the eve of the Eid from different sources.

'BIWTC negligence costs life'

Navigation risky as 22 out of 32 beacon lights out of order in Patuakhali, 4 stolen

Navigation in Patuakhali has become very risky due to absence of beacon lights in most of the routes, which often cause accidents and claim lives.

Twenty-two out of 32 beacon lights are out of order for long and another four, stolen long ago, are yet to be re-installed, BIWTA (Bangladesh Inland Water Transport Authority) sources here said.

At least 50 launches ply the routes during daytime and at night. The risk increases at night and in early morning when visibility is reduced by dense fog, launch operators said.

In the recent accident that took place on Thursday, at least 12 people were killed and over 100 injured when two launches collided on the Meghna in Hijla, allegedly due to poor visibility in absence of beacon light.

Sources said solar chargers of beacon lights are being stolen by an organised hand of thieves. One light costs Tk 34,000 to Tk 40,000. The thieves sell those in black market,
