#### More 'pro-BNP staff' brought to Dhaka zone of Titas

The Titas Gas Transmission and Distribution Company Ltd (TGTDCL) yesterday transferred its 26 Dhaka-based staff to accommodate pro-BNP trade unionists from different zones outside the capital.

All these 26 staff are activists of the Titas Gas Karmachari Union -an affiliate of the AL's labour front Jatiya Sramik League, and the 25 replacements mostly belong to three BNP-supported trade unions, sources said. Name of the other replacement is yet to be finalised.

The alliance government has so far transferred 574 Titas staff from Dhaka since coming into power. Trade unionism in the TGTDCL has been 'officially' suspended for over a year now amidst the cry to save the organisation from the clutches of militant unionists.

But the BNP-backed trade union leaders have remained active unofficially and are even influencing the TGTDCL management for transfers and promotions.

"Transfers are meant to soup up the organisation," observed a Titas official, "but this is not the case here.

# **Denial of basic** rights now an everyday affair

#### **Democratic Lawyers' Association** conference told

The people are now suffering mainly due to violation of the constitution in governance and denial of their fundamental rights has become an everyday affair.

Senior lawyers expressed this view at the third national conference of Bangladesh Democratic Lawyers Association held on the Supreme Court premises vesterday.

Addressing the conference, Supreme Court Bar Association President Rokanuddin Mahmud said the practices of the state's executive organ are far removed from constitutional provisions.

"We are passing thorough a critical juncture in national life. People are being dehumanised in police custody and in the open

streets as well." he said. President of International Association of Democratic Lawvers Jitendra Sarma could not attend the conference because he was denied

Leaders of Indian Bar Council from West Bengal, Karnataka and Tamil Nadu attended it.

Former High Court judge Naimuddin Ahmed said the constitution is being flouted since 1972 and its mutilation began with 1st and 4th amendments.

He called upon the lawyers to play their due role in protecting the judiciary from corruption. The bar and the bench must unite to establish a corruption-free judiciary, he

### Concern over below-par madrassah edn

JS body asks boards to fight exam cheating, corruption

Most teachers, students and unscrupulous board officials are responsible for substandard education in 16,429 registered madrashas across Bangladesh, a parliamentary body observed at a meeting yesterday

The parliamentary standing committee on the education ministry asked the ministry to immediately take effective measures to improve the standard of madrasha education, pegging the situation as grave.

'The madrasha board gives subpar education as teachers are not attentive to their duties and students tend to copying in examination, Shamsul Alam Pramanik, chairman of the committee, told newspersons emerging from the meeting at the Jatiya Sangsad Bhaban.

The parliamentary body also asked the general education board chairmen, who attended the meeting on special invitation, to free the boards from corruption and bring

The ban has been imposed as the book caused severe hatred and reaction in the state, society and religious community in Bangladesh as it contains serious objectionable statements on Islam and Prophet Hazrat Mohammad (SM), the handout said.

### SC judge appointment adds to superseding

#### Justice Amirul Kabir elevated to **Appellate Division**

The government yesterday appointed a judge to the Appellate Division of the Supreme Court by superseding a senior judge of the High Court Division.

Justice Amirul Kabir Chowdhury superseded senior judge Syed Amirul Islam in the appointment that was signed by President lajuddin Ahmed in consultation with Prime Minister Khaleda Zia.

Earlier, Justices MM Ruhul Amin. Tafazzul Islam and MA Aziz superseded Justice Sved Amirul.

The appointment was made to fill the vacancy left by the retirement of Chief Justice KM Hasan on January

His appointment will be effective from the date of his swearing-in, an official handout said

Justice Syed Amirul is the most senior judge of the High Court Division, who was appointed as a judge of the court on February 10. 1994, much ahead of Amirul Kabir, who joined on June 1, 1996.

## Cops want phones with caller ID

Law-enforcement agencies have called for telephones with caller identification device to detect anonvmous callers blamed for spreading bomb and fire scares.

An official said police informed the home ministry about it after some international flights were delayed as anonymous callers told Zia International Airport that bombs were secreted in the planes, which proved hoaxes in a string of recent

Police carried out a hectic operation for hours in the diplomatic enclave in Baridhara last month in search of bombs after a call from an unknown person.

"Such calls have became an worry for us and we have no mechanism to know the caller's identity in case of a hoax," a senior police official told The Daily Star. The ministry plans to forward a

request to Bangladesh Telegraph and Telephone Board (BTTB) to

A senior BTTB official says only new exchanges have such facility. adding: "If the authorities want, the BTTB can provide CLIP for phones at police stations to track misleading information."

The BTTB can easily replace the old phones with CLIP-enabled sets but phones under the old exchanges require upgrading to offer such facility. An official says the BTTB

planned to introduce caller ID for all phones under a project but it could not be done as it involves huge "It requires a customised soft-

ware to enable old exchanges with caller identification device which is costly." the official said, adding the project is going slow as the BTTB did not charge for caller ID. Earlier the BTTB planned to introduce CLIF as a value-added project.

Telephone subscribers believe a substantial reduction in unwanted

calls can curb call-related crimes. "Some callers call people with intent to annoy them," says Shahfigul Alam, a BTTB subscriber.

## Two more GIs killed in Iraq

Insurgents killed two American soldiers yesterday in a roadside bombing west of Baghdad as the United States was reportedly ready to make major changes in its blueprint for handing over power to a new Iraqi government. The bombing occurred near

Khaldivah, 50 miles west of the capital, according to the US command. Two soldiers from Task Force All-American were killed, along with at least one Iragi, the command said. One US soldier was wounded. Insurgents also fired a rocket-

propelled grenade Thursday at an American convoy in Khaldiyah but the projectile missed, witnesses Those deaths brought to 545 the number of American service mem-

bers who have died since President Bush launched the Iraq war on March 20. Most of the deaths have occurred after Bush declared an end to active combat May 1.

With casualties mounting in an election year, the Bush administration would like to transfer political power to the Iraqis by the end of June and shift more security

responsibility to the US-trained Iraqi

Bush wants to end the occupation well ahead of the November presidential election in the United States to minimize Iraq as a campaign issue. However, the formula for establishing a new government remains in dispute.

US and Iraqi officials were awaiting an announcement later Thursday by U.N. Secretary-General Kofi Annan on the feasibility of holding legislative elections here before June 30, as demanded by Grand Ayatollah Ali al-Husseini al-Sistani and others in the influential Shiite clergy.

The Bush administration hopes Annan will say that elections are impossible by June 30 and endorse the idea of extending and expanding the US-picked Iraqi Governing Council so it can take interim control of the country on July 1.

In an interview with the Japanese newspaper Yomiuri, Annan said elections were essential in Iraq but they could probably not be held before the transfer of power.

## Traditional venue ends up in BNP's **JSSS** hands

Ruling BNP's cultural front has forced the Sammilita Sangskritik Jote (SSJ), a non-political cultural body that had been organising the Amar Ekushey programmes since 1984, to shift its traditional venue from the Central Shaheed Minar to Rabindra Sarobor Mancha at

Dhanmondi lake The Jatiyatabadi Samajik-Sangskritik Sangstha (JSSS) last year also drove the SSJ out of the venue, sources alleged.

SSJ President Nasir Uddin Bachchu viewed the move as a blow to the national heritage and felt a permanent guideline should be there on the use of the Shaheed Minar venue. "If the government or the (Dhaka University) authorities want a dialogue on the matter, we are ready to sit," he said.

The SSJ and JSS are trading blames over the issue. The JSSS claimed to have obtained Dhaka University's (DU) permission to use the venue but the SSJ said it had been organising the programmes commemorating the Language

Movement at the Central Shaheed Minar for 20 years and never before did it require permission from the

JSSS President Wasimul Bari Rajib said they are organising the programmes at the Shaheed Minar after getting the nod from Dhaka University authorities.

DU Proctor AK Firoz Ahmed said the JSSS asked the university authorities for permission to hold its programmes at the Shaheed Minar from February 16 to 19 and DU Vice-chancellor Prof SMA Faiz gave the nod. But, the SSJ had not taken permission from the DU.
