Send Azad abroad by Mar 14 for treatment

Dhaka University Teachers' Association (Duta) has exempted all the traditional and course final examinations from their strike but vowed to continue work abstention programme until their demands are met.

The association took the decision for greater interests of the students at its executive committee meeting yesterday, with its President Prof. Dr AAMS Arefin Siddique in the chair.

It has been on the strike since February 28 demanding immediate arrest of and punishment to the 'real culprits' responsible for the butcher's knife attack on prominent writer Prof. Humayan Azad.

At the meeting, the association leaders demanded that the DU authorities send Prof. Azad abroad by March 14 for better treatment.

If they fail to do so, the association will take initiative to send him abroad, the Duta president said.

The association also condemned the statement issued to the press by six Duta members and leaders.

The teachers will form a human chain at the foot of 'Aparejeyo Bangla' at 11.00am tomorrow as part of their ongoing agitation demanding arrest of the attackers and resignation of the home minister.

Fraud case against DG of Manpower, 21 others

Afraud case was filed against director general of Manpower, Employment and Training Bureau, Dhaka and 21 others with the Chief Metropolitan Magistrate's (CMM) Court, Dhaka yesterday.

The case was filed against Director General Motiur Rahman, Director (Welfare) Shafiqur Rahman Chowdhury, Deputy Director (Welfare) Mohammad Humayun Khan, Chief Assistant (Welfare) Mohammad Abul Kashem and investigation officer in Noakhali district office Mohammad Nurunnabiand 17 others.

After hearing, Metropolitan Magistrate Mohammad Emdaul Haq took the petition into cognizance and directed the Officer-in-Charge of Motijheel Police Station to register it as a regular case upon the investigation.

In her complaint, Mosammat Anwara Begum of 29/J Block in the city's Motijheel area told the court that her younger brother Jasim Uddin working in Saudi Arabia died in road accident on November 19,1994. Later, victim's family members were given TK 13 lakh as compensation and the court gave an order for distribution of the money among the heirs (including the complainant) of the victim in accordance with the Muslim Law. But the accused in connivance with others misappropriated her entire share of Tk5lakh, the complainant added.
