RIVER DIVERSION PLAN

Fact-finding mission to study adverse effect in Bangladesh

A fact-finding mission to Kansat in Chapainawabganj is being organised by the Citizens Fact-finding Commission to study the adverse effect of diversion of rivers at upstream in India on March 16.

The visit is being organised against the backdrop of Indian mega plan to inter-link the Himalayan rivers leaving the economy, ecology and livelihood in Bangladesh in tatters.

The citizens commission representing about 20 organisations of environmentalists, journalists and human rights activists will make down to earth rapid investigation to bring to the notice of people what adverse impacts diversion of rivers causes to life and livelihood of people who live at downstream of rivers in Bangladesh.

The trip involving the participation of several thousand people will begin from the National Press Club, Dhaka at 6 am on March 16. The participants will have interactions with citizens of Rajshahi who are also sufferers of diversion of water of the Ganges, at Rajshahi Madrassah ground at 12 noon.

The convoy of citizens commission will set off for Kansat from Rajshahi at 2 pm. After having interaction with farmers, fishermen, boatmen, businessmen and elite of the area, the citizens will return to Rajshahi at 7 in the eve-

A sluice gate is being constructed illegally by cutting Water Development Board's embankment on Kholpetna river at Khalishabunia in Shyamnagar

About 4000 bighas of shrimp enclosures will be inundated if the sluice gate is constructed at that point, local people claimed while talking to this correspondent recently. They urged the authori-ties concerned to stop the construction.

A 24-hour (Ashta Prohor) 'Nama Kirton' was also held in her memory They said one Bappi of Khulna is constructing the sluice gate at polder No. 15 without the authori-Relatives, well-wishers, journalists, businessmen, different professionals and government officials attended the Sraddha.

Earth has been removed from a

sizeable portion of the WDB embankment and bricks, sand and cement have been taken there for the construction work.

The local people alleged that Bappi has collected a handsome amount of money from a few owners of shrimp enclosures assuring them supply of saline water for shrimp cultivation. Once the sluice gate is completed and saline water supplied, 4000 bighas of shrimp enclosures will go under water, they said.

The local people also held demonstrations protesting the illegal move and urged the officials concerned to take take action, but to no effect, they said.

There are croplands in the area, which will also reel under saline water, they said.

Abduction bid foiled in Barisal court area, 2 beaten by mob

Two persons were beaten by a mob on the Barisal magistrate court tried to snatch two persons accused in a case.

Those beaten are Parimal Chandra Pal, Nalchhity upazila fishery extension officer in Jhalakati district and Laden Tarek, a BNP activist and alleged drug peddler, police and witnesses said.

After the incident Laden Tarek

filed a case with Kotwali thana against some lawyers including TM Yunus office secretary of Barisal district Awami league and former president of Barisal Bar. Other named in the case are Majibor, Manjur, Delware Munshi and Delwar Hossain Dilu, all leaders of Awami Ainjibi Parishad.

Police said Parimal and Laden Tarek tried to snatch Gopal and Milon, accused in a case for allegedly stealing Parimal's mobile phone, ornaments and money.

Gopal and Milon had gone to

a magistrate court in Barisal on Sunday to conform a bail granted to them by the High Court in the case.

As they were preparing to appear before the magistrate court, Parimal and Laden Tarek tried to snatch them from the lawyers.

Hearing the hue and cry, their lawyers and others came and foiled the bid and beat Parimal and Laden Tarek. Some of the lawyers were also injured in the incident.
