ASA, Jagoroni Chakra help restore lost glory of Magura village

Life is now meaningful to Nabiron, an abandoned housewife of Gopalnagar village in Mohammadpur upazila here. She is now a wealthy woman in the area by selling bamboo-made traps to

Fortune smiled on Nabiron, a mother of three sons, when ASA (Association for Social Advancement), a major NGO (Non-Governmental Organisation) came forward to her rescue by providing training and micro-credit for small entrepreneurs. ASA offered her a loan of 9.000 taka in 2001. Making good use of the loan she set up a bamboo-based cottage industry on her father's land. She started making bamboo- made traps to catch fish, locally called 'dohar.' She used to make a fish trap at a cost of six taka and sold it at 12 taka. Every Saturday she began to supply her product to the wholesalers from her house at the rate of 1.200 taka per 100 traps. The wholesalers sold her product to the adjoining districts of Faridpur and Rajbari.

"Now I earn 3,000-4,000 taka each month and my children are attending school," smiling Nabiron told this correspondent. With the profit she also built a tin-shed house last year.

Once Telipukur and its surrounding villages were famous for cottage industries, locals told this correspondent. But due to shortage of capital and lack of partronisation, bamboo-based cottage industries faced ruination, they

However, ASA initiatives brought back the lost glory of the villages. At present 31 women at Telipukur village only are involved in manufacturing bamboo-made fish traps. The names of a few

women like Nabiron, Selina Monjina, Hasina, Zakia, Fatema Angura, Nilupha and Pervin are worth mentioning.

Here is a story of another woman named Nilupha at this village. Only three years back the poor housewife, also mother of five children had to live in extreme poverty. Because her rickshawpuller husband could not feed his family of seven members with his meagre income.

About two years back Jagoroni Chakra, another NGO brought back Nilupha's good days. Jagoroni provided her with a microcredit of 8,000 taka. Utilising the credit she also started manufacturing 'Dohar'. Now her monthly earning rose to 4000 taka per month. She told this correspondent that she got her eldest daughter married to a man of her choice this year with her savings

Faulty rubber dams hamper boro cultivation in Gazipur, Mymensingh

Boro cultivation on 400 hectares of land in two upazilas faced a setback due to unplanned construction of two rubber dams in two rivers. The Local Government

Engineering Department (LGED) constructed the two rubber dams, one at Urahati point on the Khiru in Bhaluka upazila here and the other at Golaghat point on the Matikata in Sreepur upazila, Gazipur.

The three crore taka project was aimed at producing an additional 2,300 metric tons (MT) of crops on 400 hectares of land in dry season.

Initially the dams were constructed to contain sufficient water upto a height of maximum 12 feet, needed for irrigation in the dry season. But farmers in the upstream faced problem in boro cultivation due to water logging in dam area last

Workers of the Department of

Agriculture Extension (DAE) in two upazilas removed water by one foot from the waterlogged area but in vain. The farmers could not make up their losses

Moreover, because of siltation in the upstream of the rivers, the quantity of water was reduced in the dam areas. As a result, both the rivers dried up creating cracks at various points. In such a situation the farmers could not operate their power pumps to irrigate their fields during the dry season. Abdur Razzaq, a farmer at Urahati

village told this correspondent that before construction of the dams, the flow of water was smooth during the dry season. He used the river water to irrigate lands. Farmers have expressed their

opinion that if the rivers are dredged upto four or five feet at upstream, then the normal flow of the rivers in the dry season will be restored making the rubber dams effective

Bid to revive social afforestation programme

Finance Minister Saifur Rahman's intitiative brings hope for people in Moulvibazar

A fresh bid has been undertaken to revive the social afforestation project (SAP) here

Following publication of a story in The Daily Star recently, Finance and Planning Minister M Saifur Rahman took an initiative to revive the programme.

Under the initiative a fresh tripartite accord will be signed among the Bangladesh Water Development Board (BWDB), the Department of Forest and the concerned beneficiaries. The initiative brought hope for local people.

The finance minister inspected a project area of the programme adjacent to the 'Monu Barrage' near Moulivibazar town. He instructed the

departments concerned to take initiatives to continue the popular programme. He also advised people to plant saplings on BWDB embankment and roadside areas.

Forest and BWDB officials also visited different project areas in Moulvibazar and Rajnagar upazilas. During the visit, officials of both the departments assured people of renewal of the project for next 10

The Forest Officer of Moul-vibazar. Champalal Baidva told journalists that the department has taken necessary arrangement to plant saplings of 25,000 fruit-bearing and wooden trees on 25-kilometre areas of different embankments and roadside locations in Moulvibazar and Rainagai

No clue to Syedpur twin murder in Nilphamari

Police could not find any clue to the sensational twin murder at Mollahpara under Kashiram Belpukur union in Syedpur upazila on March 28.

A mother and her 48-day-old baby were slaughtered by unidentified killers while they were asleep at their house on the fateful night.

The victims were identified as Monira Sultana, 20, and Masuma.

The killer also tried to kill Monira's step son Abdullah, 12, who is now undergoing treatment at the

Rangpur Medical College Hospital

(RMCH) with grievous neck injuries. During the incident Monira's husband Azizul Islam, a madrassah teacher was not present at the house. He disclosed to police that he was away from his house after getting life threat from his opponents. He has a feud with his neighbour over land for a long time. Azizul and his opponents filed as many as 15 cases against each other till date. Of the cases one was a case of kidnap in which a son of Azizul was abducted. He remains missing

till filing of the report yesterday

However, after the incident

Azizul Islam lodged a case on March 28 accusing nine persons including the BNP president of Kashiram Belpukur union unit Kazi Ekramul Haque.

On April 5, the brother of the deceased housewife, Monira Sultana lodged a case against his brother-in-law Azizul Islam where he accused him of killing his sister.

Meanwhile, wounded Abdullah in a statement given before the magistrate echoed his father's voice. Police regard Abdullah as an important witness in the incident. But his statement differed the statement which he gave on the day of the incident.

Monira's brother told police and local people that his brother-in-law played a suspicious role in the incident. But Azizul Islam alleged that a powerful political quarter in Syedpur upazila is engaged to mislead the investigation in a bid to save the killers.

60 injured in B'baria clash

At least 60 persons were injured in a clash between two rival groups following an altercation at Chitna village in Nasirnagar upazila on Wednesday.

According to eye-witness and hospital sources, one person named Tauhid Mia was fishing in the pond of Askar Ali. There he started an altercation with Rahmat Ali. Later, both of their supporters equipped with lethal weapons locked in a clash that lasted for three hours resulting in injuries to both the groups. Five

houses were also damaged. Of them, Ahada Begum, 29, Kulsum, 15, Kulsuma Begum, 15, Ibrahim. 27. Tahera Kahatun, 18, Rahmat Ali and Taudhid Mia were sent to Madhabpur Upazila Health Complex. The rest were given first aid at a local clinic and Nasirnagor hospital

Property worth two lakh taka was damaged during the clash.
