Villagers rebuild 1.5 km road in Brahmanbaria

The villagers joined hands and did it voluntarily after repeated appeals for reconstruction of a road fell on the deaf ears of the

The 1.5 kilometre road from Moin Purbapara to Rishi Para under Mazlishpur union in Sarail upazila is nearing completion.

It was a different scene when this correspondent visited the village last week. People of all classes, from students and teachers to farmers and poor day labourers, were cutting earth with spades. The atmosphere was enthusiastic. Jubilant people were working as microphones blared music and patriotic

The villagers said as repeated appeals failed, they sat in a meeting and decided to reconstruct the road themselves before onset of the mon-

The only road linking Moinde and Fothehpur villages with the upazila Sadar and the district headquarter remains under one metre water during wet season, they said. It also connects Barura Bazar with Titas Ghat, a launch terminal in Titas river.

Life of about 5000 people of the villages depends on the road. Boat is the only means for children to go to school during wet season when the low lying area goes under water and the villages

remain isolated.

Over the years, the road was virtually washed away, creating enormous problem.

Several prayers were submitted to the Union Parishad and the local parliament member for its repair. But none came forward.

"As all efforts failed, I drew the attention of Sarail Upazila PIO (Project Implementation Officer) and managed allocation of six tonnes of rice under Food for Works Programme but the local

Union Parisjad Chairman diverted it for other projects", Fazilatunnesa, an elected local body member, told this correspon-

Naru Mia, Hanif Mia and Nasir Mia of Moinda village said politicos from UP chairman to parliament members came before election to seek vote. They promised to reconstruct the road. Once the election was over, they were

They said all the villagers sat in

a meeting in March and decided to do the job voluntarily.

"The meeting divided all the villagers into several groups", Naru Mia said

"The groups are working alternately. The work will be completed well ahead of the monsoon", he

"No one can change our condition if we do not help ourselves" said farmer Hanif Mia.

Patients suffer as BSMCH interns continue strike

Doctors place 6-point demand including security: Health Directorate informed, efforts on to restore normalcy, authorities say

At least 50 patients left Barisal Shere-Bangla Medical College Hospital till yesterday as treatment facilities collapsed since the interns went on strike Tuesday evening.

Hospital sources said nine patients died during the period. Relatives of the victims claimed that the deaths were due to lack of treatment.

The interns began the wildcat strike protesting ransacking of an office at the surgery ward and assault of some doctors by relatives of a patient for alleged negligence in treatment.

On Wednesday, the striking interns placed a six-point demand including assurance of safety and security of doctors and other staff and punishment of the attackers.

At about 8 am on Thursday, to the peril of hundreds of patients and

their attendants, interns locked the hospital campus including the emergency wing. The locks were removed at about 12:30 pm at the initiatives of the local leaders of Bangladesh Medical Association

On Thursday, they vowed to go for harder programme if their demands are not fulfilled within 72

(BMA) and hospital authorities.

Dr Md Abdul Jalil Sheikh, director of the hospital, said higher authorities in the Health Directorate have been informed of the situation and efforts are on to restore normalcy. But there was no progress till yester-

Treatment facilities have collapsed as the 500-bed hospital with a handful of senior doctors is mainly dependent on interns. The hospital accommodates over 700 patients.

On Tuesday at about 1.30 pm,

eight vear-old Mohiuddin Sheikh son of businessman Abdur Rahman Skeikh of Hatkhola Chawak Bazar area of the city, was brought to the hospital with critical burn injuries he suffered from contact with a live electric wire.

Doctors advised the boy's relatives to take him to Dhaka immediately as the hospital lacked facilities for treatment of such critical injuries.

The relatives requested the hospital authorities to allow a doctor to accompany the boy on way to Dhaka. The authorities declined, saying there was no such provision. They then ransacked the office at the surgery ward and assaulted some of the doctors.

The relatives later alleged that the doctors gave the advice without giving emergency treatment and proper nursing, a charge denied by

Most of those recruited are activists of ruling BNP, they claimed.

The leaders also alleged that the RU authorities violated the University Grant Commission (UGC) embargo on fresh appointment.

50 hurt in Kushtia clashes

At least 50 persons were injured in two separate clashes in Sadar and Daulatpur upazilas on Thursday.

Police said at least 30 workers were injured, 10 of them by bullet, in a clash between two groups of workers at Akij Bidi Factory in

The clash ensued when the factory owner's men and hired hoodlums attacked the general workers

The attack came when the workers were bargaining with factory manager Khorshed Alam at his room for their right to trade unionism in the factory including realisation of their long standing

As the news spread, more workers joined feuding fellow workers. The clash lasted for about two

After the clash the aggrieved workers blocked the Kusthia-Mahiskundi road for about an hour. In another cash at Ailchara village in Sadar upazila 20 persons were injured.

Finally both were locked in a fight.

Abducted child rescued

after paying Tk 1.5 lakh

upazila in Jhalakati district Thursday morning, was rescued in Barisal in the afternoon after payment of Tk 1.5 lakh ransom.

Md Shamim, 17, maternal uncle of the child, who claimed to have negotiated with the abductors, was arrested as the prime suspect.

The child's father, Md Giasuddin alias Chan Mia, who worked in Saudi Arabia, returned home eight months ago. Shamim. who appeared at the last SSC examination, came to his house two days

On Thursday morning, Shamim took Prince out of the house for

break fast. At about 2 pm, Chand Mia got a mobile phone call that his son was abducted. The caller asked him to come to Nathullabad bus stand in Barisal city with Tk 1.5 lakhs to free his son.

The caller threatened him not to inform police.

Chan Mia came to Barisal and informed police. Plainclothes police followed Chand Mia.

As directed by the abductors over phone, Chand Mia reached under a krishnachura tree at Nathullabd bus. He was then directed to go at Jail Gate Crossing on the Sadar Road.

There, Shamim told Chand Mia that he was negotiating with the abductors. Chand Mia handed over the ransom to Shamin. He went away asking Chand Mia to wait. After some time Shamim

returned with the abducted child. Waiting plainclothes police arrested

Police said Shamim planned the abduction. But the money realised from the child's father could not be recovered. Shamim told police that one

Sabuj and his accomplices abducted him along with Prince from Rajapur and forced them on gunpoint to contact Chan Mia for ran-

Talking to newsmen later in the evening, Chand Mia alleged that others involved in the abduction and the money could be recovered had police been more vigilant since he complained to them.

The Janaiuddha faction of outlawed Purba Banglar Communist Party (PBCP-ML) has claimed responsibility for the murder of Satkhira district BNP vice-president and Tala thana BNP president ABM

Altaf Hossain. Hossain, 55, a former chairman of Tala Upazila Parishad, died while being taken to hospital when three bombs were hurled on him on Tuesday night at Panchrata intersection near his party office while he was returning home from Patkelghata bazaar in a motorcycle

"Our cadres eliminated him (Hossain) as he was a class enemy", a fax message sent to local newspaper offices by Apu Rojario, self-styled Khulna divi-

Police arrested five persons after the murders.
