Villagers buy drinking water

Most tubewells in Nabinagar upazila in Brahmanbaria are highly arsenic-contaminated: DPHE identifies 216 arsenicosis patients: About five lakh exposed to danger

Unbelievable though, villagers have to buy drinking wate

They buy 10 litres of treated water at Tk 5 from a private plant at Nabinagar upazila headquarter because tubewell water is highly arsenic-contaminated.

But they are a microscopic fraction of a population of 48,8650 exposed to danger because groundwater in all the 196 villages except one is highly contaminated with

Ashar Alo Bebosaye Samati (hope traders association) headed by one Bikash Roy has set up the plant. Its lifts water from nearby Titas river and purifies it with Potash Alum and Chlorine. It supplies up to 6000 letres

But the buyers do no know how

Md Monir came from a far away village for water. "They (plant owners) apply the chemicals basing on assumption and have no tool to measure the ratio", he told this correspondent at the plant vesterday.

Bikash Roy said they examine the ratio of Chlorine with a test tube. There is no need to examine the ratio of Potash Alum as water can not absorb excess quantity of the chemical, he said The arsenic contamination has

created a crisis of drinking water in all areas of Nabinagar upazila because most of the ponds have dried up. At places, people are taking impure water of the Titas, causing diarrhoea and other water-borne diseases. Sources at the DPHE (Public

Health and Engineering Department) said 23,663 tubewells out of the 28068 in 195 villages have been found highly contaminated with arsenic. Rasulpur village in Natghar

union is the only exception. All the tubewells there are arsenic-free.

Arecent DPHE survey detected at least 216 arsenicosis patients in the upazila. The number is increasing.

In 58 villages, there is no tubewell free from arsenic. The groundwater is severely contaminated in 34 villages. These include Chander Char, Das Kanda, Sadekpur, Daponia, Islampur, Kamalpur, Lakhawra, Radhanagor, Bangaura North, Asrabpur, Pandabnagar, Padmanagor, Bhatpukur, Kajzlla, Barashikonika, Chalikhula, Chakrakhukla, Buldibari, Gunpukuria, Bajebi, Bandukhar, Nasrabari and Ghiara, DPHE sources said.

DPHE has marked the affected tubewells with red marks, forbidding their use. But finding no alternative. people are drinking arsenic contaminated water from red-marked tubewells, they said.

Arsenic damages kidney, liver and the nerves system, leading to

death, doctors say.


DPHE Sub-assistant Engineer Md Guulam Mastufa Buian at Nabinagar told this correspondent that he often visits the private plant but he has no equipment to test the treated water. Sometimes the owner of the plant shows him a 'fitness he said

According to the DPHE survey report, arsenic contaminated water is found at a depth of only 30 metres.

DPHE sources at Brahmanbaria said they have taken up a plan to sink 125 deep tubewells and dig 37 ring wells in the affected areas.

Besides, the Unicef-assisted Arsenic Mitigation Project is working on a plan to preserve rainwater for

DPHE Executive Engineer Fazlul Haque at Brahmanbaria when contacted said a plan has been taken up to mitigate the problem soon

Municipal polls: AL does better in Sylhet region

The Awami League (AL) and its allies performed well in the just concluded pourasabha (municipality) elections in Sylhet region.

In seven pourasabhas of the division, AL bagged three posts of chairman, 4-Party Alliance two posts; and Jatiya Party and an independent candidate got one post each.

In Sunamganj Pourasabha, a faction of the AL led by the party presidium member Suranjit Sen Gupta backed Moujdin. Sen joined Moujdin's processions and meetings violating the party decision. Moujdin came out victorious as chairman for third time defeating the AL candidate Ayub Bakht Jaglu also acting general secretary of the Sunamganj AL. Moujdin bagged 11,450 votes while Jaglu got 9,244 votes.

The Four-Party Alliance candidate Advocate Humayun Kabir Jahanur got only 1,755 votes losing his security money.

In Moulvibazar Pourasabha elections, six charman candidates brought serious allegations of irregularity against ruling party candidate Faizul Karim Mayun who had been declared elected unofficially. They demanded fresh poll in presence of the Army.

Agitation is still going on there. The district unit secretary of the BNP, Faizul Karim Mayun was unofficially declared chairman bagging 7, 677 votes.

Similarly, incumbent chairman of Habigani Pourasabha Advocate Shahid Chowdhury of the AL was defeated by the ruling party candidate GK Gous. Gous got 15,713 votes while Shahid bagged 9,373 votes. A serious allegation of rigging was brought against the ruling party candidate

In Kulaura Pourasabha, both the

4-Party Alliance and the AL candidates were defeated by independ ent candidate Kamal Ahmed.

In Nabiganj Pourasabha, the AL candidate and incumbent chairman Tofazzal Islam Chowdhury retained his position by a margin of only 146 votes defeating the Alliance candidate Advocate Abdus Shahid Golap In Madhabpur Pourasabha, both

the ruling party and the AL candidates faced resistance from their own party. However, the AL candidate Shah Mohammad Muslim Uddin got 3,721 votes while his rival candidate also his party man Advocate Mohammad

Ali got 1,236 votes.

În Shayestaganj Pourasabha, the Jatiya Party's Jahir Ahmed Moyna Miah became chairman bagging 5,700 votes while incumbent chairman Abdur Razzaque Raja got 3,446 votes.

Blind Selim is now a hawker and earns at least Tk 125 a day, thanks to the Satkhira unit of National Blind Welfare Organisation. He left begging in 1996 and started hawking brooms, cleaners and plastic articles on the streets of Satkhira town with Tk 2000 donated by advocate Shamsul Haq and advocate SM Haider, president and general secretary of the organisation here. Son of a day labouder, he had left the School for the Blind when he was a student of class eight at the age of 15. Selim, now 32, says he saved money from his small business and arranged marriage of his younger sister Amena. He is grateful to those who buy things from him. But he has qualms. He married in November last year but his wife left him because he is blind. "I am born blind. Is this my fault?" he said while talking to this correspondent.
