EPZs to have TUs from 2006

Limited trade union activities will be allowed in the exclusive industrial areas, the Export Processing Zones (EPZs), from November 1, 2006 Until then the existing Workers' Welfare Committees in the factories will protect employee rights, according to a draft law approved by the cabinet vesterday

The draft of the law titled "EPZ Workers Association and Industrial Relations Act, 2004" will be placed before parliament in the next budget session for its passage.

According to the proposed law, the existing welfare committees will work to pave the way for trade unions until October 31, 2006.

The committees will not have the right to call strike or work abstention in factories. They will not have the right to hold rallies or demonstrations in support of any demand.

In the limited form of trade unionism, each industrial unit may have one union without any political affiliation. A trade union must have the support of at least 30 percent of

To elect a leader, at least 50 percent of the workers have to cast votes and a leader will have to get 60 percent of the votes cast.

"The draft was formulated in consultation with all parties concerned including the US embassy, AFLCIO (a US labour union body) in Washington, the World Bank and

Six EPZs have a total workforce of around 1.30 lakh. South Korea is the leading investor in the zones with a stake of around \$600 million.

The government took the decision to allow trade union in the EPZs after a prolonged pressure from Washington. Foreign investors, however, were against the move as they thought it would hamper their

Govt closes Taiwanese office

Bangladesh has decided to close down Taipei Representative Office in the capital, according to Chinese embassy officials in Dhaka.

Foreign affairs ministry formally communicated the decision to the Chinese government on May 19, according to a message from Chinese foreign ministry made available to The Daily Star by fax vesterday.

"We have a copy of the statement sent to the Chinese foreign ministry." said a Chinese embassy official in Dhaka.

A government spokeswoman said an announcement on the portfolios was likely on Sunday night, more than 24 hours after

ministers took the oath. Portfolios are usually announced almost immediately after ministers are sworn in.

Singh, 71, took over as prime minister of the world's biggest democracy on Saturday, completing the return of the Congress party to power after a surprise election win.

A team of 67 ministers, decided after marathon negotiations, was also sworn in to form a left-leaning government to replace the Hindu nationalists who were voted out. Twenty-eight were of cabinet rank.

The cabinet met during the day and decided to call a session of parliament from June 2-10, with a vote on the floor of the house on

As a seven-day ultimatum for the arrest of assassins of opposition lawmaker Ahsanullah Master expires today, main opposition Awami League's (AL) labour front Jatiya Sramik League is set to enforce a countrywide 24-hour hartal and industrial strike on June

The Sramik League will announce the shutdown -- from 6:00am of June 5 to 6:00am of June 6 -- from a press conference this afternoon, its leaders said.

Opposition sources hinted that the upcoming programme will be a prelude to a fresh wave of anti-

government agitation over issues like the lawmaker's assassination, emergence of religious extremists in the northwestern districts and bomb attack on the British envoy to Bangladesh at Hazrat Shahjalal

The AL is trying to win support from pro-left political parties in its latest bid to pull down the BNP-led coalition government from office, the sources added.

The main opposition party has decided not to focus its agitation solely on the capital, unlike on previous occasions. Instead, the AL will involve its different units and SEE PAGE 11 COL 1

The High Court division bench, comprising Justice Abdul Matin and Justice Tariq ul Hakim, also issued rule asking the RO to explain by three weeks why the decision allocating "bench" instead of "Kula' as the election symbol would not be declared illegal.

Israeli minister sees Gaza attack to Nazi action

An Israeli cabinet minister yesterday said the army's demolition of Palestinian homes in the Gaza Strip reminded him of actions the Nazis took against his family during World War II and called for a halt to the policy of destroying homes.

The remarks by Justice Minister Yosef Lapid, a Holocaust survivor, sparked an uproar at the weekly Cabinet meeting, officials at the meeting said.

The ministers were discussing Israel's demolition of homes in the Rafah refugee camp. Dozens of homes have been destroyed or damaged during an ongoing offensive along the Gaza-Egypt border. Lapid was quoted by officials at

Fenchugani field goes into production

UNB, Dhaka

State-run Bangladesh Petroleum Exploration and Production Company (Bapex) has started producing gas at Fenchugani gas field in Sylhet from Saturday.

Bapex engineers began pumping 25 million cubic feet gas from the site every day on experimenta basis, said a press release.

"The Bapex had taken up programmes to develop the field and recently went into production at the well for the first time," it added.

State-run Bangladesh Oil, Gas and Mineral Resources Corporation Petrobangla) discovered the field in 1988, the press release said.

Petrobangla officials hoped the produce of the new well would help improve gas-supply situation in the country in the wake of growing demand for gas.
