Tongi poura chairman gets bail

Tongi Pourasava chairman Advocate Azmatullah Khan, an accused in the case filed under the Speedy Trial Act, was granted bail after his surrender.

Judge Abdul Hye of the Dhaka District and Sessions Judge's Court granted the bail upon a bond of Tk one lakh with two guarantors.

Azmatullah Khan, Gazipur district Awami League General Secretary along with his lawyers appeared before the court yester-day and submitted a petition for ball.

Moving the petition, the lawyers told the court that the petitioner surrendered before the High Court (HC) for anticipatory bail on May 22. After hearing, the HC directed the petitioner to surrender before the Sessions Judge's Court within three weeks, they said. As per direction of the HC, the petitioner appeared before the court and sought bail.

In the case filed with Railway Police Station, it was alleged that Azmatullah Khan and 11 others equipped with firearms attacked and ransacked the BNP offices of Tongi thana adjacent to Tongi Railway station at about 5 pm on May 7. The accused also looted valuables worth about Tk 65 thousand from those offices.

Abul Hossain, president of Hawkers Dal, Noagaon, Tongi filed the case accusing Azmatullah and 11 others on May 11.

The investigation officer pressed charges against Azmatullah and 11 others on May 15.

Death threat to Prof. Arefin

BCL demands arrest of culprits

Bangladesh Chhatra League (BCL), student wing of the opposition Awami League, yesterday demanded immediate arrest of and punishment to those who issued death threats to Prof. AAMS Arefin Siddique, president of Dhaka University Teachers' Association.

At a rally on the campus, the BCL leaders threatened to launch a tougher agitation if the culprits are not brought to book immediately.

They blamed the religious fundamentalists for the death threats and called on the people to resist them.

It is not only a threat to Prof.

Siddique but also a threat to freedom of expression, BCL President Liaqat Sikder said. The fundamentalist forces have been strengthening their position day by day with the patronisation

of the BNP-Jamaat alliance government, he added. DU unit President Delwar Hossain presided.

Top criminal Joy behind BJP leader Didar killing

Investigators said yesterday three hitmen deployed by a listed top criminal in the capital -- Joy -killed Bangladesh Jatiya Party (BJP) Vice Chairman Golam Parvez Didar mainly for his refusal to pay toll out of the profit he would make from construction works for which he obtained a contract from the Roads and Highways (R&H) Department.

"Primary investigation suggests rivalry among crime syndicates operating in R&H Department and Didar's refusal to give them a huge amount in toll are the main reasons behind his killing," said Deputy Commissioner of Dhaka Metropolitan Police Mazharul

"The motive of the killing is clear to us and we are now trying to identify the masterminds behind

Another top police official said they have already identified the three hitmen who sprayed bullets on Didar, also a first class contractor, when he was moving out of his apartment house at Mohammadpur in a microbus on

He however declined to disclose the names of the hitmen for the sake of 'proper investigation'.

Sources in the R&H Department also said Joy, one of the 23 listed top criminals in Dhaka, hired the three hitmen for killing Didar. All three are involved in criminal activities in Mohammadpur area.

Joy once lived at Bashiruddin Road in Dhanmondi and was known to Didar. He went into hiding after the our-party alliance

BJP is a component of the ruling

The sources alleged crime syndicates led by listed top criminals are active in the R&H Department and they force contractors to give them a certain percentage of their estimated profit as toll after obtaining a con-

Police were still interrogating three employees of the BJP leadr's construction firm, his driver Harun and Sohrab, Akhter Hossain and Abdul Haq, who were in the microbus during the attack.

Didar's wife Dalia Nargis, who filed a case with Mohammadpur Police Station on Tuesday night, mentioned in the first information report three unidentified criminals shot her husband dead.

Police were yet to track down any of the killers.

Two youths in a motorcycle followed Ali's microbus to his office after he drew the money from the Standard Chartered Bank in Banani.

"As he got down from the microbus in front of the office, one of the muggers shot him in his back and took away the sum," said owner of the farm Shahin Talukder.

In Moghbazar, five robbers went to Orient Chem-Tex Ltd. office in Tajuddin Ahmed Road at 1:45pm and attacked its officials Abul Kalam Azad and Golam Rabbani at the stairs without any

As other officials raised an alarm, locals caught two of the robbers and beat them up until
