Eminent Agri-scientist and former vice-chancellor of Bangladesh Agriculture University (BAU) Prof Dr Kazi M Fazlur Rahim died of old age complications at Sikder Hospital at Gulshan in the city yesterday at the age of 87.

He left behind his wife and one daughter to mourn his death.

He was the vice-chancellor of BAU from 1971 to 1973.

He was buried yesterday afternoon after his namaz-e-janaza at Gulshan Mosque.

Education Minister Dr Osman Farruk expressed profound shock at the death of Dr Rahim.

Teachers, students, officers and employees of BAU expressed deep shock at his death.

alty are Ziauddin Howlader Zia, Tafalbari UP member Siddhique Gharami and primary school teacher Babul Akhand. Ziauddin is the prime accused in the murder case and the eldest son of Latif Howlader, one of the four victims.

Abdul Hakim, a Muhuri in Swarankhola sub-registrar's office, was given life term.

Of the convicts, Siddique Gharami and Babul Akhand were present in the court during the pronouncement of the Judgement while Ziauddin and Hakim were tried in absentia.

The prosecution story in brief is that Ziauddin Howlader alias Zia in connivance with three other accused hacked his father Latif Howlader,48, mother Samia

Begum,38, brother Kamruzzaman alias Khokon, 14, and sister Shurma Akhtar Putul, 18, to death to grab the valuable magnetic border pillars worth several crores of taka. The victims were drugged and murdered at the instigation of Hakim Muhuri, father-in-law of Ziauddin.

1430 more held UNB, Dhaka

Police arrested 1,430 people during their countrywide drive on various charges in the last 24 hours till 6.00am yesterday.

During the drive, they also recovered eight firearms and 99 bullets and filed six cases against 10 people under the Arms Act, said a police headquarters press release.


Verdict in Srikanta murder case June 10

The Speedy Trial Tribunal in Chittagong will give the verdict in the sensational Srikanta Raxmit murder case on June 10.

Judge M Hasan Imam fixed the date after completion of argu-ments by the lawyers of both sides yesterday, sources said.

Srikanta Raxmit, a young computer engineer, was abducted on the night of April 19 last year and his beheaded body was recovered from Hathazari Upazila the following day.



Detective Police submitted the charge sheet on August 12 after a four-month investigation, accusing 17 people, including AL MP Fazle Karim. The names of Fazle Karim and five others were not mentioned in the FIR.
