### Two 'outlaws' arrested at Syedpur

Two alleged activists of outlawed Purbo Banglar Communist Party (ML-Red flag) were arrested by police at Syedpur Railway Station on Friday night.

Rezaul Karim Sukur,32, son of Jasimuddin Sarder of village Amirpur in Raninagar upazila, Naogaon is a fugitive accused in 20 murder cases. Another arrested is Rabiul Alam Tarek,32, son of Abul Hossain of village Panchupur in Atrai upazila, Noagaon, according to police sources. Tarek was the Second-in-Command of 'K area' consisting of Rajshahi, Naogaon, Chapainawabganj and Narore districts. He is a fugitive and ar accused in 50 murder cases including the sensational Six-Murder of Noidighi village in Atrai upazila.

However, another unidentified outlaw escaped arrest.

Police also recovered two mobile sets, 37,000 taka in cash, a diary and important papers from their possession.

Police told this correspondent, the arrested fugitives came all the way from Naogaon to avoid arrest where a crackdown on outlaws is going on. The two arrested outlaws were sent to Noagan for extensive interrogation on Saturday evening.

# Waterlogging a perennial problem in Patuakhali

Town protection embankment-cum-drainage project undertaken 5 years ago yet to be approved

Patuakhali town dwellers suffer a lot due to inundation of town areas during flood or high tide.

An embankment-cumdrainage project was taken up five years back to mitigate the sufferings of people, but the project is yet to be approved.

Besides flooding and erosion, water-logging is a constant problem in the low-lying coastal town.

The embankment-cum

drainage project was undertaken following visit of former Agriculture Minister Majid-ul-Haque and the then Bangladesh Water Development (BWDB) secretary to Patuakhali in 1997. The Water Resources Ministry approved the project, but the Executive Committee of National Economic Council (ECNEC) is sitting on it, Patuakhali municipality chairman Mostaq Ahmed told this corre-

and the coastal upazilas of Bauphal, Dashmina, Kalapara, Galachipa and Mirjaganj from flood and saline water. Later, the town was excluded from the pro-

Afterwards, a new project titled' Patuakhali Town Protection Embankment-Cum-Drainage Project' was taken up. At present the town inundates even after normal rise in river water. The most vulnerable areas in the town are Puran Bazaar, Kathpatti, Nabab Para, Shimulbagh,

Muslimpara, Adalatpara, College Roadpara, Sabujbagh, Arambagh, Kalikapur and Jainkati where water remains stagnant for days together after high tide or rain.

The new project was designed to protect the town from flash flood, erosion and to remove

The project includes construction of 4.20-kilometre flood control embankment, eight water drainage sluice gates, 28 outlets, one kilometre wall and installa-

## Steps needed to bring back lost glory of cottage industry

Sarupkathi upazila in Pirojpur district was once famous for small and cottage industries

The cottage industries grew up on both sides of the river Sandha. While travelling by launch or other water transport, anyone can still observe lots of people's dependence on small industries. But its name and fame are on the wane. Now time has come to do something to bring back the lost glory of 200-year-old cottage industries of Sarupkathi

Sarupkathi was named after Hindu Zaminder Sarup Dutt. It was learnt that backward Muslim community used to earn a living by pursuing various trades.

About 200 years back small and cottage industries grew here due to people's necessity and easy availability of raw materials. Gradually local products gained popularity. Over 500 cottage industries flourished in and around Sarupkathi municipality, Sutiakathi, Sarengkathi, Mahmudkathi, Sohagdal, Baldia, Aklam, Rajabari and Guarekha unions. Chocolate, handloom products, salt, cricket bat, coir, doll made of clay, bakery,

textile, fried rice, poultry, poultry feed and products made of coconut fibres are produced here.

Half of the population of 140 villages in the upazila comprising an area of 71.67 square-miles are dependent on the cottage indus-

Female workers still dominate the cottage industries although most of them work at a nominal wage. Laizu who is in her late forties is such a worker. From her childhood days she saw her mother producing jute ropes and other products while her father selling those to buyers during weekly market days. Laizu informed that at present she produces the products and her son sells the products in markets. Sultana Begum, Awal Hossain and Siddique Mia also earn a living in the same manner.

Sultana of Aklam makes dolls from clay, while Awal Hossain of Nanduhar village builds boats and Siddique Mia of Razabari area prepares fried rice.

People have created their own culture sticking to their ancestral

products, BSCIC official Majibur trades. New entrepreneurs have also come forward while some Rahman told this. others changed their ancestral

The then Pakistan government established the Bangladesh Small and Cottage Industries Corporation (BSCIC) industrial estate on 24.74 acres of land at a cost of 52.88 lakh taka in 1961.

But local products failed to compete in an uneven competition of free market. This is because of age-old technology, scarcity of raw materials and lack of promotion of The age-old communication

stem is also a major obstacle in its development. Despite its bright prospect, the cottage industries ave been facing ruination.

Time has come to take appropriate measures to develop the small and cottage industries. Will the government and other organisations come forward to protect the industry from total ruination?

## Syedpur poura chairman sued

On June 2, a group of people led by chairman Arifur Rahman went there for the same purpose. As the land owners resisted, they attacked them with lethal weapons leaving four persons injured.
