DEBATE OVER PETITION BY JUDGE

AL MPs demonstrate in House over mic turn-off

SQ Chy prompts speaker to bar Suranjit from countering Moudud

Awami League (AL) lawmakers yesterday staged an unusual demonstration in the House to protest switching off microphone of a senior fellow lawmaker who tried to counter the law minister's statement on a writ petition filed by a

The judge in his Tuesday's petition to the High Court complained of tremendous executive pressure on him for granting bail to some hardened criminals ahead of the Dhaka-10 by-polls, and that, as he

refused to cave in to the pressure, he suffered a hasty transfer.

The House was in disorder for about five minutes when the main opposition lawmakers, leaving their seats, gathered in front of the speaker and shouted protest at the turning the microphone of AL lawmaker Suranjit Sen Gupta off.

Opposition lawmakers termed the speaker's act as partisan and accused him of cutting off Suranjit's microphone upon instruction from Salauddin Quader Chowdhury, parliamentary affairs advisor to the

Responding to an opposition point of order on the judge's writ petition, Law Minister Moudud Ahmed told the House the judge was transferred by the Supreme Court as a routine one and the government

hadnohandinit. When Suranjit started to speak countering Moudud's clarification, Chowdhury stood up and protested in a loud voice the speaker's allowing the AL lawmaker to speak, shouting, "It cannot be a point of order." Speaker Jamir Uddin Sircar immediately switched off the AL lawmaker's mike and gave floor to Chowdhury. The AL lawmakers then cussed Chowdhury pointing at him and shouting "Fie upon you... fie upon you", "Shame on you... shame

As soon as the speaker switched off Suranjit's microphone and allowed Chowdhury to speak, the AL lawmakers protested and demanded to allow Suranjit to complete his speech. The speaker ignored the demand and went on with budget discussion, giving floor to a Jamaat-e-Islami lawmaker.

Ignored complaints led judge to go to court

He wrote about intimidation to law ministry, SC in May

District and Sessions Judge Shaikh Jahangir Husain, who filed a writ petition Tuesday against alleged government pressure to free some criminals before the Dhaka-10 byelection, had earlier made a series of complaints of threat and obstruction to work.

He also sought the Supreme Court protection and help from the government, say his letters to the Supreme Court registrar, law secretary and law ministry solicitor. Tuesday's petition to the High Court, which was unheard-of in recent years, came after he did not get a response from them, his law-

Husain in a letter on May 30 requested the law ministry to remove Special Public Prosecutor Mohammad Moinuddin and ask Public Prosecutor (PP) Abdullah Mahmud Hassan to stop unwarranted interference in judicial work.

In the wake of his petition, the udiciary heated up with leading lawyers raising questions whether the lower courts can carry out their responsibilities unhindered.

They claim the petition proves the lower judiciary is blatantly controlled by the government and forced to pander to the wishes of ruling party high-ups.

But Law Minister Moudud

Ahmed termed Husain's petition as politically-motivated. The public prosecutors, accused of lobbying for the release of criminals, denied the

The hearing of the petition has been adjourned until Saturday. Barrister Amir Ul Islam on behalf of the petitioner yesterday submitted to the High Court a prayer for the adjournment, seeking more time for

The May 30 letters to the Supreme Court registrar and the law ministry secretary and solicitor highlighted a series of problems, including insecurity, he was facing.

Immediately after the abduction, the gang called Manik's friend Mizanur Rahman and demanded Tk 1 lakh as ransom.

Mizan informed it to Motifheel police who told him to contact the abductors over his cell phone. When contacted, the kidnappers asked him to wait in front of Khoddor Market at Gulistan in the city.

Rumsfeld okayed prisoner torture

US Defence Secretary Donald Rumsfeld approved the use of stress positions, hoods, forced nudity, and dogs to instil fear during interrogations of prisoners at a detention centre in Guantanamo Bay, Cuba, in December 2002, memos made public showed.

The techniques, which Rumsfeld rescinded the following month after complaints from military officers, were eerily reminiscent of some of the abuses of Iraqi prisoners that surfaced earlier this year at Abu

The techniques were detailed in series of memos released by the White House on Tuesday that tracked exchanges between commanders, Rumsfeld and the Pentagon's general counsel over interrogation techniques to be used on suspected al-Qaeda and Taliban prisoners held at acrisis point," he said.

President George W Bush said he has never ordered the torture of Iraqi or al Qaeda prisoners. "Let me make very clear the position of my government and our country. We do not condone torture. I have never ordered torture. I will never order torture," Bush said shortly before the memos were released.

The White House release of a thick file of newly declassified papers tried to demonstrate that Bush and his top aides, in setting policy on interrogation methods, insisted that detainees at Guantanamo Bay be treated humanely.

But Democratic Senator Patrick Leahy of Vermont accused the White House of releasing a "selfserving selection" of documents. "The stonewalling in the prison buse scandal has been building to

day got underway with partial wrecking of a building next to the collapsed six-storey one "We've decided to demolish the house my grandfather had set up, as authorities noticed us to do so considering the risk of living there," said Raghunath Sen, 50, one of the owners of the house No. 80 in Shankari Bazar.Owner of the building No. 83 has also decided to destroy his building, which got damaged when the No. 81 collapsed on June 9. "We're waiting for a festi-

"It's not possible to demolish all

the buildings at once. The process will soon be started and we have to do it by phases," said Tapan Das Gupta, chief of the DCC Planning and Design section.
