Viral epidemic hits Bagerhat shrimp hatcheries

Farmers count Tk 100 crore in loss, 800 shrimp beds infected

Shrimps and fry of about 800 hatcheries of Baroipara in Bagerhat have died due to virus infection and white spot disease, causing Tk 100 crore oss to over 6000 shrimp farmers.

Hatchery owners and workers of Baroipara village, known as 'Mini Kuwait' of Bangladesh, are incurring huge loss due to the epidemic-like diseases, local sources said.

Akbar Azad, president of Baroipara Shrimp Cultivators' Welfare Association, said Bagerhat district alone has been the country's second highest foreign exchange earner from shrimp exports since 1980.

However, the lucrative export industry of Bagerhat recently suffered a setback and is about to collapse because of the government's indifferent attitude, he

He also urged the government to set up a laboratory in Bagerhat, where over 12000 acres of land is used for shrimp cultivation, to detect the nature of the disease in

the hatcheries. Local shrimp farmers also asked the authorities concerned to exempt them from bank loan interest as they ost their investment in the recent

"We have been incurring huge financial loss every year since 1996 due to virus-related shrimp dis-eases," said Sarder Mohiuddin, general secretary of the association.

MA Salam, vice president of Khulna unit of Bangladesh Frozen Food Exporters Association, said that the government would lose huge foreign exchange earnings from shrimp export this year due to an outbreak of white spot disease in

AL walks out in protest at PM's comment

Lawmakers of the main opposition Awami League (AL) yesterday walked out of parliament yesterday protesting Prime Minister Khaleda Zia's doubt over death threat to Leader of the Opposition Sheikh Hasina and demanding immediate withdrawal of her 'irresponsible

They also demanded discussion on the premier's remarks adjourning other businesses, but the treasury bench shrugged off the demands and tried to fend off the opposition onslaught with junior deputies, prompting the furious AI egislators to storm out of the House

Khaleda questioned the truthfulness of the threat to the life of Hasina in parliament on Wednesday.

"I came to know the matter from newspaper reports, but questions have arisen among all as the threat came abroad," she said, adding: "We've launched a probe and found out nothing of its kind so far."

After the AL deputies left the House, the deputies of the ruling BNP seized the chance to lend support to the leader of the House's comments and flay the opposition.

"They (AL) joined the session with an well orchestrated plan to walk out and they worked to their design using the prime minister's speech as an excuse," Local Government, Rural Development SEE PAGE 11 COL 4

18 Rohingyas rescued from traffickers

Motijheel police yesterday rescued 18 Rohingyas and arrested three alleged human traffickers, who brought the Myanmar nationals to Dhaka for trafficking them out to Saudi Arabia with Bangladeshi passport.

Police raided room numbers 78 87, 89 and 91 of Lucky Boarding in Fakirer Pool and rescued four boys as many girls, four women and six males. They were gathered from Kawarbil, Alitang and Balukhali of Mangu district in Myanmar. They all had Bangladeshi passports.

Police also seized unconfirmed air tickets from the traffickers -Morshed Alam, Kamal Uddin and charges of illegally entering Bangladesh by producing false

Police yesterday arrested Mahbub Alam, owner of a travel agency, for his alleged involvement with the human trafficking racket.

Dhaka City Corporation (DCC) has enhanced budgetary allocation to Tk 17.50 crore in fiscal 2004-05 from Tk 12 crore in the previous fiscal to combat mosquito menace, especially Aedes mosquito that causes the dreaded dengue fever. DCC Mayor Sadeque Hossain

Khoka yesterday announced a Tk 922.01 crore budget for 2004-05, of which 522.25 crore will come from government funds and foreign aid for projects.

The DCC needs at least Tk 50

crore a year for mosquito control and government assistance is a must for this, Khoka said. The new budget earmarked a development expenditure of Tk

676.47 crore, about 73 percent of the total budget. Khoka also presented a revised budget of Tk 641.08 crore for fiscal

EC would have gone to HC if BDB did not: Acting CEC

Acting Chief Election Commissioner (CEC) Safiur Rahman yesterday said the Election Commission would ive moved the High Court (HC) for violation of the constitution and court directives on army deployment in the July 1 by-polls had the Bikalpa Dhara Bangladesh (BDB) not already done so.

The Acting CEC disclosed this when the EC yesterday heard both sides on the appeal filed by BDB candidate Abdul Mannan challenging the validity of the Dhaka-10 by-election held in violation of the High Court's order on army deployment in each polling centre during Dhaka-10 by-election.

The BDB leader on July 6 sued three secretaries and the acting principal staff officer of the Armed Forces Division for contempt of court for not providing army in each polling centre.

After the hearing, the EC directed Mannan's counsel to submit an affidavit by July 15 on the allegation that their polling agents were driven

out of polling centres. It also asked the counsel for Mosaddak Ali Falu to submit a counter affidavit by July 18 The EC will fix the date to deliver its order on the issue after receiving the

During the hearing, both counsels traded allegations of misleading the EC by providing false information, sparking a spell of heat at the EC. The acting CEC and election commissioners M Munsef Ali and AK Mohammad Ali heard both sides

Falu's counsel Advocate Mahbubur Rahman said if army personnel were deployed in each polling centre, his candidate would have bagged more votes. He said the election was held in a free and fair manner. They (BDB) should go to the High Court with their election dispute case, he said. Mahbubur asked the EC whether

it wants to interfere interferes with the High Court as a similar writ petition is pending before the court.

Mannan's lawyer Advocate MK Rahman said everyone knows the election was not free and fair. The SEE PAGE 11 COL 2
