Bangladesh apart, India and Nepal in South Asia are reeling under floodwaters that have killed more than 350 people and left millions homeless, according to wire

Md Jamal, a Karwan Bazar chicken trader, said "Chicken farms in low lying areas around Dhaka are hit by flood causing the sudden price hike." Sugar price also jumped from Tk 28/kg to Tk 32/kg. Fish is still out of common people's reach, local Ruhi is selling at Tk 175/kg, Boal Tk 240/kg, Hilsha Tk 320/kg and Kachki Tk 150/kg. A rice trader told the correspondent that the price of rice may increase if the flood situation does not improve or if the spell of bad weather remains unchanged.
