A businessman was killed inside his office in Motijheel apparently over a feud with his brother yesterday.

Killers entered the office of GM Gaus, 55, a freedom fighter and owner of G-net Tower in Fakirerpool when he was sitting alone inside his construction firm office on the third-floor of the tower between

2:30pm and 3:30pm. The killers struck on the head of Gaus by an iron rod leaving him critically wounded.

"Hearing a shout I rushed to his room and found him lying on the floor with blood oozing from his head," said supervisor of the office Jakir Hossain.

Police rushed to the spot and sent Gaus to Dhaka Medical College Hospital at around 4:20pm where he

Security guard of the tower Mahfuzur Rahman, whom police picked up for interrogation, told The Daily Star that Gaus' younger brother Ashraf met Gaus at around 3:00pm and left in 15 minutes.

He said Ashraf went to Gaus after he forbade him (Ashraf) to take some corrugated tin from the ground floor at around 2:45pm. "At around 3:15pm Ashraf returned, told me he got permission and went away with three vans full of tins," he

Motijheel police suspect Ashraf, a hotelier, has killed his brother.

DFP DG drags on even after transfer

The director general (DG) of the Department of Films and Publications (DFP) has not yet joined the office he was transferred to over two weeks back. DG Syed Mahbubur Rahman was

transferred to National Institute of Mass Communication on July 8 but is still holding his previous office at DFP. He has been accused of gross corruption and a process is on for termination of his service.

Official sources said the Ministry of Information subsequently appointed Joint Secretary (Development) Mamunur Rashid Chowdhury as the DG for the interim period but he could not join as Mahbubur is still holding office.

"How can I join the DFP as the position is not vacant? I'll join as soon as the post is left vacant," Marnunur told The Daily Star yester-

When asked, Mahbubur said officials usually get time to continue their previous offices even after transfer. "I've informed the secretary of the ministry about my delay in leaving DFP," he added.

The secretary in-charge of the Ministry of Information was not available for comment.

However, highly placed sources at the ministry said DG Mahbubur was supposed to be suspended or made OSD (officer on special duty) when corruption charge was framed against him after approval of the president and prime minister.

The sources said high-level investigations twice proved massive corruption of DG Mahbubur long back. But he was either suspended from service or made OSD because of his links with some influential officials at the Prime Minister's

Senior officials said there is no such instance in the administration of an official taking so much time for joining new office within Dhaka

They suspect the DG is trying to cancel his transfer order and continue in the DFP as the department is currently carrying on some development projects involving a huge

parents and guardians." The multi-colour handbill contained names and telephone numbers of 10 teachers on different subjects including Biology, Physics, English Language, Chemistry, Accounting, Economics, Commerce, Bengali, Maths and Computer Studies.

Such use of contact numbers of teachers has made people even more suspicious about the motive behind the distribution of the fiver. It also published names of 10 private English medium schools.

Most of those schools are situated in Dhanmondi Residential Area. Besides, the back page of the flyer ran an advert for a Business English Course said to be administered by

the British Council. Referring to the use of phone number in the handbill one former teacher of a private English medium school said, "It's outrageous and teacher of a school should not involve himself in private tuition."

Another teacher said,"It's nothing but a trick on students and guardians." Officials of the British Council could not be reached for comment yesterday, on their weekend.
