Police prevent non-govt relief collection in city

Police yesterday prevented different political and non-governmental organisations from raising funds and collecting relief materials for flood affected people in the city.

They did not allow the leaders and workers of Bikalpa Dhara Bangladesh (BDB) to collect relief materials from different sectors of Uttara in the morning and picked up three activists, Aziz Akhand, Mobarak and Abul who were later released in the evening.

BDB spokesman and lawmaker Mahi B Chowdhury said, 'Local people came out of their houses spontaneously to contribute to the relief fund, but police foiled the

programme.'

Duty Officer Habibur Rahman of Uttara Police Station said 'We intervened in the programme at the request of the locals who were annoyed with the noise of loud speakers.'

Nibedan, a cultural forum, said police prevented their fund-raising campaign at around 5:00pm at Malibagh.

'We had been collecting relief materials in different parts of the city for last three days,' said Bishwajit Roy of Nibedan adding, 'We are now frustrated by the government decision of banning non-government relief collection and fund-raising.'

Police also snatched away the

banners and clubbed the activists of Biplobi Chhatra Moitri from collecting relief materials in Dhanmondi.

An alliance of five left parties and Chhatra Moitri, in separate press releases, protested the government decision describing it inhuman and autocratic.

Other political parties and social organisations have also criticised the government ban on non-government fund-raising and called for immediate withdrawal of the order.

Deputy Minister for Food and Disaster Management Asadul Habib Dulu said, 'We did not take such decision, but anyone found collecting toll in the name of relief will be punished according to the law.'

ADB keen to fund in Dhaka eastern bypass

The Asian Development Bank (ADB) yesterday expressed its interest in constructing Dhaka eastern bypass for the protection of Dhaka city from massive flooding in future.

A visiting team of ADB's board of directors in a meeting with Communications Minister Nazmul Huda yesterday stated the intention, meeting sources said.

Jusuf Anwar led the six-member delegation of ADB.

The ADB board members expressed grave concerns over the severe flooding that Bangladesh is faced with. They discussed post-

flood rehabilitation programmes and assured of all-out support in rebuilding communications infrastructure.

They told the minister that ADB was closely monitoring the flood situation. They underlined the importance of building roads and highways so as to be above the flood level.

The communications minister sought unconditional help from the ADB in rebuilding roads, highways, and rail tracks after the flood is over. He also called for ADB help in construction of the Padma Bridge that is likely to begin from March 2005.

Prof Mazhar Ali Quaderi passes away

Prof Mazhar Ali Quaderi, former vice-chancellor of Bangabandhu Sheikh Mujib Medical University (BSMMU), died of multi-organ failure on Wednesday night at the age of 80.

A former lawmaker, Prof Quaderi was also the founder president of Swadhinata Chikitsak Parishad and president of Bangladesh Medical Association (BMA).

As a professor of medicine, he had served in Dhaka Medical College Hospital (DMCH) and Rajshahi Medical College Hospital.

Prof Quaderi is survived by three sons.

His namaz-e-janaza was held at Gulshan Central Mosque yesterday. His body has been kept at Birdem mortuary and he will be buried after his sons arrive in Dhaka from abroad within a couple of days.

Opposition Leader and Awami League President Sheikh Hasina, Bangladesh Swadhinata Chikitsak Parishad and Bangladesh Private Medical Practitioners' Association have expressed condolence at his death.

Banker Mohammad Khaled

Eminent banker and founding Managing Director of the Pubali Bank Mohammad Khaled died at Birdem Hospital on Wednesday night at the age of 80.

Mohammad Khaled, former Deputy Governor of Bangladesh Bank, was suffering from old-age diseases for sometime. He left behind his wife.

The body of Mohammad Khaled was taken to his village home at Sultanpur under Raozan thana of Chittagong after his first namaz-e-janaza at Dhanmondi Jame Mosque.

Later, he was buried at his family graveyard at Sultanpur after the second janaza there.

President and General Secretary of Chittagong Journalist Forum, Dhaka (CJFD) Mesbahuddin Jongi and Mostafa Kamal expressed deep shock at the death of Mohammad Khaled. They recalled his contribution to the society and prayed for eternal peace of the departed soul.

Syed Abu Taher

Syed Abu Taher, a freedom fighter and retired JCO (Signal), died at his home at Mirpur on Wednesday at the age of 80, says a press release.

He is survived by his wife, two sons, three daughters and a number of grandchildren.

His qukhwan will be held at his home at Lalkuthi after Asr prayers.

Pichchi Hannan confesses about SI murder

Pichchi Hannan, one of the 23 top listed criminals, yesterday in a confessional statement to a magistrate said one of his accomplices Anai killed Sub-Inspector (SI) Humayun Kabir during a shoot-out with police on June 3, 2003.

Detective Branch (DB) of police yesterday produced Hannan before Metropolitan Magistrate Jahangir Alam at 11:00am. It was the eighth day of his 10-day remand in Humayun Kabir murder case.

Magistrate Jahangir Alam recorded the statement for three hours and later placed him on another 10 days' remand. The case was filed with Uttara Police Station on June 23, 2004 on charge of

attempting to kill policemen.

Hannan said he and his henchmen used to frequent a room of National Archives in Agargaon at night to meet and take liquor and drugs. On June 3, 2003, during such a meeting, when his accomplices went out to buy meal from a nearby shop at around 11:00pm, policemen, tipped off, ringed the area.

As Anai and four others opened fire on the policemen to escape arrest, SI Humayun and Amir Hamza alias Hamzu, 34, died on the spot, he said.

Hannan said he did not take part in the shoot-out but still managed to evade capture.

Syed Ainul Hoq, who was arrested from the scene, gave a confessional statement to court on June 7 last year linking Hannan and five others to the June 3 shoot-out.

Charges framed against Jamuna Group chief

A Dhaka court yesterday framed charges against Chairman of Jamuna Group Nurul Islam Babul in an attempted rape case.

Judge Kaniz Akhter Nasrina Khanam of the Special Tribunal for Prevention of Women and Children Repression-4 fixed August 30 for trial of the case.

Babul pleaded not guilty and demanded justice before the court after the charges were read out.

The defence lawyers submitted a petition for discharging Babul from the charges, while the prosecution opposed it praying for framing charges against the accused.

After a lengthy hearing from the two sides, the court rejected the discharge petition and framed charges against Babul.

In the case filed with Badda Police Station, a woman of Dholairpur in Demra in city alleged she met Babul, a leading businessman and owner of Bangla newspaper Dainik Jugantor, at his office in Motijheel on March 17 for a job.

Babul aided by an armed gang took her to Kuril Bishwa Road in Badda by a car, she said, and forcing her into a tin-roofed house near Bishwa Road, attempted to rape her.

She filed the case against Babul and two others on March 19. The investigation officer of the case pressed charges against Babul on April 27 to the Chief Metropolitan Magistrate's Court showing seven people as prosecution witnesses.

Karmojibi Nari distributes relief

Karmojibi Nari, an organisation for working women, distributed relief materials among the flood-affected women workers at Siddhirganj in Narayanganj on Wednesday, says a press release.

President of the organisation Shirin Akhter, Director of Training Mahmuda Imam, Arifa Akhter Anu and Al-Azham Khan were present during the distribution.

Madrasa teacher held on charge of raping girl

A madrasa teacher was sent to jail on charge of raping a minor girl in Khulna yesterday.

Moulana Abul Kalam, a teacher of Keratul Cadet Madrasa of Labonchora under Khulna thana, was sent to district jail after showing him arrested under 'Prevention of Women and Children Repression Act'.

The victim is a student of class three of the same madrasa. According to an FIR lodged with Khulna thana by her mother, the girl was raped by her teacher in his bedroom adjacent to madrasa on Wednesday afternoon.

Police arrested him on the same night after receiving the complaint.

The victim was examined yesterday and she is now undergoing treatment in Khulna General Hospital.

Two rapists get life

A Dhaka Court yesterday sentenced two youths to life imprisonment for raping a 16-year-old girl at Kandulbagh under Savar thana on April 26 in 1999.

The convicts Mohammad Safaz Uddin and Mohammad Mohsin are the residents of Kandulbagh.

Judge Sarker Abul Mansur Ahmed of the Special Tribunal for Prevention of Women and Children Repression-3 gave the verdict in presence of the convicts.

Earlier, the prosecution and the defence completed their arguments and the court recorded statements of 12 prosecution witnesses.

According to the prosecution, Safaz and his accomplice Mohsin raped the girl aged about 16 at a nearby desolated place at about 9:00pm on April 26 in 1999 when she went out of her house for nature's call.
