Train movement through Bahadurabad uncertain

1,000 feet track virtually hanging at Balashi

Restoration of direct train communication between northern districts and Dhaka is uncertain as the tracks between Trimohoni and Teestamuk Ghat in Gaibandha has been badly damaged by flood. About 1,000 feet of the track is virtually hanging at Balashi as the soil underneath has been washed away.

This correspondent during a visit to the spot yesterday saw strong current of water is flowing under the track, washing away the oil. The breached portion of the line will turn into a canal if the situation continues.

The railway ferry service between Teestamuk Ghat and Bahadurabad Ghat is suspended for over a fortnight. portion of the track is renovated. This will take a long time, railway officials

"It will take a long time to renovate

the damaged rail track. Work will begin after complete recession of water", an Earth filling work to renovate the

track is uncertain as there is still water all around, officials said.

Inter-city Teesta Express and another passenger train now shuttle between Trimuhuni and Dinajpur.

The rally was addressed by among others, Alhaj Golam Nabi Almagir, Convenor of the Parishad

The speakers said the 15 lakh people of Bhola will launch tougher agitation if steps are not taken to protect them from erosion and flooding

They said the area of Bhola is shrinking only due to erosion and lack of protection embankments.

Besides, fishes worth crores of Taka have been washed away and other resources damaged by the current floods, they said.

The mighty river devoured about two hundred square kilometer area of Bhola, Daulat Khan and Tajumuddin upazilas in the last few years displacing about two lakh people but the government did not take any measure to stop the erosion or to rehabilitate the land-

during the current flood, rendering over 50,000 people homeless. The displaced people are leading a subhuman life on river banks and high lands.

Most areas of Bhola Sadar, Daulatkhan and Tajumuddin upazilas are now inundated as the sea level is still 3 to 5 feet above the normal level due to the influence of full moon.

Several thousand marooned people in the areas and are without food and drinking water, according to reports reaching the district town.

The speakers claimed that the district administration did not give any relief to the flood affected and displaced

Rugged roads emerge

Vehicles ply 3 out of 19 pucca roads

A devastated picture of roads in Sylhet is surfacing as the flood-water is receding from different areas.

Communication has been restored on only three of the 19 roads in the district but vehicles are moving with great caution as those have been badly damaged.

The 59 km Sylhet-Tamabil-Jafflong road and the 52 km Beanibazar-Golapganj-Fenchu-ganj road are

A total of 243 km pucca roads out of 538 km in Sylhet district have been badly damaged by the flood, sources in the Roads & Highways Department

The 43 km Sylhet-Sutarkandi road

which links five upazilas is also badly affected as many points of the road were under 4 to 10 feet water for ten days. There are big potholes on it at several places.

Vehicles are however plying the road with great risk.

Buses and minibuses to Jakiganj are using an alternate road through Moglabazar and Dhakadakshin Bazaar.

At least Tk 29 crore is needed for making the pucca roads and highways somehow usable, they said talking to this correspondent yesterday.

The damage to feeder roads, bridges and culverts are yet to be ascertained as portions of many of those are still under water.

"You can well imagine the damage

as those were under water for weeks", a

high official of the RHD said. Many of the kutcha roads have been completely washed away, he said.

Case by victim's wife not recorded: 300 villagers sued, flee homes

Police did not record any case in connection with the killing of Mong Mong Marma at Boropara village in Kaptai, the victim's wife, Sui Aung Crui, told a group of newsmen during a visit to her house on Sunday.

Male members of the village inhabited mostly by Marma tribesmen are fleeing homes as forest department officials filed a case against 300 villagers terming them illegal loggers'. Twenty-five year old Mong Mong

was killed when army opened fire to quell clashes between forest department men and illegal loggers in the village in a remote hilly area on Thursday. Mong Mong was not nvolved in the clashes, his wife and other villagers claimed.

A police official at the district headquarter declined to comment when asked why the case by the

victim's wife was yet to be recorded by the police station concerned.

Sui Aung Crui said her husband was the only earning member of their five-member family including her widow mother.

"We have none to support us now", she said standing at door of her thatched house. A mother of two children, 22 year-old Sui is expecting another baby in about two months.

Army had rushed there when officials of the Fring Khyong reserve forest sent an appeal to "save them from loggers' attack", according to Rangamati Assistant Police Superintendent Moha-mmed Ali.
