'Foreign prisoners suffer for lack of legal aid'

Most of the foreign prisoners in Bangladesh and its neighbouring countries languish in jail due to lack of access to legal aid, said speakers at a roundtable yesterday.

In most cases, the speakers said, the foreign citizens imprisoned belong to lower income group and lack financial ability and moral support to seek legal

Moreover, it becomes hard for them to seek legal support in a foreign land even if they can afford it. "There are a number of cases where a person remained imprisoned even 10 years after serving their prison term," said Fazlul Huq, executive director of Bangladesh Legal Aid and Services

Blast organised the discussion on "Foreign Prisoners and Access to Justice" in the capital vesterday.

The speakers said in some cases, citizens of neighbouring countries are caught for travelling without valid documents like passport and visa. Sometimes, the fishermen cross the maritime border in bad weather in their ignorance and get arrested.

"At least 64 Bangladeshi fishermen are languishing in a jail of West Bengal," said Justice DK Basu, chairman, Legal Aid Services-West Bengal (Lasweb). He added 37 of the Bangladeshi nationals are languishing in Midnapore jail of West Bengal. Sixty-two Indians are

The ambassador of European Commission (EC) yesterday said the EC is ready to relax the rules of origin and reduce derogation of garments exported from Bangladesh, if the govermakes a proper request for that

Speaking at a national dialogue

organised by the Centre for Policy Dialogue (CPD) in the city, Head of EC Delegation in Bangladesh Esko Kentrschynskyj also underscored the need for diversifying export items, which Bangladesh's export basket badly lacks.

Kentrschynskyj's remarks came in response to speakers' observation that Bangladesh's exports to Europe and

Japan would increase manifold if the rules of origin were relaxed and trade barriers removed.

The speakers also detailed a number of reasons including non-tariff barriers and lack of capacity building and policy the country cannot fully utilise various

Iranian consul detained by Iraq militants

Iraq PM asks insurgents to quit Najaf; 43 more killed in fighting

An Iraq Islamic group said yesterday it has "detained" the Iranian consul in the central Iraqi city of Karbala for stirring sectarian strife, Al-Arabiya $television\, reported.$

The Islamic Army in Iraq, in a statement read by the Dubai-based channel, said Faridoon Jahani was "detained for stirring sectarian strife and for activities outside his diplomatic duties".

Meanwhile, Iraq's interim prime minister vesterday ordered Shia fighters loyal to a radical cleric to leave the holy city of Najaf but the militiamen were digging in and the death toll from days of clashes mounted.

Clashes erupted again around midday in Najaf and also the squalid Baghdad district of Sadr City, wit-

Other flashpoints in Iraq were tense following three days of fighting between US troops and militiamen loyal to Shia Muslim cleric Moqtada al-Sadr that has killed hundreds of people and challenged the authority of Prime Minister Iyad Allawi.

The Health Ministry said at least 43 people had been killed in Najaf and Baghdad in the last 24 hours till last

"We hope that this thing ends as soon as possible," a heavily guarded Allawi told reporters at the start of a visit to Najaf, 160km south of Baghdad. "I believe gunmen should leave the
