UNDP scheme for very poor flood victims

The United Nations Development Programme (UNDP) will launch labour-intensive infrastructure-reconstruction works, in partnership with the government, to help those who lost income

opportunities in the devastating floods in Bangladesh.

The scheme aims at "helping to rebuild devastated public services and providing employment to the very poor in the worst-affected areas," a UNDP announcement said yesterday, while the visiting UN development agency's administrator, Mark Malloch Brown, continued discussion with government leaders on the bailout plans.

"To further economic recovery, weavers, small shop owners and other small-scale entrepreneurs will be provided with capital grants to restart their business," it said.

Maldives urged to release Zaki

The South Asia Centre for Policy Studies (SACEPS) has expressed deep concern over the arrest of Ibrahim Hussein Zaki, one of its board members, and other persons associated with the democracy movement in the Maldives.

Zaki, former secretary general of Saarc, is one of the most widely regarded and respected personalities in South Asia for his continuing involvement with civil society initiatives across the region to promote cooperation in South Asia.

Zaki has also served as foreign secretary, minister for tourism and minister for planning and national development in his country.

In a joint statement yesterday, the SACEPS board members urged the government of the Maldives to release Zaki and his colleagues and to deal with their concerns within a political framework which is consistent with the rule of law and the principles of democracy.

Voter list illegal

The High Court (HC) yesterday declared illegal the voter list and election schedule for holding election to the Collective Bargaining Agent (CBA) of Chittagong City Corporation.

The court also ordered the registrar of trade unions of Chittagong division to prepare a fresh voter list for holding the CBA election.

The orders came upon a writ filed by Chittagong City Corporation Sramik-o-Karmachari League that challenged the legality of voter list prepared by the registrar of trade unions on November 3, 2002, depriving a large number of workers as voters. The High Court had stayed the election till disposal of the case.

Making the rule issued earlier absolute, a division bench comprising Justice M Abdul Matin and Justice Tariq-ul Hakim delivered the verdict.

committee led by Minister for Environment and Forest Tariqul Islam to prepare a draft of the law.

"We are facing problems in dealing with various issues such as retirement of employees of the academies," said Dilder Ahmed, cultural advisor of the ministry.

35 ships fined
