Panicky businesses fear loss in export, FDI

Prevailing uncertainty and instability in national politics coming close on the heels of a devastating flood will further degrade Bangladesh's image taking toll on export and foreign direct investment, fear top business leaders

They said when businesses were gearing up in full swing to recover from losses sustained from the deluge that inundated two-third of Bangladesh, the grenade attacks on a public rally of the main opposition party on Saturday came as a big

With no headway to the series of blasts at different public rallies and cinemas including the latest one on Bangabandhu Avenue in Dhaka killing at least 19 people, the business leaders expressed their utter frustrations while talking to The Daily Star yesterday.

The attack would put a long lasting stigma on the country's image, they fear.

Frustrations ran so high among the business community that some of them who had all along been against hartal spoke in favour of the latest two-day general strike, enforced by opposition parties protesting the attack on the rally of Leader of the Opposition in Parliament Sheikh Hasina who narrowly escaped.

Most of them said the latest

round of hartals is for a common and big cause to press the govern-ment for restoring security in the country. When human life is not safe how business can flourish in this situation, said the business leaders.

The attacks on Awami League (AL) rally and subsequent hartal has brought the business to a near standstill with major production disruptions in mills and factories and low customer turnout in shops and shopping centres.

The common view that came from the conversations with business leaders is that they are uncerpolitical confrontation.

Current hartal reality different: BGMEA chief

Bangladesh Garment Manufacturers & Exporters Association (BGMEA) President Annisul Huq said, "We do not support hartal, but this time the reality is different."

He said the country has been facing political unrest as well as natural disasters since decades. "And we are now in the middle of a

"But our tremendous performance in terms of export and production proves that we are such a nation that we can fight against any situation," he said.

Huq hopes the foreign buyers would not be worried for the current political situation and would continue their business in the country.

Double blow to economy: FBCCI vice-president

Vice-president of the Federation of Bangladesh Chambers of Commerce and Industry Abul Kashem Haider said the hartals have come as a double blow to the business and economy.

"The economy is still reeling under flood impact. At this time any production disruption in industrial sector would delay economic recovery," he said. "At no time we should support hartal whatever the reason ofit."

No reason to support hartal: MCCI supremo

Metropolitan Chamber of Commerce and Industry (MCCI) President Kutubuddin Ahmed sees no reason to support the hartal, saying Saturday's attack adding with recent floods has already damaged Bangladesh's image abroad hampering business seriously.

'We want international probe of the incident as demanded by Awami League but cannot support the

The MCCI president said the business community was always against hartal for which small and medium enterprises' growth may

Kutubuddin, who is also a representative of garment sector, said at least 30 percent garment workers abstained from work yesterday whereas the normal rate of absence is 10 to 15 percent on other hartal

He termed the government's attitude on the attack and its aftermath "positive".

Hartal harmful to progress: BTMA chairman

MA Awal, chairman of Bangladesh Textile Mills Association (BTMA), said just when the flood situation has improved, business and economic activities specially in Dhaka came to a halt after Saturday's grenade attack on the AL rally.

"We are in a fear what will hap-pen in coming days," he said. "With the uncertainty in politics, the foreign buyers are now also in an apprehension

Awal said after the grenade attacks, commercial vehicles were off the roads resulting in zero shipment from one place to another.

Commenting on hartal, the BTMA chairman said hartal is a political instrument but it is harmful to economic development.

Current hartal justified: Frozen food assoc chief

President of Bangladesh Frozen Foods Exporters Association Quazi Monirul Haq said the grenade attacks on AL rally has created a panicky situation in businesses and the uncertainty will add to woes of exporters. 'Such a chaotic and insecure

situation may further degrade country's image abroad affecting exports," he said. Monirul thinks any shutdown

affects business but he sees no harm in supporting the two-day hartal in protest against insecurity of lives that prevails at present in the coun-

Shop owners sympathetic towards present strike

President of Bangladesh Dokan Malik Samity (shop owners associa-tion) Amir Hossain Khan said shop owners are sympathetic towards the two-day protest programme to air their grievances against the insecure situation that is not congenial to

"After the incident, transactions in shops have fallen drastically. Due to uncertainty people have stopped buying products other than essentials. As an uneasy situation prevails, shop owners close their shops early and go home before sunset," he said.

Shopping malls, department stores and other retailers are yet to recover from dull business due to flood and the panicky situation arising out of the grenade attack may further dip retailing business,

Panicky situation to hurt

FDI: AmChampresident
President of American Chamber of

Bangladesh Aftab-ul Islam said the panicky and uncertain situation may not only adversely affect the local businesses but also the flow of foreign direct investment (FDI).

"The government should ensure security of lives to the people. If government is to attract more FDI and improve country's image, it must work on security," he said.

Leather exporters worry over unstable situation

Bangladesh Finished Leather, Leathergoods & Footwear Exporters' Association Chairman Tipu Sultan said such grenade attack is hateful and such incident is continuing in the last few years. "But there was no solution of those inci-

"For this, the country's business sector is now in an unstable situation and export, import and produc-tion are hampered, "he said.

EU extends KL after bird flu outbreak AFP, Brussels

The European Union has banned imports of pet birds and feathers from Malaysia after an outbreak of a ethal form of bird flu there, the European Commission said

The ban extends an EU ban slapped on poultry and bird prod-ucts from other Asian countries earlier this year after outbreaks of avian influenza. "Avian influenza is a highly contagious poultry disease that can

cause severe economic damage to the poultry industry and may be transmitted to humans," said EU Commissioner for Health and Consumer Protection David Byrne. "We can take no risks when it

comes to the import of products or

birds that might introduces this virus into the EU," he added. Bird flu was confirmed early this ear in several Asian countries, sparking an EU ban on the import of ive poultry, ostriches, other live birds (including pets), hatching eggs and affected poultry products.

Couriers thrive with growing customer confidence

Private courier service sector has been witnessing a boom for the last few years on increasing customer confidence.

The courier service, emerged as a major service sector with handsome annual growth, has been complementing and rivalling the government's postal service since 1983. The private couriers take maximum 24 hours for inter-city parcel delivery. Some leading companies provide same-day delivery for intra-city parcel.

Each of the leading companies handles 15,000 to 20,000 letters and around 2,000 parcels a day on average while small ones 1000 to 1500 letters and 50 to 200 parcels, said a high official of Sundarban Courier. The volume was almost half even five years ago.

According to an estimate of vary Courier Service Association of Bangladesh, some 100 companies handle about 1.7 lakh letters and about 15,000 parcels a day to create a Tk 500 crore service sector. The

sector generates huge revenue for

the government in the form of 15

percent VAT (value-added tax) on the service. The development of inter-city bus services contributed to the rapid growth of the courier service. The couriers use these buses to transport parcels quickly. Rising transport costs also contribute to

intra-city courier growth, industry

people say. However, industry insiders say the sector is running haphazardly with lack of uniformity in charges due to absence of a regulatory body. For stiff competition among mushrooming companies, the charges

Local courier service companies charge Tk 15 for a document weighing below 1 kg. If a document weight crosses the ceiling it is treated as goods. For goods parcel the charge is Tk 20 for first kg and Tk 10 for every next kg. Abu Naser, general secretary of

Courier Service Association of Bangladesh, said courier service expands operation and now covers every upazila of the country as it has earned confidence of customers for reliable and quick delivery.

About difference of charges, he said some companies provide discount for corporate clients to attract and retain customers. There should be uniformity in charges for the benefit of customers and new

companies also, he observed. Some companies impose service charge, which also casts bad

impact on the courier service business," he said, adding that the government should take initiative to bring the companies under uniform guidelines.

Tanvir Ahmed Rony, director (Finance) of Sundarban Courier Service, one of the leading market players, said, "The business has become so competitive and demand-driven that some companies make delivery within hours for intra-city parcel."

Sundarban, Execial and Pioneer have expanded service to India for document parcel. The companies also provide money order service. However, the government has recently planned to restrict courier firms from providing money order service as it leaves scope for money laundering, an allegation refuted by

a press release. The European Commission and Germany united Monday to insist EU states should not take unilateral tax measures to offset the impact of high oil prices.

European Monetary Affairs Commissioner Joaquin Almunia said there was concern about oil prices, which hit record highs last week, while German Economy Minister Wolfgang Clement in Potsdam admitted lofty oil prices posed "a problem and a certain

But Almunia and Clement's deputy, Alfred Tacke, stressed unilateral tax measures were not the way

"Individual actions can't counter it," Tacke said on the margins of a US-German business conference in Neuhardenberg, near Berlin, when asked if taxes or strategic oil reserves could be used to limit the impact of high oil prices.

'Global supply and demand are the decisive factors, not individual measures," he added.

The Commission was equally

adamant: "No country should take unilateral 'action," Almunia told reporters in Brussels, stressing the need for prior consultation with other EU states.

With US light crude prices scal-

ing record peaks of \$49.40 per barrel on Friday, the issue of tax cuts to offset the impact on consumers has re-surfaced in Europe, and especially in Italy. But Italian Economy Minister Domenico Siniscalco was singing

from the same hymn sheet during a visit to Brussels on Monday. There is a commitment of European finance ministers to coordinate any measures in this field, especially tax measures," Siniscalco said after a meeting with

EU finance ministers in June pledged to consults each other before acting, anxious to avoid a rerun of unilateral action in 2000, when a French cut in diesel fuel taxes sparked blockades and disrup-

tions in neighbouring countries. Italian Industry Minister Antonio Marzano has proposed tying excise duties to the price of oil so they would be cut when crude prices were high and raised when prices

But Marzano has said he would write to the EU Executive Commission and ask for an informal meeting of energy ministers while Gianluigi Magri, undersecretary of the Italian Treasury, wants EU finance ministers to discuss the issue next month.

A spokesman for the Dutch finance ministry, which organises the informal meeting of EU finance ministers next month in the Hague, said oil prices were not officially on the agenda. But he added: "I am sure it will be discussed at the meeting." The Netherlands currently holds

the rotating EU presidency. On Friday Almunia said he would

not be surprised if EU finance ministers discussed the topic on September 10-11.

Petrol prices vary widely across the EU, both due to the tax levied and local competitive conditions. For example, petrol at Dutch pumps, the most expensive in the EU, is over 50 percent more expensive than at Greek ones, according to Commission data.
