

REGIONAL AUDITORS' GENERAL CONFERENCE

A Regional Auditors' General Conference is going to be held in Dhaka on 30-31 August 2004. The Conference is being sponsored by the Office of Comptroller and Auditor General of Bangladesh in association with World Bank and CIDA. At least eight heads of Supreme Audit Institution (SAI) and another 22 delegates from Regional SAIs and observers from National Audit Office, UK, World Bank, DFID and CIDA are also going to attend the Conference.

The theme of the Conference is " Harmonizing Institutional Efforts for Promoting Accountability in the Public

Accountability in Public Sector refers to justification of performance guided by objectivity, rationality and priority. Of the various aspects for its establishment, at least three are prominent. First, the acceptance of stewardship responsibility by the public sector entities themselves that requires them to undertake certain internal control measures for the protection of resources. Second, independent and external assessment and reporting on the financial regularity, propriety and financial performance of those entities, which is accountability function performed by SAI. Third, the responsibility to act as a Supreme Body to provide synergistic support to produce attractive results in terms of input economy, operational efficiency and result-oriented effectiveness, which is accountability function by Parliament and its Committees. In various countries, there are other watch-dog agencies like Bureau of Anti Corruption, Ombudsman, Media, Civil Society etc., which can also function as oversight organizations.


