Fertiliser price hike scourges farmers in 8 northern dists

RAFIQ SARKER back from

Rangpur: High price of Urea fertilizer is scourging farmers in eight northern districts in Rangpur and Dinajpur,

threatening the prospect of Aman crop.

The crisis has shattered the flood recovery efforts by farmers, particularly in greater Rangpur, which was badly

affected by the recent deluge.

Retail price of Urea has gone up by Tk
50 to Tk 100 per 50 kg bag at places,
farmers alleged. The government-fixed

price is Tk 290 per bag.

They alleged that some unscrupulous fertiliser dealers have created an artificial crisis to mint money, an allega-

On Friday, at Boderganj in Rangpur, the Upzila Nirbahi Officer (UNO) raided

the godown of a fertiliser dealer.

He found 500 bags of urea there and disbursed those among farmers at fair price. Two farmers were injured in a stampede.

In Gaibahdha, two dealers were arrested for selling Urea at high price.

When contacted, Rangpur Deputy Commissioner Rafiqul Islam said there is a buffer stock of Urea and Potash fertilisers in Rangpur and adjoining

districts and there is no chance of price

The DC also said the District Fertiliser Monitoring Committee has kept a close watch on the fertiliser market and action will be taken against dealers who manipulate the price.

But fertiliser dealers at different places differed with the DC's view. Dealer Abul Kashem in Rangpur said.

"The supply of Urea and Potash is less than the demand and so the prices have gone up."

Farmer Sohel Khondoker of Mahiganj alleged that dealers are realising Tk350 to Tk400 perbag.

During a visit to Lalmonirhat it was gathered that there are 50 BCIC (Bangladesh Chemical Industries Corporation which runs Urea factories) fertiliser dealers in the district but the market is controlled by one bid dealer who is a member Bangladesh Fertiliser Association. He buys quotas from other dealers during peak seasons and manipulates

Lalmonirhat Additional Deputy Commissioner Babul Chandra Roy, now DC-in-charge, said action is being taken in this regard.

"We raided the fertilizer depot of one Morshed at Hatibandha and found 280 Urea bags in place of 800 allotted. He lifted the quota and sold the rest in the black market".

Some fertiliser dealers in Rangpur, Kurigram and Lalmonirhat seeking anonymity said a section of dealers are realising high prices on the plea of short supply because of lax vigilance by upazila fertiliser monitoring commit-

They said suspension of fertiliser supply to flood affected farmers in Kurigram, Lalmonirhat and Gaibandha districts under the government's flood rehabilitation programme also accentuated the crisis.

free distribution of 25 kg Urea per head along with Aman seed among flood affected farmers. Fertiliser supply to about 20,000

The government earlier announced

flood affected farmers in Kurigram and Gibandhahas been suspended. Sources in Kurigram Agriculture Extension Department (DAE) said the programme has been rescheduled.

Affected farmers in these districts will get the free fertiliser and seeds in the coming Rabi season.

Some farmers in Panchgachhi in Kurigram Sader upzila said, after the

suspension, they thronged local mar-

kets to buy Urea. The price is higher since then.

There is confusion among people about the free fertiliser distribution programme.

Official sources in Lalmonirhat said the Deputy Minister for Relief and Rehabilitation formally inaugurated programme in the district on August 24.

But many farmers this correspondent talked to in Azitmari, Hatibandha, Khunigachh and Sader upzila said they have not heard anything got free fertiliser.

Our Nilphamari Correspondent

reports: Urea prices are soaring in different areas of the district due to alleged manipulation by a section of dealers.

It is selling at between Tk 320 and Tk 350 at places in remote areas.

Requested by dealers, the Deputy Commissioner sent a fax message to the Ministry of Agriculture on August 23, seeking additional allotment of 2000 tonnes of Urea on emergency basis, sources said.

According to sources, the district agriculture office had sought 8,970 tonnes of Urea for July; 9, 680 tonnes for August and 5, 860 tonnes for September. They got 2300 and 6000 tonnes in July and August respectively. The allotment for September is 32,000 tonnes, of which 1200 tonnes reached the district yesterday. But this is inadequate, they said.

Sources in the district agriculture office however said Amon sowing in the district has crossed the target of 1, 14, 635 hectares in the district.

Now is the peak season for farmers to use Urea in Aman fields. Some farmers this correspondent talked to said fields will turn yellowish and production will be affected if they can not use Urea within a week.

The President of the Nilphamari Fertiliser Dealers Association Abdul Wahed said prices are soaring because the supply is less than the demand. He denied the allegation of market manipulation by a section of dealers. There are 73 dealers in the district.

But many farmers alleged that some dealers at times hide their stocks and tell them that the stock is exhausted only to realise high price.

HANDOVER OF POWER LINES TO PBS IN KHULNA ZONE

PDB employees begin agitation today

Employees of West Zone Power Distribution Company (WZPDC), a concern of Power Development Board (PDB), begin a two-day agitation programme today to protest a government decision to handover PDB power distribution lines in urban areas to Pally Biddut Samitee (PBS) in 21 southern districts.

They will hold demonstrations at offices and outside. The next progarmme will be announced on Thursday, leaders of employees unions said yesterday.

Recently, the government decided that power supply lines in urban areas consuming less than three megawatt power will be handed over to PBS.

According to the decision, power distribution in six municipal areas including Bakerganj, Hizla and Muladi municipalities in Barisal

Kushtia journo gets HC bail

The High Court has granted ad-interim bail to Kushtia journalist Munshi Torikul Islam, accused in a "false extortion case" filed by a clinic owner in the town following publication of a report.

A High Court Bench comprising Justice Nazrul Islam Choudhury and Justice Kamrul Islam Siddique also asked the government to show cause why the journalist would not given permanent bail within six weeks.

Torikul Islam is Kushtia Correspondent of UNB (United News of Bangladesh) and Dhaka-base daily Ajker Kagoj as well as Executive Editor of local daily Ajker Sutropat.

The "false extortion case" was filed after a report was published in Ajker Sutropat that one Dr Aminul Haq Ratan, an Awami League (AL) leader and owner of Tofazzol Hosain Health Centre, on June 8 gave a certificate to government employee to save him from punishment.

The employee was arrested in June for an alleged offence, confined in jail for six days and then served with a show-cause notice.

But the doctor's certificate said the employee was sick and was under his treatment, according to the newspaper

On June 9, some hoodlums having alleged link with the doctor also threatened the journalist of "dire consequences" for publishing the report.

Dr, Ratan filed a case under the Speedy Trail Act alleging that the journalist and his school going younger brother Munshi Habibur Rahman had demanded Tkone lakh toll for him.

Two absconding killers get life

Two killers were awarded life term rigorous imprisonment (RI) in absentia in a verdict given by a court here on Saturday.

The convicts are Zillur Rahman and

On June 28 in 1998, Zillur called his friend Babul, son of Kefatuddin out of his house at Dolapara village in Magura union of Kishoreganj upazila. Then he took him to Moulovirbazar. There he bought a betel leaf from Mohammad Ali's shop and offered it to Babul. According to a pre-planned conspiracy earlier Zillur mixed poison in the betel leaf in collaboration with betel leaf shopkeeper Mohammad Ali. Ill-fated Babul died instantaneously after chewing the poisoned betal leaf.

A Bangladeshi youth was beaten to death by a group of Indian nationals at Hakimpur village under Swarupanagar Thana in 24 Parganas (West Bengal) on Saturday.

How poor Anjoli changed her life

134 km roads damaged
Four years back, poor Anjoli Rani thought of ending her life, failing to feed her four children.
Now there is a television, electric

fan and other facilities at her house on a 10-katha land at Golapnagar village in Gheor Uupazila in Manikganj.

She also owns one bigha cropland. She told her success story when this correspondent visited her on Thursday last.

She was the eldest among five brothers and sisters. Her father was a day labourer. At the age of 12, she started her life as a domestic help at a house in the village.

At 14, Anjoli entered her husband's house in the same village.

Poverty followed her there.

Starvation started when she became mother of four as her porter husband could not feed the family, said Anjoli, now 28.

A "miracle" happened about four years back when a team from ASA, an NGO, visited their village. They enlisted her name in the Surjomukhi Samity (a women's association).

A few days later, ASA men visited her again and gave her Tk 4000 loan for cow fattening. After eight months she earned a

profit of Tk 3000 by selling the cow.

She took more loan. She bought a rickshaw van for her husband and five milch cows. She herds the cows herself and earns around Tk 200 a day by sells their milk. Her chikldren now

go to school.
