## Govt to enact law to check power pilferage

The government is going to enact a law to check power pilferage that is causing a huge loss to the power

The draft of the law will be tabled in parliament as early as possible, said State Minister for Power Iqbal Hasan Mahmud yesterday.

"The law will be applicable to both consumers and officials as consumers cannot pilfer power without the help of dishonest officials," he said at a programme titled 'Face to Face with Women Journalists' in the city.

The law will have provisions for jail term and snapping of electricity connections as punishment

Power Development Board (PDB) and Dhaka Electric Supply Authority (Desa) have been facing a total loss of Tk 4000 crore due to power pilferage, unabated corruption and non-payment of bills.

He also said at least \$ 2.7 billion is needed to meet the growing demand for power. "If we get the money, we will be able to provide electricity for all." To stop power pilferage, pre-

paid meter would also be introduced in Sylhet, Bogra Chittagong, Sirajganj and Banani area of Dhaka in January, he said.

The new law will include three stages of punishment for power pilferage -- if caught for the first

time, the person involved will get six months' jail term and the power connection will remain cut off for six months. If the act is repeated for the second time, the consumer will be jailed for one year and the power connection will remain cut off for two years. If it is repeated for the third time, the person will get seven years' jail term and will be deprived of electricity forever.

"I do not blame the consumers for pilferage; the employees are mainly responsible for it," Iqbal Hasan observed Bangladesh Centre for

Development, Journalism and Communication (BCDJC) organised the programme.

EVICTION OF LANDLESS PEOPLE IN NOAKHALI

## Rule nisi on govt

The High Court on Wednesday issued a rule nisi on the government asking it to show cause why it would not be directed to protect the landless people living in char lands declared as shrimp mohal in

Noakhali. A division bench of Justice Mohammad Abdul Whabab Mia and Justice Zinat Ara also sought to know why the government would not compensate the landless people who were harassed, intimidated and evicted by the land grabbers and socalled shrimp cultivators.

The rule nisi was issued on a writ petition filed by Nijera Kori along with BELA, BLAST, Ain-o-Salish Kendro, ALRD and BSEHR, said a press release.

In the writ, they sought settlement of the land in favour of the landless people as per the provisions of the Land Management Manual, 1990 and also the shrimp mohal management guidelines.

The court also stayed the operation of the government memo declaring 11,955.59 acres of char land as 'shrimp mohal' in Noakhali that led to severe conflicts, unrest and dispute in the locality.

The court order will protect 40,000 landless people who fell victim to river erosion and started living in the khas char land, the press release added.

The order has been served on the secretaries of land, environment, and home ministries, inspector general of police, divisional commissioner of Chittagong, deputy commissioner of Noakhali, assistant commissioners (land), Sadar Upazila, Noakhali, and assistant commissioner (land),

# NGOs against immunity to WB

Allowing the World Bank to enjoy organisational immunity from any judicial proceedings would mean infringement of people's constitutional rights, said an NGO alliance at a press conference at Dhaka Reporters' Unity Auditorium yesterday.

Representatives of the Alliance against World Bank Immunity, an affiliation of at least 25 national and local NGOs, have expressed their concern over a draft bill named The nternational Financial Organisation (Amendment) Bill 2004, and said the government has initiated the bill to amend The International Financial Organisation Order 1972.

They called upon the government not to enact any law that may allow the WB or any of its auxiliary bodies immunity from legal proceedings as such immunity would go against the people's fundamental right to seek redress to any damage caused either to themselves or to the country.

"It's unprecedented to make laws beyond the purview of the Articles of

staffs to various privileges, as no member countries have so far given the bank immunity from legal proceedings," said Aurup Rahi, one of the representatives, while reading out a written statement.

As the WB is a public organisation and not a private one, any aggrieved person or agency must have the right to sue it in case any of its acts inflicts damage, it added.

The statement said the WB sought such immunity following a case filed by its former official Ismat Zerin Khan when she was sacked from the job.

"As the bank, through its worldwide experience, has realised that its activities are harmful for the people in many cases, it now seeks immunity from legal proceedings, said Farida Akhter of Ubinig.
