

Tk 3 cr 'rotten' imported wheat seized at Syedpur

700 mt out of 2020 unloaded: 11 truckloads taken to police station

Police on Sunday seized 11 truckloads of "rotten and stinky" wheat while a consignment imported from India was being unloaded at the goods yard of Syedpur railway station.

The seized wheat is part of 2020 metric tons of wheat valued at Tk three crore, carried to the railway station through Darsana land port.

The consignment carried in 30 wagons of Indian railway reached Syedpur railway station on Friday.

Prior to the police raid, about 700 metric tons were unload and taken out of the station since the unloading began on Saturday, police and other sources said. Unloading had continued till late hours Saturday night, sources at the station

claimed.

The wheat was imported by Hazi Mostaq Ahamed, owner of Sonia Enterprise through LMJ International of Punjab in India under LC No.13, opened on September 7 through Syedpur Islami Bank.

The seized trucks have numberplates as Dhaka Metro-Ta-11-1250, Dhaka Metro-Ta-02-08-74, Jessore Ta-0240, Nilphamari Ta-05-003, Dianjpur Ta-11-00052, Dinajpur Ta-1100053, Dhaka Metro-Ta-11-0973, Dhaka Metro-Ta-11-3973, Rangpur Ta-02-0028, Rangpur-Ta-02-0051 and Rangpur Ta 9100.

Police detained the wagons and took all the trucks to Syedpur thana. A case is yet to be filed, police said.

On Sunday afternoon,

Nilphamari Deputy commissioner Shafiul Alam, Police Superintendent Choudhury Abdullah-Al-Mamun, District Controller of Food, Deputy Director of District Agriculture Extension (DAE) and Syedpur Upazila Nirbahi Officer visited the spot and inspected the seized wheat, trucks and wagons.

Samples of the wheat have been collected for test, official sources said.

When contacted yesterday, Hazi Mostaq Ahamed said he has been importing wheat and rice from India for long and such a thing never happened earlier.

Part of the present consignment could be damaged by rainwater seeping into the wagons on the way, he told this correspondent.

Hazi Mustaq has a flour and wheat mill named Australia Flour and Atta Mills at the BSCIC estate in Syedpur.

Meanwhile an influential quarter in Syedpur is trying to hush up the matter, it is alleged.

In 1999, another consignment of 3000 metric tonnes of unwholesome wheat imported from India by another importer was seized.

The import of allegedly rotten wheat during the present near-mongra situation in northern districts has created resentment among people. Many in the town say poor people are now compelled to take unwholesome food because they do not have any work.

At least two persons died and over 2000 have been attacked with diarrhoea in the last few days in several villages in Syedpur.

They pour salt water to destroy saplings

Believe it or not, they are watering saplings not to nurse but to destroy those. They are pouring salt water.

Over 10,000 saplings of valuable timber and fruit trees were planted on both sides of the 10 km Bangdah-Kunduria road in Brahmmarajpur union in the Sadar upazila.

The Satkhira Social Afforestation Centre, an organisation comprising people of all classes, planted the saplings with the help of Satkhira Forest Department. Marichhap Banayan Samitee, a women's voluntary organisation and Palli Chetana, a local NGO, were also involved.

Now, some accomplices of a local UP Chairman are pouring salt water stealthily to destroy the saplings on the plea of re-constructing the road, the planters alleged while talking to this correspondent. Authorities concerned were verbally informed but no action was taken against the persons, said Anisur Rahman, director of Palli Chatana.

Acid attack on father-in-law for dowry

A son-in-law threw acid on his father-in-law at Shikermari village in Sunderganj upazila on Saturday.

Jaharul Islam threw acid on Jahangir Alam as his daughter filed a case against her husband for torturing her for dowry.

Jaharul often used to beat his wife Julekha Begum, mother of two, for Tk 50,000. He sent her to her father to bring the dowry. Once at her father's house, Julekha filed a case against her husband.

On Saturday, Jaharul and his brother Tasizal Huq threw acid on Jahangir Alam and fled away.

The victim was rushed to Sunderganj Health Complex in a critical condition.

Police arrested Jaharul and Tasizal.

Minipuri weavers seek time to repay loans

12000 affected by flood

Flood affected weavers of Monipuri community in Kamalgonj upazila in the district need more time to repay loans distributed by the Bangladesh Handloom Board. There are about 1200 weavers in the community there.

Talking to this correspondent, many of them said they have become badly affected by the recent flood, because most of their houses and handlooms have been damaged and crops lost. The croplands at many places are now covered by sand carried by the floodwater from Dholai river and are now uncultivable.

Basanti Rani Singha of Adampur Monipuri Para said most of the weavers in five unions in Kamalgonj upazila are members of the Handloom Board, which give them loans to produce fashionable items including colourful saree, bedsheet, napkin, lungi and wrappers. These are in good demand in cities.

The recent flood made them virtually destitute and they have no ability to refund the loans.

Suna Moni Singha and Padma Mohan Singha of the same area are also weavers said they can not even produce crops for survival as lands are covered with layers of sand. Removal of the sand is very costly.

Almost all the Monipuri families have handlooms and they get loans from different organisations including the Handloom Board. Most of their looms are now inoperative. It will not be possible to repay loans in next few months, they said. They demanded extension of time to refund the loans.

Attack at DU condemned

RUTA, CUTA issue statements: Students hold rallies

Teachers of Rajshahi and Chittagong universities and different student bodies have strongly condemned Saturday's attack on the office of Dhaka University Teacher Association (DUTA) President Prof AAMS Arefin Siddique and students' procession on DU campus.

Our RU Correspondent reports: Teachers of Rajshahi University (RU) in a statement on Sunday condemned ransacking of the office of DUTA President and attack on processions brought out by Bangladesh Chhatra League (BCL) and five left-learning students organisations.

They urged the government to ensure security of teachers and students on campuses.

The teachers also warned of tougher program if the government fails to punish those responsible for ransacking of the DUTA President's office.

The teachers demanded arrest and punishment of the attackers and their expulsion from the university immediately.

The 174 signatories to the statement include Progressive Teachers Association Convener Prof Entajul Haque, Ruta Join Secretary Sadekul Arefin Matin, former Ruta president Prof Sayen Uddin, Prof Moloy Kumar Bhowmik, Prof Anando kumar, Prof Hasibul Alam, Social Science Faculty Dean AHM Zihadul Karim and Prof Anser Uddin

Different student bodies and cultural organisations also condemned the Saturday's attack on DUTA president's office and on students' procession on the Dhaka University campus.

Samajtraintrik Chhatra Front (SCF) brought out a procession on the RU campus and held a rally in the city protesting the attacks.

SCF General Secretary Shusantho Singha led the procession.

Speakers at the rally held ruling BNP responsible for the attack and demanded arrest of the culprits.

Bangabandhu Sangskritik Jote, Anushilon Drama Group,

Bangabandhu Parishad and Gonoshilpy Ghosti also condemned the attack, expressed deep concern over the incident and demanded arrest of those involve in the incident.

Rajshahi University Teachers, Officer and Workers Welfare Association in a statement condemned the attack and demanded security of teachers on campuses.

Rajshahi city unit of Bangladesh Chhatra League (BCL) yesterday took out a procession in the city and held a rally protesting the attack and demanding punishment to the culprits.

It threatened of tougher agitation if the culprits are not punished.

BCL city unit president Abdul Momin and zedu Sarker led the procession.

BCL units at Rajshahi University of Engineer and Technology (RUET) unit and Rajshahi Medical

College also protested the attack and demanded punishment of the persons responsible.

Our Cu Correspondent reports: The Chittagong University Teachers' Association (Cuta) has expressed grave concern at the incidents of attack on the DUTA President's office and on students' processions.

"Incident of such attack on the DUTA president's office is an attack on the teachers community as well as a threat to the society", Cuta said in a statement issued here on Sunday. It also demanded punishment of those involved in the attack.

The statement was signed by Cuta President Prof Dr. Nurul Anwar and General Secretary Prof Gazi Saleh Uddin.

Lubo League leader held with arms

Pistol recovered from Alliance procession

Alam was going to submit nomination paper. The piston slipped from the pocket of one of his supporters and fell on the road.

Police sub-inspector Mahmudul Huque, who was in the police team that followed the procession, picked up the pistol, witnesses said.

Police did not arrest nay body in this connection.

Yesterday was the last date for filing nomination for the Rangamati Municipal Polls.

When contacted latter, the duty officer at Rangamati thana said he did not know anything about recovery of any fire arm from the procession of the four party alliance.

HORROR IN 14 SATKHIRA VILLAGES

Males flee homes after outlaw lynched

Most of the males in 14 villages in Bardal and Khajra unions in Assasuni upazila are fleeing homes fearing arrest by police and retaliation by armed accomplices of slain Damodar Mondol, a leader of outlawed Chinnamul Communist Party (CCP).

Damodar Mondol was killed and five of his accomplices were seriously injured in a mob attack on them at Bamondanga village in Assasuni upazila when they came to collect tolls on the night of September 8.

His armed supporters threatened to retaliate, creating a panic in Bamondanga, Bordial, Madia, Baintala, Hetalbunia, Puijala, Parshemari, Surerabad, Lautara, Pirojpur, Fotikkhali, Gojuakati, Naktara and Mahishkur villages.

After the incident, Assasuni police also filed a case accusing over 400 unnamed villagers for murdering Damodar Mondol.

Now, nightfall brings horror in the 14 villages. Only elderly males are staying at homes.

"My son stays at Satkhira town for safety", said an elderly school teacher seeking anonymity.

It was gathered from local people that CCP activists led by Sangram had created a reign of terror in the area. Since 1997, they had been committing crimes including murder, extortion and abduction. Sangram was later murdered by activists of outlawed New Biplobi Communist Party (NBCP) led by Mrinal to establish supremacy in the area.

After the murder of Sangram, Tarun took leadership of CCP in Assasuni upazila. He sheltered Damodar Mondol of Hadda village in Koira upazila in Khulna.

In 2003, armed cadres of CCP led by Tarun and Damodar Mondol killed Shankar Kumar, niece of Mrinal to avenge the murder of Sangram.

The local Union Parishad chairman has also gone into hiding following the murder of Damodar.

The local people alleged that police failed to nap outlaws. Now they have lodged a case against innocent villagers, many people this correspondent talked to said.

When contacted, Assasuni thana OC Forkan Shikder admitted that there is tension in the area but police is trying to nab outlaws.

The situation is under control as special police force has been deployed there, he said.

Teenagers held with bomb-making materials

Betagi thana police in Barguna arrested six teenagers with bomb-making materials in the early hours of Sunday.

A police patrol team challenged a boat carrying some teenagers hours at Vagoler Paar on the Jhopkhali-Vanir Khal canal.

Police after a search found a huge quantity of sulfur, tin pots, broken pieces of glass and other materials used for making cocktails and hand bombs and arrested them.

The six are Jutil, Shahin, Sagir, Sujon, Majid and Hassan, all aged between 14 and 16.

During interrogation, they admitted that they were from Mirzaganj in Patuakhali and Kathalia in Jhalakati districts. They supplied bombs on orders, they told police.

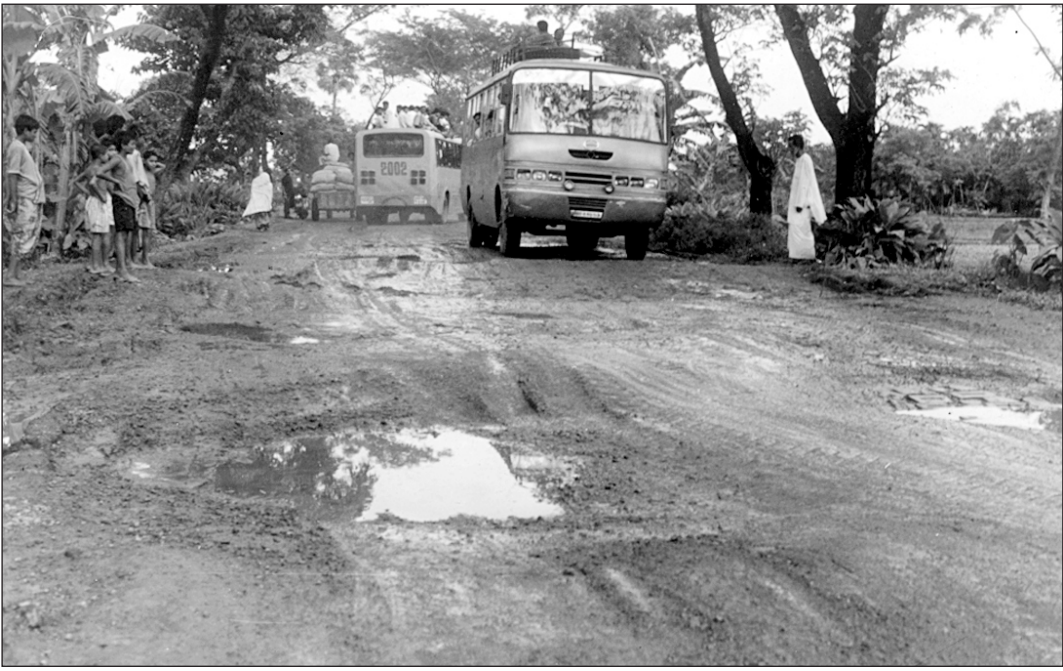

Boy killed in attack on Milad

Unidentified armed miscreants swooped on a Milad Mahfil (Muslim religious function) and shot a minor boy dead at Chandipur village on the outskirts of Barisal city Saturday night.

The eleven year-old victim Imranis the son of Rafiqul Islam, the main witness in Mahafuza Begum murder case.

Local people claimed that the targets of the killers were Nizam Khan, brother of Mafuza and complainant in the case and Rafiqul Islam, his cousin. The targets were missed and the minor boy was killed, they claimed.

Critically wounded Imran was rushed to Barisal Medical College Hospital (SBMCH), where doctor declared him dead at 9 pm.

According to the Officer-in-Charge of Kotwali thana, the Milad Mahfil was arranged on the occasion of chehlam of Mahfuza Begum, who was the complainant of the case filed in connection with the acid attack on engineer Eva on August 9. Eva died from acid burn injuries.
