Teesta irrigation project turns virtually useless

Political leaders demand release of equitable share of water in dry season

The Teesta Barrage, the largest irrigation project in the country, has virtually failed to supply irrigation water in its command area during dry season due to less flow of water

Thousands of farmers in its command area have become frustrated, as they did not get water in their lands since commission of the First Phase of the barrage in 1998.

According to records with the Water Development Board (WDB) office in Rangpur, the Teesta in Bangladesh turns into almost a "dry

channel from November to March" The lowest flow of water in the Teesta at Dalia point was about 4000 cusec in March 22, 2003, 3470 cusec in March 22, 2002, and 4050 cusec in March 22, 2001.

The Teesta Barrage project was built at a cost of about Tk 1000 crore. About 70.000 farmers in 12 upzilas in Nilphamari, Rangpur and

Dinajpur districts have left the hope of getting irrigation water from the project through canals.

A highly placed official of the project on condition of anonymity said farmers in Rangpur and Dinajpur districts under the project's command area will not get water in dry season unless India releases an equitable share of water through the

India has constructed a barrage across the river at Gozaldoba about 100 km upstream and diverts a lion share of the Teesta water during dry season, ignoring the demand in Bangladesh, he said.

The 615 metre barrage has 44 outlets, 110 metre canal head regulator with 8 outlets, a silt trap on 45 hectares of land, 2470 metre closure dam. The constructions include 80 km flood control embankment, 33.67 km main canal, 275 km major secondary canal, 1450 km primary canal, 2720 km tertiary canal and other structures

The purpose of the barrage was to supply 283 cusec water to 79378 hectares of land in 12 upazilas in Rangpur Dinajpur and Nilphamari districts during the dry season.

But the water level in Teesta decreases so much during dry season that the barrage could hardly discharge 50 cusec of water to its main canal. Hence, most of the canals under the project remained useless during dry season.

Only a few hectares of land under Nilphamari district could be brought under water supply.

Already, some parts of the secondary, primary and tertiary canals and some major structures of the project have been damaged as those could not be utilised. Some of the iron structures have been stolen as those were left inoperative.

"Only equitable share of water through the Teesta can make the barrage functional," said GM Kader, a Jatiya Party lawmaker elected from Rangour-3 constituency.

"We hope the government will arrive at an understanding with the India government soon for equitable share of water through the Teesta"

Awami League legislator Azaduzzaman Noor elected from Nilphamari-2 constituency when contacted regretted that the largest irrigation project in the country has become useless to farmers for whom it was constructed.

He blamed the then government for constructing the barrage before reaching an accord with India.

"I doubt whether the government's sincerity to make India agree to sing an accord for equitable share of the Teesta water", Noor said.

Ruling BNP's Rangpur district unit president Rahim Uddin Bhorsa said, "The secretary level meeting of the Joint Rivers Commission today (September 14) in Dhaka must be fruitful. An accord should follow the meeting", he hoped.

Disability no problem for Sumi

studies and started going to school with the help of her father. After completing primary educa-

tion, she entered local Nogendra

the Secondary School Certificate (SSC) examination in 1998 in Second Division. Sumi gratefully remembers the care and affection of her parents, her uncle Kashia Gour and Selim Jahangir, a teacher at the Arati Gour, Sumi was eager for primary school who encouraged her to continue studies. She passed the Higher Secondary Certificate (HSC) examination in 2001. Now she is a

Pilot Girls High School and passed

final year student of BA. "Ás I am disabled, I have to do something to be self-reliant. I got the job by dint of merit", she told this correspondent at her office recently.

She participated in a training course on computer at the Centre for Rehabilitation of Paralysed (CRP) at Savar in Dhaka in 2002. "After the training I was con-

vinced that disability is no problem", a confident Sumi said. "Any body with disability like me can be educated and self-reliant" Sumi wants to be lawyer because

this will upgrade her social position and help her to work for the underprivileged in the society.

"I want to do some thing for the disabled so that people remember me after my death", Sumi said.

She is also working with CRP self-help group in her area (in Muktagacha upazila) since 2001 as

"I spend my holidays with disabled people in my area and organise them, discuss how disability can be overcome. I encourage disabled people to be educated and trained to become self-reliant. I have sent some of them to the CRP for train-

Second among a brother and two sisters, an unmarried Sumi said she wants to lead a life with honour so that no one can ignore her.

But she feels that not all in the society appreciate her struggle, Sumi regretted. People should change their attitude towards. The physically disabled should get equal opportunity like others in the society in all walks of life, she said.

'Rotten' wheat imported knowingly

Case after test report, officials say

Unloading of the consignment of "rotten and stinky" wheat imported from India was completed at Syedpur railway station yesterday under police guard.

As the administration has no suitable place to store the huge quantity, it has been kept at the godown of the importer at the BSCIC industrial estate at Saidpur. The godown has been sealed and police have been deployed there,

Haji Mostaq Ahamed imported the consignment of 2020 tonnes of wheat. He has a flour mill in the BSCIC estate.

These were carried to Syedpur by 30 Indian wagons on Friday. Police seized 11 truckload of the wheat on Sunday when it became known that the food grains were rotten. About 70 tonnes were unloaded before police intervened.

handed over to BADC (Bangladesh Agriculture Development Corporation) for test.

Superintendent Chowdhury Abdullah Al Mamun told this correspondent that all papers have been seized from the importer and a case will be lodged if BADC says the wheat is unfit for human consump-

The Deputy Commissioner, the SP, and district food department officials were present when the consignment was seized at the railway station on Sunday.

Officials said yesterday the wagons of Indian railway will be released in a day or two because Bangladesh government will have to pay demurrage of Tk seven lakh per day as per international law if those are detained.

They said the argument placed by the importer that the wheat could be damaged by rainwater on way is not acceptable. As per law, food grains imported from abroad in railway wagons must be covered with water resistant things like polythene. But no such arrangement was seen in the wagons.

"So, there is reason to believe that rotten wheat was imported knowingly", one official said.

Meanwhile, tests by the district food department revealed that the moisture content in the wheat was

much higher than the normal range. The importer also argued that he was cheated by the Indian exporter-LMJ International of Punjab.

To this, officials said that, had it been so, he should have informed the bank concerned and officials before unloading. But a large portion of the wheat was unloaded and taken away before police intervened, they said. The LC for the import was opened through Islami Bank, Saidpur.

Asked why he did not inform police before starting the unloading, the importer said he was out of Syedpur at that time, the officials

"It is acceptable that he was out of Syedpur while such a big consignment was being unloaded? said an official

The import price of the wheat was Tk 6 pet kilogram, according to the papers seized. The market price of good quality wheat is between Tk 11 and 12 in Bangladesh now, sources said
