Pro-govt lawyers blame SC Bar for parallel probe

Supreme Court Bar Association has no legal or constitutional mandate to discard the judicial probe report on the August 21 grenade attack on Awami League rally, said the progovernment lawyers at a press conference yesterday.

Similarly, the association is not authorised to carry out another parallel investigation into the massacre, they said at the conference organised under the banner of Jatiyatabadi Ainjibi Oikya Parishad.

The judicial inquiry committee was constituted under the law of the land and it acted like a civil court. There is no question to reject the report of this committee, said Advocate Mahbubur Rahman MP.

Lawyers in general have not empowered the Bar association to accept or reject the commission report, he added.

The probe committee, formed by a section of lawyers in the name of the bar association, is motivated by a certain political party and has no legal basis, said Advocate Zainul Abedin, legal affairs secretary of the ruling BNP's central committee

while reading out a written state-

"Opposition leader Sheikh Hasina refused to give an interview to the judicial probe committee on the grenade attack with a view to protect those responsible," he said replying to a guestion.

Bar association's action of forming inquiry committee has not only tarnished the image of the country's highest court but also has gone against the fundamental spirit of upholding the unity of lawyers community and facilitating their professional duties, Abedin added.

City madrasa ransacked, 25 injured

Twenty-five people were injured in a clash between a group of hired men of the owner of Harli Barli Store and the students of Babus Salam Madrasa at Haii Camp Road in the airport area in the city yesterday.

The clash began when the hired men numbering about 60 vandalised the madrasa doors, windows and wall at around 10.30am yesterday, local people said.

The madrasa authorities immediately informed the Rapid Action Battalion (Rab) and the police who rushed to the spot, said Anisur Rahman, principal of the madrasa.

"But the police remained silent while the gang ransacked our structures worth around Tk 10 lakh," he said, adding that the students tried to resist the attackers.

The witnesses said that both the groups fought almost for an hour with whips, bricks, hockey-sticks, bamboos and rods, leaving 25 injured.

Later, Rab brought the situation under control. Police picked up six people, including two madrasa students from the

The injured who were rushed to Dhaka Medical College Hospital are Shamim, 20, Abdul Kuddus, 26, Abdul Hakim, 30, Kaikobad, 20, Ashraf, 20, Nasir Billah, 9, Md Emran Hossain, 12, Md, Monjurul Islam, 15, Md Yousuf, 22, Abu Bakar, 18 and Md Kabir Hossan. The rest received treatment

at local clinics.
Syed Mustak Hossain Ratan, president of the madrasa, told The Daily Star that two brothers rented the ground floor of the madrasa on February 18, 2002 but they violated the conditions of the deed and encroached around 3,000 square feet.
