Saber blames govt for creating confusion

Saber Hossain Chowdhury, political secretary to opposition leader Sheikh Hasina, yesterday accused the government of creating confusion among the people about the August 21 grenade attack on Awami League (AL) rally.

"Nearly two months have passed, but there is no headway into the inquiry although the government high-ups including the prime minister had pledged to give exemplary punishment to the culprits through proper investigations", said Saber at a press briefing at Sudha Sadan at Dhanmondi in the city.

"In fact, the government is reluctant to identify the criminals as their own men are involved in the crime," he alleged.

There is also no consistency

between what the government says and what it does, said Saber expressing his dismay over the progress of investigation.

The AL leader asked the government to make it clear whether any foreign country was involved in the August 21 grenade attack as two contradictory statements have been released in this respect.

"While the judicial commission put the blame to a foreign country, inspector general of police (IGP), at an international conference, said the police investigation did not find any international link to the August 21 and other bomb blasts in the

country", he said.

Saber alleged that both the statements were issued by the government only to create confusion.

Wife beaten to death by husband

A husband allegedly beat his wife to death at Mohortuli in the city on Monday.

She was identified as Nargis Akhter, 24, wife of a cable trader Mohammad Aslam, who resides at 33/1 Abul Hasnat Road.

Witness Al Amin, a seven-yearold boy and cousin of the victim, said Nargis asked money from Aslam for iftar which angered him and at one point of their altercation he beat her mercilessly.

Sources said Aslam then took her wife to a clinic first and then to Mitford Hospital where the doctors declared her dead at around 4:00pm. He returned home from there with the body.

On information, police recovered the body at around 8:30pm and sent it to Dhaka Medical College morgue for autopsy.

FARHAD MURDER Verdict Oct 26

A tribunal in Khulna yesterday refixed October 26 for pronouncing the judgement of the sensational industrialist SM Farhad Hossain murder case .

Judge MA Samad of the Speedy Trial Tribunal fixed the date.

Earlier, the judge fixed October 12 for the judgement.

Frozen shrimp exporter SM Farhad Hossain was gunned down by the extremists on October 17 in 2001 at Noapara under Fakirhat upazila of Bagerhat district. His wife Selina Begum lodged an FIR with Fakirhat police station on October 18 naming three people as accused and without naming 12 others.

in November last year. Nine out of 14

chargesheeted accused are still at large while two died in cross-fire with police in July and August this year. Three FIR named accused are in Khulna district jail.

3 killed in Mirersarai road accident

The magistrate postponed the hearing of remand prayer until the recovery of the arrestee.
