The Evaluation Sector has been allocated public funds from the Government of the People's Republic of Bangladesh (GoB) toward the cost of Revenue Budget, and it intends to apply part of the proceeds of these funds to payments under the contract for the provision of consultancy services for the project by a Consulting Firm (National).

The Services include:  
Evaluation Sector, IMED is the organisation which conducts impact evaluation of completed development projects of different ministries. During the current financial year, Evaluation Sector has decided to carry out five (5) impact evaluation studies by outside consultant on the following projects:

- Small Scale Water Resources Development Sector Project at upazila and union level (1996-2003)
- Youth Training and Self-Employment Project (1990-2003)
- Road Overlay and Improvement Project (1994-1998)
- Rehabilitation of Bangladesh Railway under the Assistance of CIDA (1998-2002)
- Female Support Programme Project (1992-2001).

Each impact evaluation study will be treated as separate contract. Short-listing will be done for each study.

One firm can not apply for more than three studies.

For conducting the impact evaluation studies, consulting firms will have to:

disseminate the draft report in the seminar/workshop; and finalise the draft report.

The experience, resources and delivery capacity required are: The consulting firms must have more than 10 years' experience in conducting impact evaluation studies. Interested firms are invited to provide information indicating their availability of appropriate professionals, experienced staff, brochure of firm and list of minimum 5 impact evaluation study reports. The implementation period of each of the studies will be during January 05 to May 05.

The Evaluation Sector now invites eligible applicants to indicate their interest in providing the services. Interested consultants are invited to provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar operating conditions, availability of appropriate professional qualification and experience among staff, etc.). Applicants may associate with other applicants to enhance their qualifications, and though not mandatory, association with foreign firms is not encouraged in this instance.

A consultant will be Selected using the selection under a Fixed Budget (SFB) procurement method in accordance with the Public Procurement Regulations-2003 and Public Procurement Procedures issued by the GoB.

Expression of Interest shall be submitted by 4.00 PM on 10-11-2004, sealed envelope delivered to Director General, and be clearly marked "Request for Expressions of Interest for Consulting Firm (Lump-sum)."
