Subject to the condition that all the eligible category of contractors/tenderers stated above have minimum 10 (ten) years of general experience in construction work and also either have successfully completed at least 1 (one) number of similar construction work amounting to minimum Tk 10,00,000.00 (Taka ten lac) during last 5 (five) years or have successfully carried out a building construction work amounting Tk 15,00,000.00 (Taka fifteen lac) (Minimum Billed Amount) during last 5 (five) years. The tenderers shall have to furnish certificate in this respect from officers not below the rank of Executive Engineer under whom the certified work has been done, which will be verified by the Executive Engineer of PWD of that locality/district. Certificate format will be available with the tender document (format A).
