UPGRADING BM COLLEGE TO VARSITY ECNEC approval likely today

A proposal to upgrade the Barisal Government Brojomohon College to a public university has been approved at a pre-ECNEC meeting.

It is likely to be approved by the ECNEC (Executive Committee of the National Economic Council) today, sources said here.

When asked, college principal Prof Nurul Hug corroborated the information and said that the matter will be sent to the parliamentary committee after ECNEC approval.

The decision will be effective from 2005-2006 academic session.

Prime Minister Khaleda Zia during a visit to Barisal on April 8 last year had declared that BM College would be turned into a public university.

RU BCL protests decision to rename NU

Bangladesh Chhatra League at a meeting on Rajshahi University campus yesterday protested National University Senate's decision to rename the university as Ziaur Rahman National University and urged it to reverse it.

This is part of a government plan to "politicise" the education system, speakers at the meeting said.

BCL central joint secretary Kamruzzaman Chonchol was present chief guest while BCL RU unit president Ibrahim Hossain Moon presided over the meeting.

The BCL leaders demanded immediate cancellation of the decision and threatened of agitation movement for non-compliance. They also urged other student bodies to join their agitation to stop renaming of the National University.

The meeting was addressed by, among others, RU BCL vice president Mamunur Rashid, joint secretary Wabidur Rahman and organization secretary Masud.

The BCL units at Rajshahi University of Engineering and Technology (RUET) and Rajshahi Medical College in a separate statements protested the NU Senate.

Pneumonia claims 12 children in Netrakona

Pneumonia has broken out in an epidemic form in 10 upazilas in the district.

Twelve children died of the disease and about 2,000 children were attacked by the disease in last five days, according to Netrakona Civil Surgeon (CS) office sources.

In Durgapur upazila, two children died and 300 others were affected, in Kalmakanda upazila, two children died and 250 others were affected, in Kendua upazila, one children died and 400 others were affected, in Atpara upazila, one children died and 200 others were affected, in Madan upazila, 220 children were affected, in Khaliaguri upazila, one children died and 180 others were affected, in Netrakona Sadar upazila, two children died and 450 others were affected, in Barhatta upazila, one children died and 230 others were affected, in Purbadhala upazila, 150 children were affected, and in Mohongonj upazila two children died and 270 others were affected, according to the CS office sources.

Netrakona CS Dr Mainuddin Ahmed Chowdhury told The Daily Star, change in season is the main reason of its outbreak.

Scarcity of medicine deteriorated the situation, locals alleged.

However, the CS denied the allegation of scarcity of medicine in government hospitals. He asserted that pneumonia had been in his control. The report of its outbreak in epidemic form is also totally false, he added.

Small farmers sidelined

Tk 1.6 cr loans to 3 estates, Tk 1.24 lakh to small farmers: Saplings, training not provided

**Nilphamari:** Small farmers and owners of small holdings are facing problems in getting loan, tea saplings and technical support.

As tea plantation is something new in the area, the growers need training and all other facilities but the government assistance is very limited.

RAKUB (Rajshahi Krishi Unnayan Bank) provides Tk 45,344 loan per acre to tea growers. But small farmers are sidelined in the process.

RAKUB gives preference to those who have recommendation from the Technical Committee and have created tea garden in one tenth of the land. The technical committee is comprised of four members from Bangladesh Tea Board (BTB), Tea Research Institute and RAKUB.

Getting loan is a lengthy and troublesome process for small farmers. Many of them said their loan application has to be approved by the technical committee, but it has no fixed date for meeting.

BTB sources said four meetings of the technical committee were held since launch of the pilot project.

Even after getting recommendation from the technical committee, farmers have to face hassle from a section of employees in getting bank loan.

According to data available from BTB Panchagarh regional office, 15 small farmers so far got Tk 1,24,300 loans while two small holding got Tk 8,26,200 Tk and three tea estates got Tk 1,06,35,100.

Of the three tea estates, Karotoa Tea Estate got Tk 25.91 lakh for 28 hectors, Dahuk Tea Estate got over Tk 58.11 lakh for 60 hectors and Moinaguri Tea Estate got Tk 22.35 lakh for 20 hectors.

The loans bearing 9½% interest are repayable in eight years. Repayment will begin from the fifth year but interest will be counted from the day of loan disbursement. BTB takes one per cent of the loan as service charge, many farmers said.

When contacted, RAKUB Regional Manager SM Smamsul Alam said in giving loan the bank considers the tea garden of farmers not the valuation of the land mortgaged.

Farmers said loans are given only after they create garden on ten per cent of the land, a condition which is very difficult for them to fulfil. This condition should be waived, as in the case for other crops like paddy, potato, sugarcane etc, the said. The BTB is supposed to give subsidy to small farmers at the rate of Tk 14,000 per hecter (Tk 5668 per acre) for buying tea saplings and to meet other expenses but any farmer is yet to get it.

BTB Senior Development Officer AKM Shahidullah said they have received many applications from small farmers for subsidy but could not say when disbursement will start. One hectare of land needs 16000 to 18000 tea saplings, each costing Tk 3 to 4.

BTB Senior Development Officer AKM Shadidullah however said BTB provides tea growers with many facilities like helping them to do registration, soil test, technical

support, training, recommendation of scheme and subsidy for purchasing tea saplings.

Another great problem for small farmers and small holdings is arranging tea saplings and acquiring cultivation skills.

The BTB has a two-acre exhibition nursery at Buraburi village in Tentulia upazila. But it is only for display and saplings are not sold.

The big tea estates have their own nurseries but they also do not sell tea saplings to others.

Shahidullah said they do not supply tea saplings but recommend parties and small private nurseries so that they can procure saplings and clones from the Tea Research Institute in Srimongol in Moulvibazar district.

But it is very difficult for small farmers to bring saplings from Srimongol, they said.

Taking the advantage, some dishonest people have started smuggling tea saplings and clones from across the border, but their quality can not be ensured.

Many of the farmers this correspondent talked to said they approached the BTB officials for training but were disappointed. As this is new, they need adequate technical knowledge but the BTB can not provide this due to shortage of manpower.

When contacted, BTB Development Officer Amir Hossain said they arranged three training courses so far, each lasting two days. A total of 200 people were trained so far.

But farmers said the training courses were too short and inadequate.

BTB sources said farmers interested in better training should go to Srimongol and they will give recommendation for this.

The farmers said as tea plantation is new in the area, the BTB should set field level trained workers like the Agriculture Extension Department to advise them on its cultivation.

NGO (non-government organisation) activities are not seen as regards tea cultivation in the area. RDRS (Rabangpur-Dinajpur Rural Service), an NGO, had shown some initial interest in the field but their activities are not seen now, local people said.

Another problem for small farmers is that they can not sustain the gestation period after engaging their lands in tea plantation. Many of them said they are losing interest because they can not survive four years after plantation to reap the benefit.

There are propaganda, problems and also optimism, but the great prospects will be lost if small farmers are not considered as the mainstay in the project, experts and observers said.

Very little has been achieved so far. Out of 65,000 acres, slightly over 1000 acres have been brought under tea plantation so far—about 959 acres by big estates and 71 acres by small farmers.

Small farmers should be encouraged to exploit the potential fully because there will be limitation to areas of big estates after a certain stage, they said.

Fraudulence in weight: Fertiliser godown sealed

A fertiliser godown was sealed following detection of its shortage in weight in each bag.

Upazila Nirbahi Officer (UNO), Fulchhari sealed the godown at Kalirbazaar on Tuesday.

The fertilizer and the seeds were stored for distribution among flood-affected marginal farmers in the upazila.

On the day, seeds of Mashkalai, a kind of pulse, and fertiliser packets were being distributed among the victims from the godown.

Arendabari Union Parishad (UP) Chairman Abdul Alim suspected a bag of fertiliser below its weight. He informed the matter to the concerned upazila agriculture officer who did not pay heed to the concern.

He took weight of the bag outside the godown and found there only nine kilogram of fertiliser against its actual weight of 13 kilogram.

He informed the matter to Fulchhari UNO Gautam Kumar Bhattacharya who rushed to the spot and checked many bags from the godown. He too found shortage in fertiliser bags by four to five kg against 13 kg. He informed it to the Deputy Commissioner and sealed the godown.

Planet World reopens

'Planet World', the only children's park in the city, reopened on Friday after two and half months' closure.

The reopening followed signing of a fresh agreement between its Managing Director Awami League leader the Shawkat Hossain Hiron and the Barisal City Corporation (BCC), under which the Planet World has been leased to the former for three years under fresh terms and conditions. Mayor Majibur Rahman Sarwar MP signed the agreement on behalf of the BCC. As per the new conditions, the entry fee has been reduced to Tk 8 from Tk 10 and the leased area to 4.66 acres from 8.66 acres.

Overall control of the city corporation has been enhanced. The BCC logo will be printed on entry tickets and the earlier signboard of Ladies Park will be restored, sources said.

The lessee can not destroy or damage trees and other assets of BCC and the beauty and environment of the park in the name of development.

The Planet World was closed by BCC on August 7, alleging that its lease was illegal.

Influentials grab lands along roads in Satkhira

Authorities yet to take action

After two years of demolition of thousands of illegal structures, influential people are again out to grab lands on both sides of the 75-kilometre Satkhira-Munshiganj highway in last one week.

They are rebuilding illegal structures under the very nose of the Roads and Highways Department (RHD) authorities who bulldozed those, built at a cost of Tk 10 lakh.

Local people expressed their dissatisfaction over the mysterious role played by local administration and the concerned department in this regard.

Former Deputy Commissioner Abdul Matin Chowdhury took the initiative to demolish the structures by deploying magistrates and police.

The drive continued for two months during the Clean Heart Operation-2002.

Influential people are creating false documents to grab the lands. Over 100 unauthorised structures were built along the busy Kamalnagar-Itagachha area in the town while over 1,000 unauthorised structures were rebuilt on both sides of Satkhira-Munshiganj highway. But no action is in sight till filing of the report on Tuesday.

A source in the RHD, on condition of anonymity, told this correspondent no step could be taken against the illegal occupants and unauthorised structures due to departmental complication, political pressure from the ruling party and influential people.

An official of the RHD, Satkhira, seeking not to be named, told this correspondent that the influential people had been grabbing lands of the department by creating false documents in connivance with a section of unscrupulous officials and staff of the department.

Illegal occupants claimed they have legal documents with them for building the structures.

On contact, Md Elias, Deputy Commissioner, Satkhira told The Daily Star he already instructed the executive engineer of RHD,

Satkhira over phone to take action against illegal occupants.

If needed, the unauthorised structures will be demolished by deploying magistrate and police again, the DC added. Abdul Mannan, Executive Engineer of the RHD, Satkhira told this correspondent that he is helpless 'because of political pressure'.

He, however, informed that the list of illegal occupants was sent to the higher authorities concerned for taking action against them

Diarrhoea: Seven die in Gaibandha, 2 in B'baria

Diarrhoea claimed seven persons in Gaibandha in three days and two others in Brahmanbaria in a day.

Our Gaibandha Correspondent reports: Over 300 persons were attacked by the deadly disease in three days in the district.

Of the seven dead victims three died at Sundarganj, two at Gaibandha Sadar and two others at Palashbari upazila.

The victims are Rekha Begum, 29, Tasir Bewaya, 40, Ruhul Amin, 2, of Sundarganj upazila, Manjila Begum, 27, Sima Khatun, 1, of Gaibandha Sadar upazila and Shapla Begum, 40, Khadem Ali, 55, of Palashbari upazila.

The Civil Surgeon of Gaibandha told this correspondent, about 106 medical teams were working in remote areas to tackle the situation.

The main reason of outbreak of diarrhoea is consumption of inedible food and contaminated drinking water by people in flood affected areas, according to local people. Scarcity of medicine has been prevailing in the remote areas.

Working health assistants told The Daily Star many patients died due to wrong treatment of quacks in remote areas.

Our Brahmanbaria Correspondent reports: The two dead victims are Md Nabi Hossain, 35, and Faysal, 12, of Gupinathpur village in Kasba upazila.

At least 100 others were attacked by the disease at Gupinathpur village, Deli village, Pataisha village, Khaura village, Akshina village, Lattua Mura village and Chandidhar village.

Meanwhile, over 15 villages in the upazila were affected.

The ward commissioner urged the local people to identify drug peddlers and submit their lists to police.

Earlier, they brought out a large anti-drug procession. The processionists paraded the main streets of the city.

The programme is part of a RCC anti-drug movement programme in all wards in city to create awareness against the drug and AIDS.

Effective waste management in Patuakhali

Patuakhali Pourasabha has been implementing a waste management project successfully to keep the town clean since 1999.

Initially, the Household Waste Management Project started in collaboration with the international agency-DANIDA, in three crowded areas of Kathpatti, Old Hospital Road and Charpara.

Under the project, 1,000 buckets were distributed free of cost among the residents to put their household waste in it. Visiting from door to door, appointed workers collect the waste from the buckets. They carry the waste by rickshaw-vans, supplied under the project.

A collector collects Tk 20 from every house as monthly waste charge. A charge collector, three vanpuller, three women waste collectors and an inspector are working under this project.

Conservancy Inspector Nazrul Islam told this correspondent at his office, the project has already turned the town clean. Ultimately the authorities will extend the project in the entire pourashava area, he disclosed.

15 chargesheeted in Barisal medicine loot case

Police have chargesheeted 15 people in the case for looting Tk 20 lakh medicines from the district health department store.

Five of the accused including BNP leader Farid Khan has been dropped from the charge sheet.

Nil Utpal Dey, OC of Barisal BDB police, submitted the charge sheet to Sadar upazila Magistrate court on Thursday.

The 15 chargesheeted are Kanchan Ali Howlader, Sahabuddin Sikder, Babul Khan, Manir Hossain, Mozammel

Hossain, Farid Hossain, Abdul Kuddus, Abul Kasem, Zakir alias Nana Zakir, Bazlur Rahman alias Bazlu, Barek Howlader, Taslim, Alam alias Alamin, Alamgir Sikder and Shayamol Gosh. The first five of them are in custody and the rest ten are absconding.

Names of those dropped from the charge sheet include Md Shamim, Md Tofael Sikder, Md Abul Kaium Molla and Md Shah Alam Biswas.

In charge sheet, the investigation officer said that the accused people looted medicines worth Tk 20 lakh from the store of the dis-

trict health department at Amanatganj in Barisal city on June 18 this year.

Barisal Civil Surgeon Abdul Malek had filed a case on June 19 with Barisal Kotwali police. The case was transferred to DB.

Investigations revealed that the dacoits were members of a gang of inter-district gang and the looted medicines were sold in different markets in Dhaka, Gopalganj and other districts. Some of the dacoits were involved in the looting of medicine from Pabna Mental Hospital.

Dhaka-Agartala bus service may resume this month

Bailey bridge at Akhaura being repaired

Dhaka-Agartala bus services may be restored this month after repair of the bailey bridge at Debogam in Akhaura upazila.

The repair work has already started.

Roads and Highways engineer Sirajul Haque told this correspondent that the bridge will be repaired within this month and all types of vehicles will be allowed on the road after the repair.

Movement of vehicles through the road remained suspended since August 18 as the bridge collapsed with a cement loaded truck.

Import-export activities through Akhaura customs office were also

affected as the link to India remained snapped for about two months.

After recession of floodwater from Brahmanbaria, bus service between Dhaka and Agartala was restored on August 14 through Akhaura check post. But lying of trucks weighing over 10 tons were not allowed as the road became rugged.

The bridge collapsed on August 18 when cement loaded truck weighing about 15 tons was crossing it, defying the ban.

The condition of 16 kilometre portion of the road from Dharkhar to Akhaura check post is very bad.
