Massive beautification of city for Saarc Summit

The city's beautification plan for the upcoming the South Asian Association for Regional' Cooperation (Saarc) Summit is expected to complete by mid November, a month ahead of the high-profile conference slated for January 2005.

"We hope the executing agencies will not miss the November 15 deadline for finishing the project as 80 percent work has already been done," said Commodore Sohel Faruque, member secretary of the Dhaka City Beautification Cell

The cell has been formed comprising officials of the DCC, Dhaka Electric Supply Authority, Dhaka Urban Transport Project, Dhaka Water Supply and Sewerage Authority, Dhaka Electric Supply Company, and the Police Department to assist in implementation of the beautification programmes.

The beautification project, undertaken at the directives of the Prime Minister's Office, is being executed by various government agencies and private organisations under the supervision of the Dhaka City Corporation (DCC).

Under the project, almost all important medians and road islands stretching from Bangabhaban to airport have been brought under fresh plantation. A total of 71 public and private organisations are implementing the project.

The authorities have divided the city into 109 zones and asked the executing agencies to beautify these areas. The private organisations will plant trees on medians and road dividers and maintain the plants for the next four years.

Besides, two parks have been handed over to private organisations for eight years for maintenance and beautification.

"The government does not need to spend on this project. Government agencies and private organisations are implementing this plan with their own funds," Commodore Sohel Faruque said. "DCC is coordinating the whole project.



Makeshift Iftari houses on footpaths

Makeshift iftari outlets have encroached most footpaths along Road No 27, Satmajid Road in Dhanmondi and the stretch from Mirpur Road to Dhanmondi, while footpaths of Old Dhaka are overcrowded with such shops.

Most shop owners said they begin sales an hour prior to iftari time, but residents of the area complained that sales start just With the footpaths occupied

by these outlets, pedestrians walk on the main roads, increasing the chaos on the already congested streets.

A manager of a halim house in Kalabagan admitted that selling iftari on public property is illegal. "It is only during the Ramadan Police and DCC officials warn us from time to time but since many outlets are on the footpaths, we take our chance as well," he said.

"We are continuing eviction drives on these makeshift outlets and on Saturday we evicted some shops in Fulbaria near Gulistan with the help of the police," Chief Estate Officer of DCC, Abu Taleb told the Star City. "But an hour after the evic-

tion, residents complained that the shops came out again. The police has to handle these situations as they are the law enforcers and have the authority to curtail such activities." Taleb

Abdul Noor, a resident said that right after DCC officials left, the business started again with a bribe given to the police, while

month that situation arise. Rahman Miah from a Satmasjid road outlet confirmed that a bribe of Tk 50-60 business could go on without any hindrance.


We raised the issue of increasing police patrol in the eviction drive in a meeting with the Mayor and Police Commissioner," said Abu Taleb.

There are two types of iftari vendors -- those who own shops and others with a single table catering to the low-income group. Some of them are can be seen in the open just selling chola and muri.

Vendors said that there was no specific space allotted to them by the DCC to sell iftari. "Sales will not be good if we are located inside a building or market place, as we cater to the low income group that pass by from work," said a vendor from

"As rickshaws are off-limit on many VIP roads, we have to walk home from office for iftar. But as the footpaths are intruded, 'it takes about 15 minutes more than the usual time to reach home and on quite a few occasions, I missed breaking fast with my family," said a pedestrian returning home from office.

Speaking to the police crimes division, an officer requesting anonymity told the Star City that they cannot evict these makeshift shops as this duty fell under the jurisdiction of the 24 mobile courts in the city. Each court has a magistrate who has the authority to remove such temporary shop. The police can only provide law-related support in the operations led by DCC teams.
