

First election day votes cast in New Hampshire

The nation's first Election Day votes were cast and counted just after midnight in a pair of mountain hamlets, with 35 votes for President Bush besting challenger John Kerry's 21 Ralph Nader received one vote.

The first votes came from the northern New Hampshire community of Hart's Location yesterday, where 16 voters chose Bush, 14 went with Kerry and one chose Nader. Minutes later, the 26 registered voters in Dixville Notch, about 50 miles to the north, split 19 for Bush and 7 for Kerry.

The tiny communities since 1948 sporadically have been taking advantage of a state law that allows communities to close polls early if all registered voters have cast bal-

In 2000, both communities chose President Bush over Democrat Al Gore. In Hart's Location, Bush won 17-13. In Dixville Notch, about 50 miles to the north, Bush had 21, Gore five and Ralph Nader one vote.

By state law, polls must be open between 11 a.m. and 7 p.m. But nothing prevents a town from opening the polls earlier and closing after all potential voters have cast ballots.

US polling places see scattered problems

Thousands of lawyers, computer experts deployed in states

Polling places experienced scattered problems early yesterday as legions of lawyers, election-rights activists and computer scientists watched, particularly in battleground states, for any trouble that could disenfran-

New rules, new voters and a tight presidential contest combined to create "a recipe for problems," said Sean Greene, who was assigned to watch Cleveland polls for the Election Reform Information Project, a nonpartisan research group on election reform.

Nearly one in three voters, including about half of those in Florida, were expected to cast ballots using ATM-style voting machines that computer scientists have criticized for their potential for software glitches, hacking and

Other major concerns were over provisional ballots, new this presidential election and a potential source of delayed counts, and whether poll workers were adequate

and sufficiently trained. In one Richmond, Va., polling place, voters were confronted with the wrong congressional race on the ballot the 7th District instead of the

Once it was discovered about 6:10, 6:15 (a.m.), people were offered a paper ballot," said Virginia Board of Elections executive secretary Jean Jensen. "I think the unknown is how many votes were cast before that

Long lines greeted voters in many big cities in closely contested states: Fort Lauderdale, Florida, Columbus, Ohio, Detriot and else-

where. Five locations in Franklin County, Ohio, opened up to a halfhour late because poll workers did not show up on time.

In Essex, Md., an election judge left a polling place briefly, saying he forgot something at home. Voters who had to wait were allowed to vote by provisional ballot.

One polling location in Mauldin, South Carolina, was forced to switch to paper ballots because of equip-

In Volusia County, Florida, a memory card in an optical-scan voting machine failed Monday at an early voting site and didn't count 13,000 ballots. Officials planned to feed and count those ballots

Chellie Pingree, president of the citizens lobbying group Common Cause, said she feared poll workers pressured to make quick but bad interpretations on rules governing registration validity and identification requirements.

"There's no question it's going to be a high turnout," Pingree said. "It's going to just add more confusion to already overburdened, understaffed polling places, many of which will have as many lawyers and poll challengers as they have people

By mid-morning EST, an online and phone hotline maintained by nonpartisan and liberal votingrights activists logged more than 1,650 items, mostly related to complaints or questions about registrations and polling locations. But some voters in New York and Pennsylvania complained to the hotline of troubles with non-

Legal challenges may delay result for weeks AFP, Hong Kong similar bashes bacross China.

Leading US civic rights groups warned Monday that legal challenges could again delay the outcome of the US presidential election for weeks if the race is as close as opinion polls suggest.

Final results in the 2000 presidential race were delayed for 36 days due to disputes over balloting in Florida, and resolved only after US Supreme Court intervention.

If it stays at ... basically a 50-50 split, I don't see any way in the world that we're going to know who the president is, maybe for weeks and goodness knows how much longer," said Ralph Neas president of the People for the American Way foundation, which is participating in a massive election monitoring exercise.

"I think we'll have huge issues in many states, Florida is obviously ground zero, although I worry a lot about Ohio," said Barbara Arnwine, director of the Lawyers Committee under Civil Law, which is also participating in the Election Protection:

"I believe that on Wednesday morning there will be a huge contest and fight over provisional ballots," she said in reference to the ballots cast by voters whose eligibility is

Americans in Asia

More than one million Americans across Asia were eagerly awaiting the climax of US presidential elections yesterday, preparing to break out bunting, balloons and beer for parties to watch the results roll in.

In sharp contrast it will be business as usual for tens of thousands of American soldiers stationed in the region, while others, notably Muslim US expats and aid workers, plan to spend the tense wait in quiet

Hotels from Hanoi to Hong Kong were booked up for get-togethers, featuring events such as mock ballots, debates and guest speakers intended to promote democracy as events unfold on big screens.

The US embassy and American Chamber of Commerce in China will host a party for about 1,000 mostly Chinese people at a Beijing hotel from 7:30am Wednesday, with similar bashes being held in cities

In addition to free food, partygoers will be able to watch election day coverage, while computers will be set up for people to go online. Mock ballots will be available for Chinese guests to vote for the candidate of their choice. "It's really an opportunity to

show how democracy works," said a US embassy spokeswoman. "It's a way to give us an opportunity to explain the election process to our contacts.' Guests include Chinese foreign

Ohio court okays voter challengers at centres

A federal appeals court has cleared the way for challengers to be present at polling places throughout Ohio, ruling early yesterday that their presence on Election Day was allowed under state law.

A three-judge panel of the 6th US Circuit Court of Appeals ruled 2-1 to grant emergency stays of two federal judges' orders Monday that barred voter challengers from political parties. The judges also consolidated the two appeals, which stemmed from separate lawsuits in Cincinnati and Akron.

Alphonse Gerhardstein, attorney for the plaintiffs in the Cincinnati case, said early yesterday that he appealed the 6th Circuit decision to

the US Supreme Court.

The federal appeals court said that while it's in the public interest that registered voters cast ballots freely, there is also "strong public interest in permitting legitimate statutory processes to operate to preclude voting by those who are not entitled to vote."

At least eight people were killed in a car bombing spree across fraq yester-day that targeted symbols of the USbacked government, while hundreds of residents fled the rebel-held city of

States voted for its next president after an election campaign that has focused closely on Washington's decision to invade Iraq.

Upping the stakes, at least four staff from a foreign company, including an American, remained

missing after kidnappers raided their Baghdad offices on Monday.

Prime Minister Iyad Allawi has oledged to restore order to the country ahead of Iraq's own landmark polls, promised by January, and is prepared to use force.

At least six people were killed and another 21 wounded when a suicide car bomb tore through a line of cars outside the education ministry in Fallujah after a night of air raids. The unrest came as the United northern Baghdad at about 9:30 am (0630 GMT), medics and police officials said.

'It was a suicide attack, we found the body of the driver inside the charred remains of the car," said police lieutenant Bassam Bahr. The bomber attempted to ram

Two national guardsmen were also hurt when a roadside bomb exploded as their convoy drove through the town of Abu Ghraib on the western outskirts of the capital.

Adding to the bloodshed, a national guard commander, General Rashid Falih, and at least one other guardsman died and 11 others were wounded in two separate car bomb attacks in Iraq's main northern city of Mosul, Iraqi police

In a separate crisis, four people -an American, a Filipino, a Nepalese and an Iraqi -- remained missing after kidnappers raided a Saudi trading company's Baghdad offices on Monday, another employee said.

Meanwhile, an Iraqi cameraman working for Reuters was shot dead during clashes in rebel-held Ramadi Monday, while a US war plane bombed nearby Fallujah overnight, the military and news agency said
