there are 40,000 blind children in the country. Of them, 10,000-12,000 are suffering from blindness due to un-

operated cataract. We will operate upon all the blind children having childhood cataract across the country," Programme Coordinator of SSI Dr Alamgir Hossain told journalists on the sidelines of the seminar held at the Brac Centre at Mohakhali here.

Dr Hossain said the SSI started the campaign in July last, but the formal programme would be launched from January next year. Blind children would be operated upon at six hospitals -- Islamia Eye Hospital in Dhaka, CEITC in Chittagong and eye hospitals at Comilla, Sirajganj, Dinajpur and

Inaugurating the SSI campaign, Social Welfare Minister Ali Ahsan Mohammad Mujahid said 80 percent blindness of children occurs before the age of five. However, the sights of a third of the blind children could be restored through cataract surgery, he said.

Eminent eye specialist and former minister Professor MA Matin chaired the inaugural function, which was also addressed by country representative of SSI Dr M Enamul Kabir and representative of International Centre-for Eye Health of London Dr Muhit.
