## Literacy status far from millennium goals

### Experts tell seminar

The present literacy status is far short of the target of education for all, one of the Millennium Development Goals (MDG) of 2015, said the experts at a seminar yesterday.

They said the goal cannot be reached if the government does not bring massive change in its policy on primary education, they said quoting a Unesco Monitoring Report on the world literacy status based on the MDG published recently.

The national consultation seminar on 'MDG and Education For All' was organised by the Campaign for Popular Education (Campe) at the LGED auditorium in the city.

According to Unesco, the literacy rate of Bangladesh is 42 percent, whereas the Directorate of Primary and Mass Education has fixed the rate at 62.

"Even if we do not go for debate regarding the rate, the quality of primary education is very far from the MDG," said Dr Manzoor Ahmed, director of a Brac education project.

Only 35 percent students enrolled in the primary schools can read and write and know the basic mathematics on completion of their study at Class V, he added.

Plan Bangladesh's Learning told

The Daily Star that lack of trained and skilled teachers is the main reason for this drawback.

Campe Director Rasheda K Chowdhury said corruption and bribery in recruiting the primary school teachers have seriously hampered the quality of primary education.

Basu Dev Neupane, member of Millennium Campaign Team, Asia has however expressed his satisfaction at the increase of budgetary allocations by the government for primary education.

### Tk 2.45CR EMBEZZLEMENT CASE

## Two ex-bankers get 10 yrs, 9 others 5 yrs

A Dhaka court yesterday sentenced two former bank officials to 10 years' rigorous imprisonment (RI) and fined them Tk one crore each in an embezzlement case filed 21 years ago.

The court also sentenced nine other officials to five years' RI and fined them Tk 10 lakh each in the same case.

The convicts who got 10-year RI are former manager of Janata Bank at Mitford Branch AKM Wahiduzzaman Khan and an official of the same branch Belayet Hossain Khan. Both the convicts were tried in absentia.

The nine other convicts are Jalal Uddin, Zahangir Hossain, Kazi Mokarram Hossain, Abdus Sattar, Shamsul Gani, Jamil Akhter, Yar Omar Khan, Ruhul Amin, Patwary and Mohammad Hanif. Of them, Mokarram, Omar, Patwary and Hanif were tried in absentia.

In the case filed with Lalbagh Police Station, it was alleged that the two officials in collusion with others misappropriated Tk 2,45,04,500 some customers of Small Industry Corporation deposited with the bank in the form of nine cheques on different dates. They withdrew the money through forged vouchers and cheques on May 3, 1983.

The court acquitted nine other accused as the charges brought against them were not proved.

The punishment of the fugitives will be effective from the date of their arrest or surrender,

the judge said.

Judge Mohammad Rezaul Karim Khan of the Special Court for Dhaka Division gave the verdict at a jam-packed courtroom.

Earlier, the prosecution and the defence completed their arguments and the court recorded statements of 20 prosecution witnesses.

Md Rezaul Rahman, former manager of the bank, filed the case accusing Wahiduzzaman and Belayet on May 6, 1983 and the investigation officer pressed charges against Wahid and 19 others on January 23 the next year.

### Mob gouges out eyes of outlaw in Jessore

Angry mob beat up a listed criminal and gouged out his eyes in Keshabpur upazila of Jessore district on Tuesday evening.

The mob caught Kartik Mondol, 30, at Kalagachi Bazar while he was extorting tolls from the traders.

He was later handed over to the police.

Kartik is an armed cadre of the outlawed New Biplobi Communist Party (NBPC) and an accused in 18 murder cases, police said. He was the bodyguard of NBPC chief Monoranjon Goshai alias Mrinal who was gunned down in Nadia district of West Bengal recently.

Kartik, son of Mukul Mondol, returned from India last Monday.

## Ctg Mayor vows to hold victory fair at outer stadium venue

Chittagong Mayor ABM Mohiuddin Chowdhury yesterday vowed to organise the traditional month-long Muktijuddher Bijoy Mela on the outer stadium premises in December at any cost.

Mohiuddin, also chairman of the Mela Parishad and general secretary of Chittagong city Awami League, declared this at a rally protesting the 'occupation' of the Outer Stadium venue where the Bijoy Mela (victory fair) since 1989.

But since 2002, Chittagong city, north district and south district commands of Bangladesh Muktijoddha Sangsad (BMS) under the banner of Muktijuddher Bijoy

Utsab Uddipan Parishad have been organising 'Muktijuddher Bijoy Utsab' at the same venue.

Announcing the Bijoy Mela programmes, the mayor said the Parishad would hold a rally on the central Shaheed Minar premises at 2.00pm on December 1 to mark the opening of the fair. The rally will be followed by a procession that will end at the foot of Bijoy Shikha (victory flame) on the Outer Stadium premises.

And with the lighting of the Bijoy Shikha, the 31-day victory fair will be formally inaugurated, Mohiuddin said. The title of this year's fair is 'Rajakarer Biruddhe Muktijuddher Bijoy Mela'.

He said after the occupation of the fair venue (outer stadium) by

the pro-BNP organisations, the Bijoy Mela now would not be limited to Outer Stadium or Lalbagh Moidan area, but it would spread all over Chittagong.

The protest rally was held in front of the Chittagong Press Club after the police prevented the Parishad from holding the rally at the scheduled venue at the foot of Bijoy Shikha.

Former minister and Chittagong City Awami League President MA Mannan, former CU pro-Vice chancellor Dr Abu Yusuf Alam and Mela Parishad Secretary General Abul Hashem also addressed the rally.
