## Shamim returns with a bang

Shamim Reza celebrated his 'premier' return after two seasons with a brace in Abahani Krira Chakra's 3-1 win over Azad Sporting Club in the Green Delta Premier Hockey League opener yesterday.

The former national striker, who was banned after staying back in the United Kingdom while touring with the national hockey team a couple of years ago, put the defending champions ahead inside the first minute at the Maulana Bhashani National Hockey Stadium and scored another in the early second half. Newcomers Azad pulled one back through Mahub but Musa Mia sealed Abahani's three points with a last-minute strike.

Shamim, who played in the Club

Cup hockey tournament earlier this month, saw his ban lifted by the Bangladesh Hockey Federation prior to the league and made no mistake to score with a reverse hit after playmaker Musa drilled the ball through the rival defence inside the penalty area.

Abahani won four penalty corners in the next nine minutes but Azad's young goalkeeper Mehrab Hossain, who was in tremendous form throughout the 70 minutes, made two brilliant saves to keep the Sky Blues at bay.

With the youthful exuberance of BKSP players, Azad not only survived the pressure but also fought neck and neck with their mighty rivals. They came close to equalise halfway through the first half when Nannu got into the rival area down the left flank. But his final pass evaded Mominul who was unmarked in a scoring position.

Abahani had a golden chance to make it 2-0 just before the break but Musa's fierce reverse hit was kept out by Mehrab. The Azad keeper, however, could not stop a cool finish by Shamim who scored his second goal four minutes into the second half after receiving a pass from fellow forward Jimmy.

While the champs failed to beat their rival defence from as many as seven penalty corners, the Azad boys showed some innovation during their only penalty corner when Mahub reduced the margin four minutes from time with a fine angular hit.

But experience prevailed as Musa finally utilised the last penalty corner when he dribbled two defenders before pushing the ball past Mehrab.

## England land in Zim

### First ODI now Sunday

England's cricket team touched down in Harare on Friday, two days later than planned due to a row over accreditation for the majority of British media covering the Zimbabwe tour.

The first of five one-day matches, originally set for Friday, had been rescheduled for Sunday, England team spokesman Andrew Walpole said.

"The rest of the schedule should follow shortly," Walpole told journalists shortly before the team flew from Johannesburg to Harare.

The whole tour was thrown into question earlier this week when the England and Wales Cricket Board (ECB) told the team to remain in South Africa after Zimbabwe authorities barred 13 British journalists.

But the tour got the go-ahead on Thursday when the host authorities rescinded the ban. "We are delighted the decision has been fully reversed," said ECB director of operations John Carr, who briefed the players on Thursday.

"The tour has to take place to fulfil England's commitment to the (International Cricket Council's) Future Tours Programme. The goalposts were moved when accreditation was denied but we are back to where we were now," he added.

Major Anyway Mutumbudzi, a senior official at the Zimbabwe department of information and publicity, said the 13 barred reporters had been part of a backlog of applications which had now been cleared.

Earlier, a spokesman for President Robert Mugabe said the reporters had been banned because they worked for organisations hostile to the Zimbabwe leader.

"Bona fide media organisations in the UK have been cleared, but those that are political have not. This is a game of cricket, not politics," George Charamba said.

Top strike bowler Steve Harmison boycotted the tour before the squad was announced and several players, including captain Michael Vaughan, aired reservations before the latest crisis.

Relations between Zimbabwe and its former colonial ruler Britain have hit rock bottom since Mugabe launched a campaign of chaotic and often violent seizures of land from white farmers, many of whom held dual British citizenship.

Britain, accusing Mugabe of rigging his 2002 re-election, has spearheaded international sanctions and Mugabe in return says London has masterminded a campaign of economic sabotage and negative media coverage.

### ESPN-STAR on collision course with BCB

When contacted, chairman of the BCB's media committee Rezauddin al-Mamun admitted that there has been some displeasure on both sides following ESPN-STAR Sports' demand.

## Mohammedan to tour Nepal

Mohammedan Sporting Club will tour Nepal next month to participate in an invitational football tournament which starts from December 13 at the Dasharath Stadium in Kathmandu.

The Bangladesh Football Federation initially decided to send the national team under the banner of BFF XI but top officials opposed the idea of exposing an under-prepared team.

More than one club expressed their interest to take part in the event but National Football League and Premier League champions Brothers Union and Mohammedan stood as the final candidates.

Mohammedan, the only local heavyweights not to tour abroad this season, got the final go-ahead from the BFF on Thursday night.

Nepal and Bhutan's national teams and two Indian teams will compete in the tournament which is scheduled to end on December 19. Also, 16 Nepalese teams are playing in the qualifying rounds for the remaining berths in the finals, according to a BFF source.

## ICC withdraws ban on Ganguly

The International Cricket Council (ICC) has lifted a two-match ban on Sourav Ganguly, allowing the Indian captain to play in the second Test against South Africa.

ICC match referee and former West Indies captain Clive Lloyd suspended Ganguly for India's slow over rate in their one-day international defeat to Pakistan on November 13.

The 32-year-old was allowed to play in the drawn first Test against South Africa because his appeal could not be heard before it.

India face South Africa in Kolkata in the second Test, which starts on Sunday.

ICC Appeals Commissioner Tim

Castle said he had considered oral evidence from Ganguly and Lloyd as well as match paperwork and a video of the match.

"I am of the opinion that the circumstances were particularly unusual in this game and a large number of them conspired to cause the delays which occurred," he said.

ICC Chief Executive Malcolm Speed said Castle's decision highlighted the independence of the ICC's appeals process.

"His judgement highlights the exceptional circumstances that prevailed during this particular match while also emphasising the general importance of maintaining the required over-rates during international matches," Speed added.

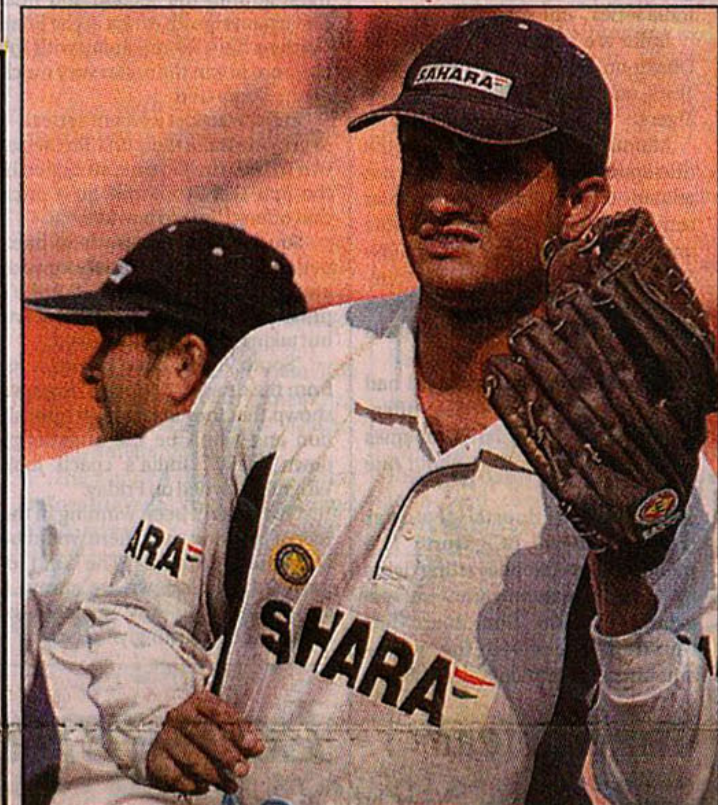

## Windies rebels await meeting

The prime ministers of Grenada and Barbados will mediate in a meeting between the representatives of the West Indies Cricket Board (WICB) and the players' association, to help to find a resolution with the ongoing contracts dispute. The meeting is scheduled to start at 1130 local time in Grenada (10:30 pm Bangladesh time).

Dinanath Ramnarine, the president of the West Indies Players' Association (WIPA), welcomed the intervention of Dr Keith Mitchell, Grenada's prime minister, and Owen Arthur, Barbados's prime minister. "We consider that the dispute is capable of being resolved once a process of dialogue is resumed and we hope that your initiative is able to facilitate this," Ramnarine indicated in a press release.

"A failure to arrive at a satisfactory resolution of this issue can do irreparable harm to West Indies cricket".

Mitchell himself concurred: "Given the vital importance of cricket to the social and economic

## Aussies in command

### Hayden refuses to walk

Justin Langer led an Australian roasting of New Zealand's bowling with his 20th Test century, as opening partner Matthew Hayden reignited the 'walk' debate in the second cricket Test at the Adelaide Oval on Friday.

The 34-year-old left-handed opener scorched out of the starting blocks, plundering 23 runs off the first two overs before steadying for his third century on the picturesque ground as Australia powered to 327 for three at first-day stumps at 3.6 runs an over.

Langer batted all day to be unbeaten on 144 in 367 minutes including 19 boundaries. Hometown hero Darren Lehmann was not out 28.

"I don't think it was one of my best centuries, to be honest," Langer said.

"Besides the first couple of overs and probably a couple of overs with the new ball it was more of a gritty innings, but I thought my balance was good, and for me that's very encouraging."

A major talking point was Hayden's refusal to 'walk' after he appeared to be clearly caught and bowled by off-spinner Paul Wiseman.

Hayden turned his back on

English umpire David Shepherd and stood his ground as the Kiwi fieldsmen celebrated and he only left the wicket minutes later when adjudicated by the video umpire.

There has been acrimony in the series over the issue of walking, or batsmen admitting they are out before waiting for the umpire's decision.

New Zealand batsman Craig McMillan accused Australian vice-captain Adam Gilchrist of being "righteous" over the matter during a confrontation over a turned-down appeal in the first Gabba Test last week.

Langer said there were no words of anger exchanged between the players over the Hayden incident.

"There was a big thumping noise, Matty thought that he had hit the ground (with the bat)... the umpires did the right thing by using the technology to make absolutely sure he was out... it just saved any issues," Langer said.

"There was no aggro, it was just one of those things."

Wiseman said Hayden was entitled to stand his ground because he wasn't sure if the ball had come off his bat or the pitch.

Hayden looked set for his 21st Test century before he advanced down the wicket on 70 to give Wiseman the comfortable return catch.

He is poised to create Test cricket history if he bats a second time in this Test as he needs only 10 more runs to become the first player to score 1000 runs in a calendar year for the fourth successive time.

Hayden and Langer shared in their 13th Test century partnership with 137 runs for the first wicket in three hours' batting.

Langer launched into his 23rd Test half-century off 75 balls, but a cramping injury after lunch restricted his scoring for a time and he added just 33 runs in the middle session to tea. He registered his 100 in 285 minutes late in the day.

Skipper Ricky Ponting, who scored 242 in last year's corresponding Adelaide Test against India, looked in ominous touch before he was deceived by left-arm spinner Daniel Vettori and was stumped for

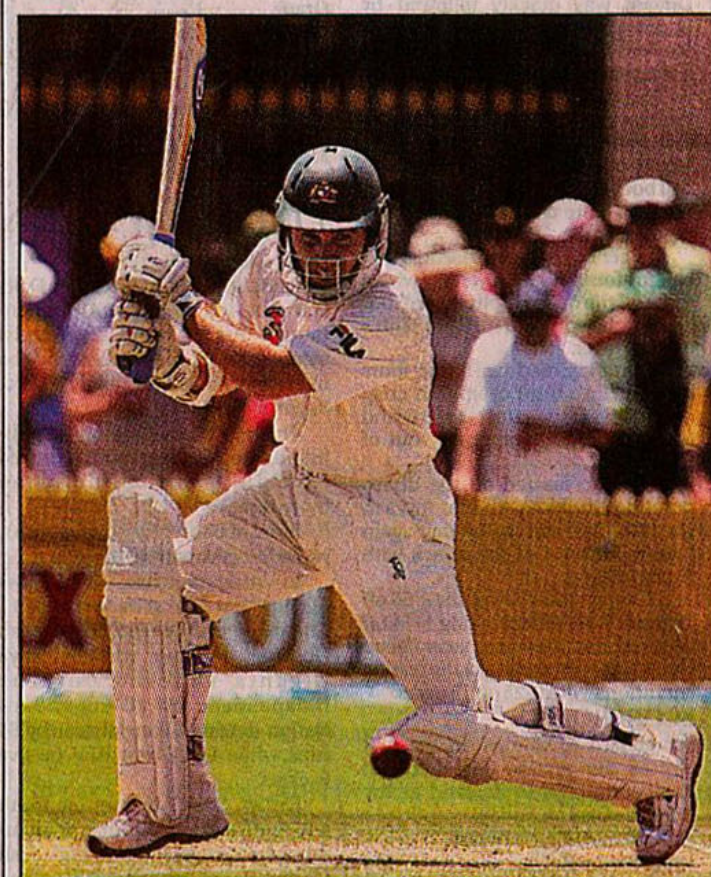
