Singapore's employment rose by 14,100 in the July to September quarter -- the strongest quarterly gain in three quarters -- but lower than an earlier estimate of 16,600 jobs, the Manpower Ministry said yesterday.

The second quarter saw total employment grow by 10,900 jobs, the ministry's third quarter labour

market report showed.
Singapore's unemployment rate fell to 3.4 percent in September, its lowest in three years, as hotels and restaurants hired new workers. But analysts said unemployment

may rise again in 2005.

The jobless rate had been stuck at

4.5 percent since the end of December, when it fell from a 17-year high of 5.5 percent.

China's mobile phone users sent 176 billion short messages in the first 10 months of this year, according to figures released by the Ministry of Information Industry

Euro nears record high against dollar

The euro marched towards record high points against the dollar Thursday on news overnight that foreign investors had slowed their fund flows into the United States, as markets awaited US current account

The single European currency rose to 1.3417 dollars in early European trading, from 1.3393 late on Wednesday in New York.

The dollar stood at 104.19 yen compared with 104.20 on

The euro reached as high as 1.3443 dollars on Wednesday, nearing the record peak of 1.3469 achieved last week, after US government figures showed foreigners cut investment in long-term securities in the United States in October.

"The trend of dollar depreciation is firmly back in place after yesterdays dollar selling resulted in the euro rising to an intra-day high of 1.3443," Bank of Tokyo-Mitsubishi economist Derek Halpenny said.

The dollar plunged after the US

Treasury Department said that net foreign purchases from US residents of long-term securities -- including domestic and foreign-issued bonds and stocks -- slumped to 48.1 billion dollars in October from 67.5 billion dollars in September. The figures have raised renewed

concern that the United States will find it difficult to cover its huge current account and budget deficits.

Markets were expected to closely study US current account figures for the third quarter, to be published later Thursday, especially in the wake of official data earlier in the week that revealed the US trade gap unexpectedly shot to a record 55.5 billion dollars in October.

"Another large current account deficit will be unsurprising, bringing the deficit close to 6.0 percent of gross domestic product," Calyon analyst Mitul Kotecha said.

Indian oil firm interested in Yukos assets

India's state-run Oil and Natural Gas Corp. said Thursday it is interested in bidding for some of the assets of stricken Russian oil giant Yukos, but and not the whole company.

"If Yukos offers assets individually, we would be interested. We never proposed to bid for the company as a whole," Subir Raha, chairman of ONGC, said in comments broadcast on NDTV.

ONGC, India's sole oil and gas exploration firm, is believed to have held talks with Russian gas supplier Gazprom for a possible joint bid for a portion of Yukos' assets.

Russia is putting up for auction Yukos' main oil producing unit, Yuganskneftegaz, and has set a starting price tag of 8.65 billion dollars for the December 19 sale.

AirAsia confirms purchase of 40 Airbus jets

Malaysian budget carrier AirAsia announced Thursday that it will buy 40 A320 jets for 2.5 billion dollars from Europe's Airbus, which beat US aerospace giant Boeing in bidding for the contract.

AirAsia said in a statement to the stock exchange that it would sign a preliminary agreement with Airbus on Friday and would also agree to take options to acquire up to 40 more aircraft.

The order for the 40 jets would be valued at 5.2 billion dollars at the catalogue price, the Wall Street Journal said in a report on the negotiations last month, but AirAsia will pay less than half that amount after securing major discounts.
