HC halts election to JS reserved seats for women

The High Court (HC) yesterday directed the government and the Election Commission (EC) not to hold polls to 45 seats reserved for women in the Jatiya Sangsad, until hearing of a writ petition challenging the election process.

The HC bench of Justice MA Matin and Justice AFM Abdur Rahman passed the order following a petition filed by 13 women leaders seeking an injunction on the polls

process. The court fixed February 23 for hearing the petition.

On December 14 last year, the HC had issued a rule on the government asking it to explain in two weeks' time why the law providing for election to the reserved seats for woman should not be declared unconstitutional


The court, however, had not then ruled on whether there should be a stay of operation of the law itself.

Two more writ petitions relating to the 14th amendment to the con

stitution, which provided for the 45 reserved seats for women in parliament, were filed earlier and the HC had issued separate rule following the petitions.

The Jatiya Sangsad on November 29 last year passed the bill for indirect election to the reserved seats on proportional representation of political parties or alliances amid strong protests by the opposition

ACC hamstrung by crises Baghdad governor

Acting Secretary Matin resigns; commission stumbles without staff, rules

Confusion reigns supreme at the Anti-Corruption Commission (ACC) which is yet to set its rules, regulations and staffing one and a half months into its formation.

The situation only worsened as former director general (DG) of the now defunct Bureau of Anti-Corruption (Bac) and Acting ACC Secretary MA Matin resigned yesterday, a day after the government had announced all Bac staff as 'reserved

and not to work for the commis-

The relocation of the commission from the Bac office in Segunbagicha to Agargaon yesterday did not help either absorbed into the ACC after desolation of the bureau.

In his resignation letter to the ACC chairman, Matin regretted discontinuing his job. He said the Cabinet Division's controversial decision about the Bac employees has resulted in a stalemate and there is no congenial atmosphere at the commission to continue working.

Matin alleged the Cabinet Division took the decision, though it was contrary to a clear opinion given by Attorney General AF Hassan Ariff that all Bac employees would be

Earlier, after the formation of the ACC, the government had cancelled the contractual service of Matin but the ACC chair appointed him as secretary to the commission in addition to his job as the Bac DG.

Gunmen killed Baghdad's governor in Iraq's highest-profile assassination in eight months and a suicide bomber killed 11 people at a police checkpoint yesterday in an escalating campaign to wreck the January 30 election.

The shooting of Governor Ali al-Haidri in a roadside ambush showed insurgents' power to strike at the heart of the governing class, raising fresh doubts as to whether security

The assassination took place hours after a bomber rammed a fuel truck into a checkpoint near Baghdad's Green Zone, a sprawling compound housing the Iraqi government and the US and British embassies. The vehicle went up in a giant fireball that rocked the capital. The blast killed eight police commandos and three civilians and

Petrobangla seeks cabinet help

Petrobangla has turned to the Cabinet Committee on Economic Affairs to recover its arrears of gas bills worth Tk 697 crore from 30 government entities, including a number of ministries, and three autonomousinstitutions

In a request, which will be tabled before the committee today, Petrobangla says the delays in payments have put it into a corner, as it has to pay millions of dollars every

month to international oil companies to purchase gas. The state oil and gas authority

complains a dearth of funds has also stalled some of its urgent gas-related development projects. If the arrears were cleared, Petrobangla adds, it could start some gas exploration and development work.
