Tsunami devastation The world responds

T is a small consolation that, in the wake of an epic natural disaster, people and governments can rise to the occasion and demonstrate deep Compassion for the plight of their fellow human beings. We saw this in the international response to the great cyclone that ravaged Bangladesh in 1991, and we are seeing it again after last week's devastating tsunamis in the

The size and scope of the tsunami disasters have struck a poignant chord in all of us. We understand that stepping forward now to support the shell-shocked survivors is both a moral obligation and a duty as members of the

The incredible outpouring of support from around the world underscores the global impact of this disaster. Donations have poured in from developed and developing nations alike.

Individual American citizens have pledged over 200 million USD of their own money. I was particularly moved by the generosity of the residents of the southern Russian town of Beslan, who, still in mourning for their own loss of 300 people in the terrorist school siege last November, have donated over

The United States Government has pledged \$350 million for relief and reconstruction efforts, and U.S. military forces are providing critically needed aid to survivors in the worst affected areas of Sumatra. While, however, governments can lead, it is individuals and ordinary people who make

In an unprecedented demonstration of American resolve, former Presidents Bush and Clinton have embarked on a massive campaign to raise relief funds from the American people and the American corporate sector. We will continue to work with the international donor community to coordinate relief efforts and are pleased that so many governments have pledged to work together to rebuild the affected countries

Private relief organisations were among the first to answer the call for help. The American Red Cross has collected more than \$79 million, and a U.S. based Internet retailer has raised from its customers more than \$12 million. Oxfam America received such a large volume of contributions via the Internet, more than \$7.5 million, that its website was temporarily disabled. Catholic Relief Services has raised almost \$15 million, and Save The Children has added another \$14 million.

Bangladeshis, I believe, should be proud that their country, no stranger to natural disasters, has this time assumed the role of donor by sending relief supplies and personnel to Sri Lanka aboard giant C-130 aircraft provided by the U.S. government to support Bangladesh's contribution to peacekeeping and humanitarian relief missions.

I am confident that Sri Lanka will long remember this practical demonstration of concern and good neighborliness. Similarly, the pledge by the Bangladeshi cricket team to donate towards the relief effort needs to be commended.

The world has already pledged \$2 billion, but much more needs to be done. As Secretary Powell said this week in Bangkok, as he led a Presidential mission to coordinate U.S. relief activities in the region, the road to recovery is long and hard. We have made a great start. The challenge now is to sustain this level of commitment and compassion until the job is done.

Lanka, Indonesia, India and Thailand, smaller number of deaths were also reported from Malaysia, the Maldives, Myanmar, Bangladesh and Seychelles, as well as distant east African coastline countries particularlySomalia.

The commitments of aid and logistic support by America for distribution of relief goods and establishing coalition with the governments of Japan and India to conduct relief operation in the affected areas were appreciated by the international community. President Bush's further announcement

of designating George H.W. Bush, 41" President and Bill Clinton, 42nd President to spearhead a nationwide fund-raising drive for these natural disaster victims was well received by Americans irrespective of party affiliations. Apart from this, Bush administration has sent high powered team headed by Colin Powell, Secretary of State, which included brother of the President, who is the Governor of Florida, Jeb Bush to the affected region in Asia to assess the death toll and destruction as well. Many Americans and European tourists are reportedly missing in Thailand and Sri Lanka.

Although belated, the actions taken by Bush administration will in fact go a long way in building its image which has been tarnished in the comity of nations because of wrong doings in Iraq and double standard policy in the Middle East. Unilateral use of military power by Bush administration has caused displeasure and disagreement among its trusted allies in Europe.

This unprecedented natural disaster has another effect too. Banda Aceh province of Indonesia and northern and eastern portions of Sri Lanka have been the scenes of separatist movement for a long time. Northern and eastern parts of Sri Lanka, which are controlled by Tamil tigers, have been worst hit by tsunami. The rebels have separately appealed for aid, but Sri Lanka government has already begun relief operation. In an address to the nation on December 26, 2004, President Kumaratunga said that "the mighty forces of nature have compelled us to learn a lesson that some of us refused for long to learn. We have to act together." The President has formed all party national committee to handle gigantic relief and reconstruction work. She has also invited Tamil Tigers' leader to join the national committee.

Tamil tigers have been fighting with government forces for 20 years for separation from Sri Lanka. Presently there has been cease-fire in the area since 2002 on the basis of Norway brokered truce. It is expected that a good will gesture will prevail upon on the Tamil tigers to make a deal with the government to avoid blood shed in future.

Aceh, on Sumatra Island's northern tip, has been the focus of a long guerilla war against Army of Indonesia. This disaster, however, compelled the rebels and the military to come closer to put down arms and work together for relief operation. Meanwhile, Free Aceh movement has announced a cease-fire in its struggle for independence. The newly elected President of Indonesia, former General Susilo B Yudhoyano, visited the tsunami battered Aceh. He needs to win hearts and minds of the affected people there to quell the trend for ever. America has embarked on a massive scale aid effort in close cooperation with Indonesian government. This is the major change of attitude of American administration to show to the Muslim world that they do not have any animosity towards Muslim community as such. It may be recalled that America had suspended many forms of military cooperation with Indonesia since 1992 due to concerns over human rights abuses by the Indonesian armed forces.

Media in America, both print and electronic, have been according wide possible coverage to this disaster, which succeeded in generating sympathy of Americans, who have been responding to the call for help. In an editorial The New York Times on December 28, 2004 commented that "no human power could have stopped the wall of water that washed over coasts from Indonesia to East Africa on Sunday. But human foresight could, and should have mitigated resulting tragedy". It said that there are certain to be additional tsunamis in this region in the future, although the historical record suggests that it may be several decades before the next one strikes. "That time should be used to create a reliable warning system that reaches all coastal areas. Washington, which has already offered all appropriate assistance to the affected countries, is uniquely qualified to provide the needed technical and humanitarian help." Similarly, United Nation's call has a positive effect in this respect.

Why this massive hypocrisy?

S the world mourns over 150,000 Tsunami deaths in Asia, one has to wonder why the world is so silent about the killing of no less than 100,000 Iraqi civilians in the aftermath of the USled invasion of Iraq. Tsunami is a natural disaster; no nation or human beings are responsible for it. The invasion of Iraq was premeditated --nations and individuals who decided to invade Iraq, are responsible for the deaths. While the earthquaketriggered Tsunami deaths could not be avoided, the man made disaster and killing in Iraq could have been and should have been avoided through non-invasion. Yet, as the world oozes out its sympathy for the Tsunami victims, it turns a cold, deaf ear to the cry of the Iraqis. Why this massive hypocrisy?

Paul Findley, former Republican congressman from Indiana, in a recent article entitled, "What is Bush's Real Goal in Iraq?" questions Mr. Bush's Iraq motives: "Our most urgent challenge in Iraq is convincing the insurgents that we will pack and leave once a directly-elected govern-ment is installed. Distrust of U.S. intentions is the root cause of the bloody rebellion that seems to gain strength every month. Is the Bush administration honest in stating that its objective is a stable, democratic Iraq? Or is it just a cover for permanent military bases that will enable the U.S. government to dominate Iraq far into the future?

Here are a few reasons why the Iraqis distrust U.S. intentions:

1) "Neocons" in the Defence Department long ago urged an inva-sion of Iraq as a step toward U.S. control of the Middle East. Retired U.S. General Anthony Zinni, former chief of the U.S. Central Command, publicly stated recently that "EVERY-ONE" IN WASHINGTON KNOWS THAT OIL AND ISRAEL ARE THE REAL REASONS FOR THEWAR.

2) Headlines and newscasts are replete with forecasts by administration officials that U.S. troops will be needed in Iraq for years.

3) Beginning with the thunderous, devastating "shock and awe" opening rounds, U.S. military assaults have left over 100,000 Iraqi civilians dead, with other thousands wounded and/or homeless, and vast areas, including the great historic city of Fallujah, in ruins.

4) No serious shake up or reprimand in high places followed the disclosure of US torture and humiliation of detainees

5) Administration handpicked the interim Iraqi government in its entirety. The prime minister Ayad Allawi, resided for a long time in the United States, had close links with the CIA, and earlier was a close colleague of Saddam Hussein, once serving as the dictator's hatchet man in Europe.

6) At the end of 1991 Gulf War, the U.S. government urged the Iraqis to overthrow Saddam. This prompted a strong uprising but the US govern-ment refused to provide support in any form. This refusal prompted Saddam to use helicopter gun-ships to slaughter dissidents by the hun-

7) For a decade after the GulfWar, U.S. fighter planes enforced severe sanctions that led to the immense civilian suffering, including the death of at least half a million Iraqi infants.

8) In the 1980s -- the height of Saddam's cruel treatment of Kurds and other Iraqi citizens -- the U.S. government served as the dictator's silent, uncomplaining partner, helping him battle Iran.

9) Before invading Iraq in 2003,

Bush must take prompt, rigorous steps to erase Iraqi fear of American colonialism. Otherwise, his page in history will be bleaker than President Lyndon Johnson's legacy from the VietnamWar.

In Iraq, trust -- not military manpower -- is the greatest and gravest shortage. More troops will inspire more insurgency, not less," Congressman Findley concludes.



Distrust of the U.S. government is virulent throughout the Arab world and beyond, not just in Iraq, and our government does almost nothing to spelit. If the administration fails to estab-

lish credibility, the rebellion will intensify. The best first is to convince the Iraqis that we will leave the minute the new directly elected government wants us out. President Bush must pledge, without qualification, that the timing and extent of our withdrawal will be controlled by Iraq. To make this promise believable,

Bush must state clearly that our government will withdraw all U.S. military forces and all U.S. contractors and dismantle U.S. military bases within a few weeks after the new government takes office. The only exception should be military units or contractors the new Iraqi overnment may wish to remain Such units will remain only as long as the new government wishes.

Our government must also promise unequivocally that once the new Iraqi government takes office, the diplomatic mission, now bursting with 2,000 persons, the largest in recorded history - will quickly be reduced to a standard level.
