Car bomb kills Palestinians vote four in Iraq

Insurgents kidnap 3 senior officials

A suicide bomber detonated his car at a petrol station near an Iraqi police and army checkpoint south of Baghdad yesterday, killing four civilians and wounding 19, police

They said most of those killed had been queuing at the fuel pump in the village of Mahaweel, about 80km south of the capital, which was crowded amid chronic fuel short-

The explosion wrecked at least three cars but did not hurt any of the police or soldiers manning the checkpoint a little further down the

Police said the blast appeared to target the petrol station, although the motive was unclear. Insurgents frequently attack Iraqi police and troops whom they accuse of working with U.S.-led forces they want out of

the country. Militants abducted three senior Iraqi officials, beheaded a man who worked for the US military and killed at least four others, officials said yesterday, a day after a US general warned that insurgents may be planning "horrific" attacks ahead of

Jan. 30 elections. Air Force Brig. Gen. Erv Lessel, a senior deputy for Gen. George W. Casey Jr., the top US commander in Iraq, said American leaders expected a rise in attacks before the election, but they had no intelligence indicat-

ingspecific plots. I think a worst case is where they have a series of horrific attacks that cause mass casualties in some spectacular fashion in the days leading up

to the elections," Lessel said Friday. "If you look over the last six months, they have steadily escalated the barbaric nature of the attacks they have been committing. A year ago, you didn't see these kinds of horrificthings."

In Washington, President Bush said the elections will be "an incredibly hopeful experience" despite rising violence and doubts that the vote will bring stability and democracy. He acknowledged security problems in four of Iraq's 18 prov-

"I know it's hard but it's hard for a reason," Bush said.

The comments came amid an escalating insurgency believed to be led by minority Sunnis, who dominated the country during Saddam Hussein's regime. In the election the first democratic vote in Iraq since the country was formed in 1932 the Sunnis are certain to lose their dominance to the Shias, who comprise 60 percent of Iraq's 26 million people.

Reflecting Shias' demands to hold the vote as scheduled and Sunnis' two senior religious leaders expressed sharply differing views during Friday prayers.
"We want all the Iraqis to partici-

pate, we also insist on holding the elections as scheduled and to put these elections behind us as a way to end the conflict in Iraq," Saadr Aldeen al-Qubbanji, a leader of a prominent Shia party, the Supreme Council for the Islamic Revolution in Iraq, said in the southern city of

of the Sunnis' Association of Muslim Scholars favored postponing the

"We all want elections, but we are seeking fair and free elections," he said in Baghdad. "Those of us who are calling for postponement are seeking that for the benefit of the country. Elections have to be an Iraqi demand, not the demand of the foreign coun-

The United States insists on holding the vote as scheduled and strongly opposes a postponement.

This week has seen a string of assassinations, suicide car bombings and other assaults that killed nearly 100 people, mostly Iraqi security forces, who are seen by the militants as collaborators with the American occupiers

Authorities in Saddam's hometown of Tikrit said Saturday that gunmen abducted a deputy governor of a central Iraqi province and two other senior officials as they traveled to meet with Grand Ayatollah Ali al-Sistani, Iraq's most prominent Shia leader, in the holy city of Najaf to discuss national elections.

The delegation was stopped and the members kidnapped about 40 miles south of Baghdad on Friday. The area is in the so-called "triangle of death," a string of Sunnicontrolled towns that have been the scene of frequent attacks.

The US military said the delegation was traveling in two cars one of which managed to escape the militants' ambush.

Those insurgents and terrorists who intimidate and resort to kidnapping public officials are the true enemies of the Iraqi people," said US military spokesman Maj. Neal

In Baqouba, insurgents broke into the house of a translator working with the US Army and then beheaded him, police said Saturday. An Iraqi policeman was killed by masked gunmen as he left his house in Baghdad's southern Dora neighbor-

The police put up barbed wire fences on the roads leading to the AL headquarters in the morning barring the opposition activists from entering the area. However, a small precession led by senior AL leader Matia Chowdhury paraded around the cordoned-off area. A group of AL lawmakers led by

Opposition Chief Whip Abdus Shahid marched on the Mirpur Road and staged a sit-in at Russell Square for several hours.

Experts from abroad are also coming to assist in this emergency operation, according to the Petrobangla chairman.

However, the Niko operations manager was unable to give any details of when the company will be able to start remedial measures. "After the situation comes under total control, we will start work for drilling a relief well for linking with lower zones of the main well. It would be about 500 metres off the main well." Mercier said. Thirty-seven engineers, techni-

cians and workers, including 22 foreigners, were working on the gas field before the fire took place. Foreigners have now been shifted to safer places. The Bangladesh Rifles from the nearby outposts along with the

police have been deployed two kilometres away from the gas field. In a further twist, it is alleged that the gas field itself was arbitrarily given to Niko in October 2003 violating government rules.
