The government has already formed a five-member committee to turn the BTTB into a public limited company and offload its shares in phases, said Abdul Quayyum, coordinator of the committee, at a


Handing over the mobile venture to Teletalk is a prelude to the offloading of shares in the public

The BTTB is one of the profit-making organisations and it paid over Tk 1600 crore to the government exchequer last year, they said.

They leaders said thousands of workers and employees have been passing their days in a state of uncertainty as the restructuring of the BTTB will lead to job losses.

ROBBERY, CARJACKING Govt takes tough steps to deal with criminals

In the wake of rising incidents of robbery and carjacking in the capital, the government has taken tough measures to deal with such criminal

In an exclusive meeting with the law enforcers yesterday, State Minister for Home Affairs Lutfozzaman Babor directed the police to investigate the robbery and car jacking incidents within 15 days of the heists.

Sources said the state minister cautioned the cops about punishment for failure and reward for success, underlining the imperative of working hard with "utmost honesty

and dignity". Two trained and efficient subinspectors in each police station are being set with specific responsibility of dealing with the robbery and car

jacking incidents, police sources said.

Besides, a special squad of detective branch is also being formed with a view to preventing and promptly detecting the heists.

Omar Farook, Inspector General of Police Ashraful Huda, additional director general of Rapid Action Battalion (Rab), acting DMP commissioner, deputy police commis-sioners, additional deputy commissioners, assistant police commissioners and the officers-incharge of the police stations under

Sources said that the home minister also asked the assistant commissioners and officers above the rank to closely monitor and supervise the work of the field-level officers.

Body to probe timber smuggling

Timber worth about Tk 25 lakh were seized in Cox's Bazar and Bandarban during the joint drives by BDR and forest officials in December and the first week of January, sources added.
