

EU finance chiefs to thrash out stability pact reform

European Union finance minister will try this week to hammer out reforms to the eurozone's tattered budget rules ahead of a March summit devoted to economic reform.

At their meeting late Monday and on Tuesday, the ministers will also discuss the economic fallout of the Asian tsunami and the related question of debt relief for the world's poorest countries.

"At Tuesday's Ecofin we will be taking a very important step to reduce the options that are on the table," a senior source with the EU Luxembourg presidency said.

China holds key to Airbus super-jumbo success

High-flying European airline builder Airbus has already logged dozens of orders for its new giant A380 aircraft, but success will not be complete unless it can interest China, one of the world's biggest operators.

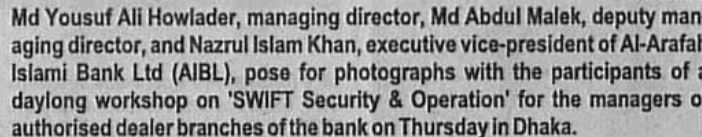
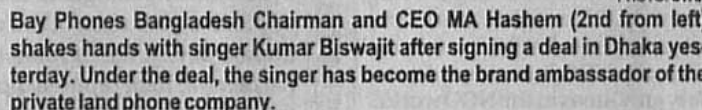
With the 2008 Beijing Olympics looming, there is speculation that the Chinese order for the twin-deck four-engine plane, which can carry some 550 passengers, will be announced at the A380's official roll-out on Tuesday, Hong Kong-based aviation analyst Peter Neglin of bankers JPMorgan said.

Such an announcement had already been expected when French President Jacques Chirac visited China in October, and again when German Chancellor Gerhard Schröder was in Beijing in early December.
